Tier 1 Categorical Exclusion

After appropriate environmental review, it has been determined that the subject job is a Tier 1 Categorical Exclusion as described by the ARDOT/FHWA Programmatic Agreement on Categorical Exclusion Documentation and Processing. A public hearing will not be offered for this project.

The purpose of this project is to rehabilitate approximately 9.8 miles of I-55 between Blytheville and the Missouri state line in Mississippi County, AR. This project would include applying Ultrathin Bonded Wearing Course to the interstate and entrance/exit ramps. During construction, a single 4-mile lane closure in one direction would be used to allow for the maintenance of traffic. All work will take place within the existing right of way. A project location map is attached.

The project will not involve relocations, prime farmlands, wetlands, underground storage tanks, hazardous materials, any environmental justice issues, or cultural resources. This project has been determined to generate minimal air quality impacts for Clean Air Act criteria pollutants and has not been linked with any special mobile source air toxics concerns. The cultural resources clearance is attached.

The official species lists obtained through the U.S. Fish and Wildlife Service's Information for Planning and Consultation identified the following species as potentially occurring within the project area: Eastern Black Rail (*Laterallus jamaicensis ssp. jamaicensis*), Piping Plover (*Charadrius melodus*), Red Knot (*Calidris canutus rufa*), pondberry (*Lindera melissifolia*), and monarch butterfly (*Danaus plexippus*). This project will have "no effect" on the aforementioned species due to the limited scope of the action, lack of suitable habitat, and distance to known species locations.


This project will not have a discharge of dredged or fill material into waters of the U.S; therefore, a Section 404 permit will not be required.
