# MINUTES OF THE MEETING <br> OF THE ARKANSAS STATE HIGHWAY COMMISSION 

June 1, 2016

Following is the record of proceedings of the Arkansas State Highway Commission in Little Rock, Arkansas, June 1, 2016. Members present were:

IT IS ORDERED that a meeting of the Arkansas State Highway Commission be opened at 10:00 a.m., June 1, 2016.

WHEREAS, the Purchasing Committee has awarded purchases on April 13 and 19, 2016, and May 4, 2016, in the amount of $\$ 2,759,036.17, \$ 151,396.00$ and $\$ 551,977.33$, respectively, totaling $\$ 3,462,409.50$, and supply and service contracts, in accordance with authority previously conveyed, all of which have been documented by official minutes which are of record in the files of the Commission and Equipment and Procurement Division.

NOW THEREFORE, IT IS ORDERED that the action of the Purchasing Committee be ratified and confirmed in all particulars.

WHEREAS, the Great Arkansas Cleanup is an important antilitter program which contributes to the appearance of the State's highways; and

WHEREAS, the Arkansas Highway and Transportation Department spends approximately $\$ 5$ million annually to remove litter from State Highways; and

WHEREAS, the Department's previous contributions to the Keep Arkansas Beautiful Foundation have been helpful in continuing the Great Arkansas Cleanup.

NOW THEREFORE, the Director is authorized to make a contribution of $\$ 25,000$ this year to the Keep Arkansas Beautiful Foundation for use in conducting the Great Arkansas Cleanup Campaign.

WHEREAS, the Federal Highway Administration sponsors the National Summer Transportation Institute, a program to encourage secondary school students to pursue transportation careers; and

WHEREAS, increasing awareness about transportation related careers is important to the transportation industry; and

WHEREAS, the Federal Highway Administration has encouraged state transportation departments to continue this $100 \%$ federally funded program; and

WHEREAS, in accordance with the Federal Highway Administration's guidelines for selecting a host site, the Department issued a Request for Proposals; and

WHEREAS, the University of Arkansas at Little Rock has submitted a proposal that meets the scope of the program and is within the projected budget allowance provided by the Federal Highway Administration.

NOW THEREFORE, the Director is authorized to enter into an agreement with the University of Arkansas at Little Rock to host the 2016 National Summer Transportation Institute.

WHEREAS, it is necessary for the Department to provide timely right of way acquisition services for selected projects in order to proceed with construction; and

WHEREAS, the Department currently has on-call contracts to perform indefinite delivery of right of way acquisition services; and

WHEREAS, these on-call contracts have been found to be an effective method of producing timely right of way acquisition services and supplementing Department staff in project delivery and legal proceedings.

NOW THEREFORE, the Director is authorized to request proposals, select an on-call consulting firm or firms, and enter into any necessary contracts and agreements as needs are identified.

WHEREAS, the recruitment and retention of engineering professionals is essential to the Department; and

WHEREAS, Minute Order 2008-111 authorized the Department to provide appropriate transportation research assistantship positions to the Mack-Blackwell Transportation Center (MBTC) at the University of Arkansas for research and training; and

WHEREAS, the Transportation Research Assistantship Program's criteria was last updated and authorized by Minute Order 2008129 ; and

WHEREAS, there is a need to revise the Assistantship Program's criteria in order to provide consistency with the requirements of the advanced degree programs offered by the University of Arkansas and with the Department's educational requirements for engineering professionals.

NOW THEREFORE, the Director is authorized to provide appropriate assistance to the MBTC through the Department's Transportation Research Assistantship program using the attached revised criteria.

WHEREAS, Federal transportation planning regulations require the development of a multi-year, financially constrained statewide transportation improvement program for all areas of the State in accordance with the provisions of 23 CFR 450; and

WHEREAS, Arkansas' Statewide Transportation Improvement Program for Fiscal Years 2016-2020 (STIP), has been prepared in accordance with the regulations and is ready for submittal to the appropriate agencies for approval.

NOW THEREFORE, the Director is authorized to submit the STIP to the Federal Highway Administration and the Federal Transit Administration for approval and to publish the STIP for distribution after approval by the federal agencies.

WHEREAS, the Department's current practice is to only allow standard welcome signs within the state highway right-of-way; and

WHEREAS, a standard welcome sign consists of white text on a green background, which simply states the name of the community and is compliant with the Manual on Uniform Traffic Control Devices; and

WHEREAS, a number of communities have expressed interest in installing decorative gateway signs and/or landscaping on state highway right-of-way that welcome visitors to their community and express their sense of identity; and

WHEREAS, although it is not desirable from a traffic safety standpoint to distract motorists from their primary task of driving, an aesthetically pleasing decorative community gateway sign and/or landscaping can enhance the roadside setting while providing minimum distraction.

NOW THEREFORE, it has been determined that expanding the current practice to allow decorative gateway signs and/or landscaping on state highway right-of-way would be a positive addition.

FURTHERMORE, the Director is authorized to implement the attached City or County Welcome Sign Guidelines that define how, when and where it is appropriate to install such signing and landscaping, while ensuring a safe highway environment that adheres to both State and Federal laws and regulations.

WHEREAS, the Commission acquired in fee property known as Tract No. 8XR, from Justin Ethridge and Lori Ethridge for Job No. 100708, Hwy. 412 West-Hwy. 49 (Gr. \& Strs.) (S), by Warranty Deed dated September 8, 2015, and filed of record in the Circuit Clerk's office as Document Number 201506456; and

WHEREAS, Tract No. 8XR was acquired by the Commission for ONE THOUSAND ONE HUNDRED SEVENTY-FIVE AND NO/100 DOLLARS ( $\$ 1,175.00$ ); and

WHEREAS, Justin Ethridge and Lori Ethridge have requested to reacquire the property pursuant to Arkansas Code Ann § 27-67-322, and the District Engineer for District 10 has determined that Tract 8 XR is not now needed, nor in the foreseeable future will be needed for highway purposes. Tract 8 XR is more particularly described as:

Part of Lot 7 of Cedar Ridge Estates also being part of the East Half of the Southwest Quarter of Section 9, Township 16 North, Range 5 East, Greene County, Arkansas, more particularly described as follows:

NOW THEREFORE, the above described property is declared to be surplus; upon the receipt of the consideration of ONE THOUSAND ONE HUNDRED SEVENTY-FIVE AND NO/100 DOLLARS $(\$ 1,175.00)$ for Tract 8XR, the Chairman of the Commission is authorized and directed to execute a Quitclaim Deed conveying the right, title, interest or equity of the above-described property to Justin Ethridge and Lori Ethridge, husband and wife, and hereby releasing the same from the State Highway System; a copy of this Minute Order and the Quitclaim Deed shall be recorded in Greene County, Arkansas; and, if necessary, the right of way shall be remonumented to reflect the boundaries designed
herein. Any Federal-Aid Funds from this disposal shall be credited to Federal-Aid Funds or otherwise credited as permitted by Federal law.

WHEREAS, the Arkansas State Highway Commission (Commission) acquired property in connection with Job No. 1405-37-7 as Tract No. 718, Guernsey Road - Highway 4, Hempstead County, Arkansas, from property owner, Denver Daugherty and Emma Sue Daugherty, husband and wife, by Warranty Deed filed for record on October 11, 1966, in the Circuit Clerk's office of Hempstead County, Arkansas; and

WHEREAS, the Commission acquired Tract No. 718 (consisting of 7.42 acres) and its access for ELEVEN THOUSAND AND $\mathrm{NO} / 100$ DOLLARS ( $\$ 11,000.00$ ), and three (3) qualified appraisers have, in accordance with the requirements of Arkansas Code Annotated §27-67322, opined that the current fair market value of that portion of Tract No. 718 being offered for sale is ONE HUNDRED FIFTY AND NO/100 DOLLARS (\$150.00); and

WHEREAS, the Amandex Holdings LLC, an Arkansas limited liability company, $\mathrm{d} / \mathrm{b} / \mathrm{a}$ Amandex Apartments, LLC, the holder of an assignment from all heirs of the original Grantors, has asked the Commission to reacquire a portion of said Tract No. 718 that the remainder portion, known as Tract No. 718, which the District Engineer for District 3 has determined is not now, nor in the foreseeable future will be, needed for highway purposes. However, it is necessary to retain the control of access. That portion of Tract No. 718 is more particularly described as follows:

NOW THEREFORE, the above-described properties are declared surplus and upon receipt and consideration of the sum of ONE HUNDRED FIFTY AND NO/100 DOLLARS (\$150.00) from the Amandex Holdings LLC, an Arkansas limited liability company, d/b/a Amandex Apartments, LLC; the Chairman of the Commission is authorized and directed to execute a Quitclaim Deed conveying the right, title, interest or equity of the above-described property portion of Tract No. 718 for Job No. 140537-7, Hempstead County, Arkansas, to the Amandex Holdings LLC, an Arkansas limited liability company, $\mathrm{d} / \mathrm{b} / \mathrm{a}$ Amandex Apartments, LLC; excluding the original access rights acquired by the Commission; and hereby releasing the same from the State Highway System, that the Right of Way Division is directed and authorized to record a copy of this Minute Order and the Quitclaim Deed in the records of Hempstead County, Arkansas; and, if necessary, the right of way shall be remonumented to reflect the boundaries designated herein. Any Federal-Aid funds from this disposal shall be credited to Federal-Aid Funds or otherwise credited as permitted by Federal Law.

WHEREAS, the Commission granted by Minute Order 2015056 in the Minutes of June 10, 2015, Tract No. 7XR, for Job No. 060395, a Permanent Nonexclusive Easement For Ingress And Egress as Instrument No. 2015042683, filed and recorded on the $15^{\text {th }}$ day of July, 2015, in the records of Pulaski County, Arkansas, for the benefit of Travis G. Moore and Martha A. Moore; and

WHEREAS, Crown Castle, who holds an interest in the dominate estate, has requested broader language be included in the Permanent Nonexclusive Easement For Ingress And Egress concerning sublessees and licensees.

NOW THEREFORE, the Chairman of the Commission is authorized and directed to execute the Correction Permanent Nonexclusive Easement For Ingress And Egress; and this Minute Order and the Correction Permanent Nonexclusive Easement For Ingress And Egress shall be recorded in the records of Pulaski County, Arkansas, for the benefit of Travis G. Moore and Martha A. Moore.

WHEREAS, the Commission acquired a highway easement for Job No. 5197 Mountain View City Connection Road AR Hwy. 66/14, by County Court Order, dated May 18, 1936, and filed of record in County Court's office of Stone County in Book H, at Page 492; and

WHEREAS, the City of Mountain View, Arkansas, has requested that a portion of said highway be transferred to it pursuant to Arkansas Code Ann. § 27-65-109, for the purpose of drainage and construction of auxiliary facilities, adjacent to the existing highway; and

WHEREAS, the Commission's interest in that portion of the May 18, 1936, County Court Order that is the subject of the City's request is more specifically described as follows:

WHEREAS, the analysis identified safety improvements such as signage, shoulder rumble stripes, resurfacing, curve realignment, shoulder widening, and pavement markings to address roadway departure crashes and provide substantial safety benefits; and

WHEREAS, the Arkansas Strategic Highway Safety Plan (2013) identified roadway departure crashes as a primary emphasis area; and

WHEREAS, these improvements are eligible for Federal-aid Safety funds.

WHEREAS, a review of 55 intersections throughout Arkansas that were identified by the Districts and the public for potential safety improvements has been completed; and

WHEREAS, the Arkansas Strategic Highway Safety Plan (2013) identified intersections as a primary emphasis area; and

WHEREAS, roundabouts are a proven safety countermeasure to reduce the severity of intersection crashes by addressing angle collisions; and

WHEREAS, the analysis identified three intersections with a high number of fatal and serious injury angle crashes where a roundabout would be appropriate; and

WHEREAS, these improvements are eligible for Highway Safety Improvement Program funds.

NOW THEREFORE, the Director is authorized to proceed with surveys, plans and construction of a safety improvement project(s) at the locations shown on the attached maps as funds become available.

WHEREAS, traffic congestion within the Central Arkansas region continues to increase; and

WHEREAS, the Department recognizes the need to utilize various techniques to address congestion in a growing region; and

WHEREAS, Metroplan has proposed a partnering arrangement with the Department to fund 50 percent of an Area-wide High Occupancy Toll (HOT) Lane Study for the Central Arkansas Region, to include all or a portion of Pulaski, Faulkner, Saline, and Lonoke Counties; and

WHEREAS, the Department and Metroplan agree that such a study should commence upon completion of the Interstate 30 Corridor Study currently underway.

NOW THEREFORE, the Director is authorized to enter into any necessary agreements with Metroplan to conduct an Area-wide HOT Lane Study.

FURTHERMORE, the Director is authorized to take any necessary actions to engage the services of a consulting firm to conduct the Area-wide HOT Lane Study.

WHEREAS, IN HEMPSTEAD COUNTY, the Quorum Court of Hempstead County, by Resolution No. 2016-05, has acknowledged Highway 332, Section 6, at Log Mile 3.5, in the vicinity of the Antioch Baptist Church as the "Elsie Van-Hook Highway"; and

WHEREAS, the Highway Commission has adopted guidelines for the installation of commemorative signs by Minute Order 2014-023, and the actions taken by the Hempstead County Quorum Court meet these guidelines.

NOW THEREFORE, the Director is authorized to allow the installation of one sign in each direction in the vicinity of the Antioch Baptist Church on Highway 332 in accordance with Commission Policy.

WHEREAS, Scott County, by Resolution 2016-1, has acknowledged the sacrifice of Sheriff Cody Carpenter and Wildlife Officer Joel Campora; and

WHEREAS, the Arkansas Highway Commission has adopted guidelines for the installation of commemorative signs by Minute Order 2014-023 and the County's request meets these guidelines.

NOW THEREFORE, the Director is authorized to permit the installation of signs in each direction on Highway 71, as requested by the County, in accordance with Commission Policy.

WHEREAS, the City of Springdale, by Resolution 23-16, has acknowledged the sacrifice of Springdale Police Officer John Tillman Hussey; and

WHEREAS, the Arkansas Highway Commission has adopted guidelines for the installation of commemorative signs by Minute Order 2014-023 and the City's request meets these guidelines.

NOW THEREFORE, the Director is authorized to permit the installation of signs in each direction on the Springdale Northern Bypass, as requested by the City, in accordance with Commission Policy.

WHEREAS, the Highway Commission has been authorized by Arkansas Code Ann. § 27-67-206(a)(2)(A) to establish written procedures and regulations for the procurement of qualification-based design-build services, design-build finance services, and for the administration of both design-build project contracts and design-build finance contracts; and

WHEREAS, the Department has developed draft rules describing these procedures and regulations; and

WHEREAS, the Department and Highway Commission desire public comment on the proposed Arkansas State Highway and Transportation Department Rules for Design-Build Contracts and to proceed with the required promulgation procedures pursuant to the Arkansas Administrative Procedures Act.

NOW THEREFORE, the Director is authorized to submit the attached draft of Arkansas State Highway and Transportation Department Rules for Design-Build Contracts for public comment and to proceed with the required Arkansas Administrative Procedures Act promulgation procedures.

WHEREAS, the Arkansas State Highway Commission will receive bids on the following projects at the June 22, 2016 letting; and

WHEREAS, a thorough bid review and analysis is undertaken by the Department to ensure that only those projects are awarded which are judged to be in the best interests of the State; and

WHEREAS, the right is retained to reject any or all proposals, to waive technicalities, or to advertise for new proposals, also as judged to be in the best public interests of the State; and

WHEREAS, the Commission desires to expedite work on these important projects; and

WHEREAS, in accordance with Arkansas Constitution, Amendment 42, Section 6, as well as other laws of this State, the Commission has the authority to delegate certain powers to the Director of Highways and Transportation.

NOW THEREFORE, upon the Contractors furnishing the necessary performance and payment bonds and submitting all additional information required for the above mentioned projects, the Director is hereby authorized to enter into contracts and supplemental agreements for any projects deemed to be in the best interests of the State.

FURTHERMORE, the Director is authorized to reject any or all proposals, to waive technicalities, and/or to advertise for new proposals whenever deemed to be in the best interests of the State.

Chairman Trammel opened the meeting recognizing Robert Moery with the Governor's Office. Mr. Moery thanked the Commission, Director Bennett and the Department, on behalf of the Governor, for the support and leadership these last few weeks with the passage of both Arkansas Works and the Arkansas Highway Improvement Plan.

MOTION
Commission Chairman Dick Trammel brought up the previous Commission Minutes of April 20, 2016. Commissioner Alec Farmer moved, Commissioner Frank D. Scott, Jr. seconded and the motion passed to approve these previous Minutes.

Commissioner Robert S. Moore, Jr. moved, Commissioner Alec Farmer seconded and the motion passed to approve the 2016-2017 AHTD Operating Budget, including funds for cost of living adjustments and performance (merit) bonuses, as presented by Department Staff.

MOTION
In February of 2012, the Commission passed a motion to authorize the Director to amend the Supplemental Specifications regarding bidding restrictions for Contractors in liquidated damages. The Director recommended going back to the previous specifications before this motion which would prevent a contractor in liquidated damages from submitting a bid, but it wouldn't extend to related parties. Commissioner Frank D. Scott, Jr. moved, Commissioner Robert S. Moore, Jr. seconded, Vice Chairman Tom Schueck opposed, and Chairman Trammel abstained. The motion passed 3 to 1 .

MOTION
Commissioner Alec Farmer moved, Vice Chairman Tom Schueck seconded and the motion passed to enter into Executive Session at 12:35 p.m. to discuss the Director's performance evaluation.

MOTION
Commissioner Alec Farmer moved, Commissioner Frank D. Scott, Jr. seconded and the motion passed to reconvene at 1:00 p.m. Chairman Trammel stated that Director Bennett's review was satisfactory and everything was good.

## OTHER DISCUSSION ITEMS

Chairman Trammel introduced Robert Phelps, Executive Director of the Keep Arkansas Beautiful Commission. Mr. Phelps made a presentation on the "2016 Great Arkansas Cleanup" and on the litter control activities of Keep Arkansas Beautiful. He requested that the Highway Commission consider a contribution to the "2016 Great Arkansas Cleanup" as has been provided in past years. A Minute Order was submitted and approved authorizing a contribution of $\$ 25,000$.

Mike Boyd, Chief Fiscal Officer, provided the April 2016 update on state highway revenue. Mr. Boyd noted that state highway revenues to the Department from traditional sources are up a total of \$11.9 million in the State Fiscal Year (SFY) 2016 compared to the same period for SFY 2015. With the revenue from the Natural Gas Severance Tax coming in significantly lower for this year compared to last year, total revenues available are $\$ 9.9$ million lower for this year. Actual state revenue received is $\$ 3.5$ million lower compared to projected (budgeted) revenue for this year.

In closing, Mr. Boyd stated that April revenue from the $0.5 \%$ General Sales Tax for the Connecting Arkansas Program was $1.96 \%$ lower, $(\$ 283,292)$ than projected by the Department of Finance and Administration (DF\&A). Current Fiscal Year to date revenues are above the forecast by $1.3 \%$ ( $\$ 1.8$ million). This revenue source is cumulatively $0.01 \%$, or $\$ 45,174$, over DF\&A's projections to date.

Director Bennett provided the latest information on the Federal highway and transit funding issues. Director Bennett noted that the passage of the FAST Act has ensured federal funding for the next five years. Now the issue becomes sufficient state revenue to provide the matching funds required for Federal-aid funds. The Governor called for a special session of the legislature that began on May 19 in order to pass a funding package designed to meet the Department's most immediate needs. Director Bennett gave an update on the results of this special session.

Director Bennett gave an update on the status of the 2011 Interstate Rehabilitation Program (IRP) and Connecting Arkansas Program (CAP). The 2011 Interstate Rehabilitation Program was approved by Arkansas voters in November 2011. Under this program, the Commission has the authority to issue up to $\$ 575$ million in GARVEE bonds for Interstate rehabilitation. Three series of bonds have been issued. The first was sold in September 2012 at a par value of $\$ 197$ million (true interest cost of $1.6 \%$ ) with a premium of $\$ 33$ million (total of $\$ 230$ million available for construction). The second was sold in October 2013 at a par value of $\$ 172$ million (true interest cost of $2.2 \%$ ) with a premium of $\$ 29$ million (total of $\$ 201$ million available for construction). The third was sold in November 2014 at a par value of $\$ 206$ million (true interest cost of $2.1 \%$ ) with a premium of $\$ 37$ million (total of $\$ 243$ million available for construction).

The Connecting Arkansas Program was approved by Arkansas voters in November 2012. Under this program, the Commission has the authority to issue up to $\$ 1.3$ billion in revenue bonds for four-lane highway construction. The first series of bonds was sold in September 2013 at a par value of $\$ 469$ million (true interest cost of $3.1 \%$ ) with a premium of $\$ 25$ million (total of $\$ 494$ million available for construction). No other bond sales under this program are expected.

Director Bennett presented a summary of the apparent low bids and bidders from the May 11, 2016, Bid Letting.

Director Bennett provided a list of upcoming meetings and events, including the I-69 Coalition Meeting on June 9, 2016, in Tillar, AR, and the ROADeo Finals to be held on June 16, 2016, here in Little Rock.

Director Bennett recognized Highway Police and their "Cops on Bulls" event for fulfilling the dream of eighteen-year-old Make-A-Wish kid, Kaden, to visit Rome, London and Paris.

Director Bennett ended the meeting by recognizing Jimmie Sneed for her service with the Department. Jimmie will be retiring at the end of June and has done a great job and will be missed. Christie Heidelberg will begin working for Lorie and Scott after her retirement.
