#### THE DIRECTOR'S PAGE

This hasn't been our best year, mainly because we haven't been in this bad an economic condition in a long, long time. But, in looking back at what we've accomplished, I feel good about this past year and am proud of the way everyone has put forth a little more effort to get the job done to improve and maintain the 16,000 mile Highway System so important to the people and the economic growth of Arkansas. This has been a difficult task this year because of the cutbacks in Federal funds and declining State revenues.

We have reduced many of our programs, such as roadside mowing and litter pickup. Due to the discontinuation of Federal revenue sharing funds to the State, we have practically eliminated the overlay program. In an effort to reduce other costs, our workforce has been reduced through attrition, the 10-hour day, four-day work week was implementated for the spring and summer months and equipment purchases are being reduced.

If economic conditions don't improve and additional highway revenues are not made available, other services such as rest area and roadside park maintenance, mapping services and technical assistance to local governments will have to be reduced or eliminated.

Although the times are tough, we have managed to keep the vital services intact. This is, in a large degree, due to the fact that the Highway and Transportation Department employees are the most dedicated and hardest working group of employees anywhere.

Your dedication to the job has not gone unnoticed by the public you serve. We receive compliments daily from people who have seen first-hand the terrific job you are doing.

The members of the Highway Commission and I want to thank each of you for your dedication and hard work this past year, and we wish you and your families a happy holiday season.

# HIGHWAY 71 AND INDEX BRIDGE OPENED TO TRAFFIC



New construction of U.S. 71 five-lane section north of Texarkana.


Highway and Transportation officials from Arkansas and Texas met jointly in Texarkana, September 9 to celebrate the completion of work on U.S. 71 and the Index bridge over the Red River.

U.S. 71 was widened to four and five lanes from I-30 north along the state line for a distance of 1.7 miles at the cost of \$3.7 million. Arkansas and Texas shared in the cost of the project, with Arkansas' portion totaling \$1.6 million. The bridge, which is entirely in Arkansas, was constructed at a cost of \$3.4 million.

The new structure replaces the original Index bridge constructed in 1919 and is the second of two Index bridges serving the U.S. 71 traffic corridor north

of Texarkana. The first structure, a \$5 million project, was completed in 1976 and was a joint project between Arkansas and Texas.

The new bridge, built just east of the first structure, will carry northbound traffic, forming a divided highway by use of both bridges.

Arkansas Highway Commission Chairman James Branyan of Camden and Texas Commissioner Sam Waldrop of Abilene, Texas, were the featured speakers at a luncheon sponsored by the Texarkana Kiwanis Club.

Branyan said the rate of new highway construction and improvements was down and would continue that way because of the decline in revenues from both federal and state resources. He pointed out that highway construction costs are on the rise and revenues collected from the gasoline tax and vehicle registration fees have dropped.

Waldrop echoed Branyan's concern for the future of highway construction.

The Texas commissioner said the decline in fees means the people of Arkansas and Texas are going to have to make some tough decisions in the coming months about what they are going to do about transportation.

Future plans for the U.S. 71 corridor from Texarkana to Ashdown call for widening the roadway to four lanes for the entire 16 miles. A short two-lane section north of Texarkana, which is entirely in Texas, is on the Texas Highway Commission's Five Year Program, according to Waldrop.

# Railroad Overpass Dedicated at Jonesboro

A parade, led by the Arkansas State University Color Guard and the Jonesboro High School Marching Band and featuring the members of the Arkansas Highway Commission, area legislators and city and county officials, kicked off dedication ceremonies for the new Highway 49-B Railroad Overpass, September 24.

The \$2.2 million overpass was hailed as a longneeded alternate route over the two major rail lines (Cotton Belt and Burlington Northern), which will improve north-south traffic flow and expedite emergency traffic.

Marion Ulmer, manager of Jonesboro City Water and Light and master of ceremonies for the dedication, said tribute should be paid to Joe Martin, long-time chairman of the Chamber of Commerce Streets and Highways Committee, Mayor Neil Stallings, city council members, Joe Heinemann of the Downtown Improvement District, the downtown merchants, the highway department and commission, and the two railroads, for all those individuals' and groups' efforts in bringing the project to fruition.

Highway Commission Chairman James Branyan of Camden, who was the featured speaker, presented a plaque to Heinemann commemorating the event.

At a luncheon following the dedication, Branyan warned that rising costs of highway construction and declining revenues "have been on a collision course."


"It will take \$92 million in new revenues just to maintain the system we have," Branyan said.

"I don't know whether you want highways or you don't," he said. "I don't know what you're willing to pay for. . . Arkansas is at a crossroads, and Arkansans must tell their elected officials if they want to pay for continued road projects. Arkansans must say whether we'll go forward or backwards. . . Take a community, put a good highway through it, and I'll show you economic progress," he said.

The dedication ceremony also gave the highway commissioners an opportunity to announce some long-awaited good news. . . the continued four-laning of U.S. 63.

Branyan told the audience that a segment from Payneway north to near Trumann should be ready for contract by "the first of the year," provided the necessary funds are available.

The 6.8 mile section of four-lane highway is estimated to cost about \$17 million to construct.

#### Highway 4 Railroad Underpass Completed

Just looking at the "before" and "after" pictures of the Highway 4 Railroad Underpass in Hope is enough to describe the many advantages the new \$1.4 million structure has over the one it replaced.

One dignitary attending the dedication ceremony October 23 even went so far as to express pleasure at hearing the swishing sound of cars and trucks as they drove past the dedication site.

The old timber, two-lane underpass has served Highway 4 traffic since 1942 and local residents were ready for a change.

In late 1976, the city of Hope requested that the S.H. 4 Underpass be added as a top priority for Federal Aid Urban System funding. A public hearing was held by the Highway and Transportation Department in November, 1977 and a contract was awarded in February, 1979 for the construction of the new


structure.

In addition to the underpass, Highway 4 was widened from two to four lanes, from Third Street to Avenue B, traffic signals were installed on U.S. 67 at two locations near the underpass and four intersections were improved along Highway 4.

Highway Commission Chairman James Branyan of Camden expressed his appreciation to those who worked hard to bring the project to a reality.

"We are here today to dedicate this magnificent improvement because the public worked hard to get it built. You never let up in your desire to see this through and I want to thank you for that," Branyan said.

Following the dedication, the Hope Chamber of Commerce hosted a luncheon at the Hope Country Club.





No matter how good you are in your chosen field, there are always ways to improve upon the job you are doing. One way to improve is to take a look at what others are doing and incorporate some of their ideas with yours.

That is exactly what Loris Gordon Smartt and Rockcliff Syoemen Christie of Georgetown, Guyana are doing.

Smartt is the Acting Chief Roads Maintenance Superintendent for the Ministry of Works and Transport in Guyana and Christie is a District Superintendent. Both men spent two weeks in October visiting the Arkansas State Highway and Transportation Department to gather information about our road and maintenance techniques.

The two men came to the United States in July and returned home in November. During that time they visited ten state highway and transportation departments, the Federal Highway Administration in Washington, D.C., and three road construction and maintenance equipment manufacturers.

In comparing this country's road system to his own, Christie said the U.S. system was better funded and the control over the system was better.

Guyana, a country in South America with 850,000 people scattered out over 83,000 square miles, has only about 6,000 miles of what Christie said were "first class bituminous surface roads." The remaining 10,000 miles

so consists of chip seal, gravel d jungle trails. There are very few oncrete roads.

The weather in Guyana creates special problems, according to Smartt. "We have two rainy seasons lasting about two and a half months each. We will get 70 to 100 inches of rain during this time and drainage is a big problem. Many of our roads in the hilly part of the country wash out completely each year," he said.

The salty air in the coastal

The salty air in the coastal area also presents additional problems. "We have to keep our bridges protected," Christie said. "As a result, we have more concrete bridges and we don't use as much steel as you do."

Since the temperature in Guyana remains warm year 'round, the plants are never dormant. "Grass and weeds grow all of the time," Smartt said. "We are constantly mowing the roadsides to keep vegetation down," he added.

Smartt and Christie spent an Intire day of their visit in Arkansas studying our chemical vegetation control techniques. "We don't use chemicals in vegetation control because of the possible harmful effects on the animals. We are very interested in what you are doing and want to find out more about it," Christie said.

In addition to looking at maintenance techniques, the visitors spent a great deal of time studying job training and management systems.


"It doesn't matter how good the highway system is, you have to have the proper training of personnel and effective work scheduling to keep it good," Christie said.

"You know how to build the roads. You know what it takes in material, in equipment and skills. You can have all of this; but if the people don't have the right attitude, then you have problems," Smartt said.

"We are trying to eliminate these problems. We are looking at the way we control our work. We are trying to be more efficient. The trip to your country and state has been very helpful. We have learned a lot," he added.

# LOCATION HEARING HELD AT COLLEGE STATION

More than 150 College Station residents attended the Department's location public hearing on the proposed Bankhead Drive in eastern Pulaski County, September 1.

The proposed project would provide an improved connection between the East Belt Freeway (Interstate 440) and Frazier Pike. A combination of federal, state and county funds would be used to construct the project.

Four alternate locations were discussed at the hearing. Each one is approximately one-half mile long. The new street would be 45 feet wide and have curbs and gutters. It is estimated to cost approximately \$450,000 to \$470,000.

The Highway and Transportation Department was asked by Pulaski County to begin preliminary

work on the project in April, 1980 as part of the State-Aid County Road Program.

County Judge Bill Beaumont told the audience that the new street is to be named for Annie Mae Bankhead, a well-known College Station community leader. Beaumont also pointed out the new street would have an advantage over the present connection from College Station to Little Rock.

"We believe that this is tremendously important because of safety features, so that you no longer will have to cross a railroad track and all of the hazards associated with that, to get to your community," he said.

Once a location for the new route is selected and approved, design on the project will begin and a Design Public Hearing will be offered.

# Redesignation of US 165 Provides Better Continuity

The Arkansas State Highway and Transportation Department received approval in October from the Route Numbering Committee of the American Association of State Highway and Transportation Officials to extend U.S. 165 from Dumas to North Little Rock.

The new highway designation is along State Highway 54 from Dumas to State Highway 1, along State Highway 1 across the Arkansas River through Gillett and DeWitt, where it then follows State Highway 152 and State Highway 11 to Stuttgart and then along State Highway 130 through England and ending in North

Little Rock. The redesignated route is approximately 110 miles long.

U.S. 165 begins near Lake Charles, Louisiana and proceeds through Alexandria and Monroe before entering Arkansas just south of Wilmot.

The Pendleton Bridge across the Arkansas River between Dumas and Gillett completes a continuous route through the Arkansas Delta from Louisiana. The route provides for multimodal interstate and international transportation of commodities such as rice and soybeans. This route is the key link between the Little Rock area's urban high-density route (Interstate 440) serving ports and railheads, and the crop-producing land north of the Arkansas River. This extension will also carry part of the Great River Road route from Dumas to DeWitt.

The route extension was requested earlier this year by State Representatives Wayne Hampton of Stuttgart and Bill Foster of England, and was supported by city and county officials in the five counties affected by the change.

The Highway and Transportation Department has replaced approximately 360 highway signs along the route.

# SKID CALIBRATION PAD WILL SAVE TIME AND MONEY

The Federal Highway Administration's Safety Program requires the Department to monitor the skid resistance of highways throughout the State. The Technical Services Section of the Planning Division conducts a program for the continuing skid testing of the State's highways. This program requires the full time utilization of one skid unit and a two man crew to travel constantly around the State. Materials and Research Division has a skid unit available which is used primarily for

monitoring Research projects but is also often utilized to perform skid tests on highways at the request of various Divisions or Districts within the Department.

Periodically, the skid units must be tested on a control surface and be re-calibrated; this is to assure that both of the systems will produce reliable and consistent skid data. This re-calibration procedure is normally required on an annual basis. Previously, only two facilities available to the Department had the

equipment necessary for the recalibration. The closest facility was in College Station, Texas, and approximately \$10,000 was required to send each unit and a crew to Texas for the procedure. The Department has for several years considered ways of reducing this cost for maintaining the units.

Recently, the Department completed construction of a skid testing pad at the District 2 Headquarters complex at Pine Bluff. This pad and




Skid pad provides different surface textures for calibrating the units.

the Arkansas Highway Safety Program and the Department. The pad is an "L" shaped, 1700 foot section of roadway constructed of asphalt cement hot mix surface course. The installation was designed by the Research Section and constructed by District 2.

Each skid unit is composed of a truck and trailer. During a test run a trailer tire is "locked up" and the forces acting upon this tire are electronically measured. These forces are an indication of a highway's skid resistance; the larger these values, the more resistant the pavement is to skidding. Skid values will vary, depending upon the surface type and the condition of the pavement. Low skid numbers help to identify pavements that may require some type of rehabilitative measures.

The skid pad contains a widened segment approximately 300 feet long which is used in the actual calibration of the units. This segment is divided into three sections with each having a different surface texture. One of these sections has been painted by a striping crew from the Department's Sign Shop, the second section has a single bituminous seal coat (placed by District 2 personnel), and the third section has the surface course with no additional treatment. These three sections will provide a wide range of skid resistance values that are necessary in calibrating the units. The remainder of the pad is used for acceleration of the units (tests are run at 40 mph normally) and for deceleration and turnaround.


The skid pad will allow the Department to re-calibrate the skid units, not only on a yearly basis, but will also enable the units to be constantly updated and thereby assure reliable skid data. This makes the skid pad a valuable asset in monitoring the State's highway system and insuring the safety of the motoring public.

#### Iwo Jima Memorial Stops in Arkansas

Motorists traveling on I-40 and I-30 in Arkansas, October 8, probably did a double-take as they passed the tentruck convoy carrying the dismantled sections of the plaster cast of the Marine Corps' Iwo Jima Memorial.

The magnificent work of art, standing six stories tall and weighing 130 tons, has been donated by the sculptor, Dr. Felix deWeldon of Newport, Rhode Island, to the Marine Military Academy in Harlingen, Texas. It was dismantled and packed in 78 crates for the trip, which represents one of the largest fine arts movement operations since the London Bridge was moved to Arizona a few years ago.

The convoy made a stop at the Texaco Truck Stop near the intersection of I-30 and I-430 in Little Rock for a brief ceremony that included local officials and the Catholic High School Marine Corps Junior ROTC drill team.

The plaster cast is the original hand-sculpted piece from which the bronze statue in Arlington National Cemetary was cast. It is valued at \$3.5 million. The bronze statue is valued at \$15 million.

The memorial portrays six Marines placing the United States flag on Mount Suribachi on February 19, 1944, during World War II. It is considered a symbol of the heroism of American fighting men and the determination of free people throughout the world.







The Interstate 630 Bikeway in Little Rock is one of 52 projects nationwide selected for a Commendation for Design Achievement from the Design for Transportation National Awards Program, sponsored by the U.S. Department of Transportation and the National Endowment for the Arts. Eighteen other projects were given Awards for Design Excellence.

Arkansas Highway Commission Chairman James Branyan accepted the award at the ceremony held in conjunction with the annual meeting of the American Association of State Highway and Transportation Officials held in Chicago, October 6.

During the planning of I-630, which cuts across Little Rock from east to west, planners saw a major opportunity to create a trunk line for a network of urban bikeways.

After discussions with city planners and engineers, the state included a bicycle arterial in its construction contract for the Interstate.

An asphalt bikeway was built within the highway's right of way; it includes crossings under the highway at two points and a bridge across Rock Creek near Kanis Park. It also connects with bikeways being constructed by the city.

Two miles have been built and another two miles proposed. The eventual goal is a system of bicycle paths that will connect all parts of Little Rock, with the Interstate 630 segment as its major artery.



The Computer Services Division recently acquired a system, or series of programs, from the Louisiana Department of Transportation and Development that designs and plots highway signs. This system, called the Highway Sign Sizing System, actually consists of five (5) major programs.

The first and most important program, written in Cobol, designs the horizontal and vertical spacing for the legend, sizes the sign, establishes post lengths, and designs the footings. The other programs, written in Fortran, take the information and create a plot tape to be plotted on the Calcomp 748 flat bed plotter located in Computer Services.

The plots created include a large scale, small scale and cross-section plot of the sign and terrain with dimensioning.

The design program was originally written in Texas and modified by Louisiana. The plotting programs were also added by Louisiana.

Greg Newkirk of Computer Services and Rick Henriksen of Traffic Division have been modifying and testing the system for the past few months to meet the requirements of the Arkansas State Highway and Transportation Department. Some of these changes include the implementation of the Arkansas State Shield, advance turn arrows and rescaling the plot programs in order to have the plotter create a finished plan sheet.


The Bridge Design Division has also contributed to the programs modifications. Ed Fain and Dallas Vire re-wrote a structural routine in order to have the system design the sign footings.

Although far from being totally finished, the system has already shown its potential as a tool when the Traffic Division was recently confronted with a large interstate signing contract with a relatively short period of time in which to be completed. Due to the speed and flexibility of the program, the deadline was met.

Much time and effort have gone into the implementation of the system; however, the savings far outweigh the costs. The ultimate goal is to have the system design the signs and then have them plotted (from a tape created by the programs) onto a plan sheet.




Greg Newkirk of Computer Services loads tape program on Calcomp 748 flat bed plotter.

The Equal Employment Opportunity Section recently received approval from the Federal Highway Administration of the Department's revised Affirmative Action Plan.

Part II, Internal Employment, has been bound into a booklet and recently distributed throughout the state.

Although it is not economically feasible to furnish each employee with a copy of the plan, Melba Shepard, Internal EEO Coordinator, stated that each District, Division and Independent Section has been provided a copy, which is available for any employee's use.

There have been several modifications and additions to the plan. One area which merits clarification is the complaint/grievance procedures. There are two avenues available within the Department by which an agrieved employee can register dissatisfaction. When an employee feels that any condition affecting his or her employment is unjust, inequitable or creates a problem, but is not discriminatory in nature, the employee may elect to file a grievance. Employees who have cause to think they have been treated unfairly due to discrimination on their present job or as a result of application for another job within the Department, may elect to file an alleged discrimination complaint, she said. The EEO Section does not be-

come involved in grievances, but only in complaints that are of a discriminatory nature. In either case, all employees are urged to first contact their immediate supervisor and discuss the situation prior to filing a grievance or compliant. Many times problems can be resolved at this point.

The Department feels strongly that communication of EEO matters must be a continuing process and not just a one-shot affair. Therefore, the EEO office has established a practice of keeping employees informed through memos to supervisors and articles in the Employee Newsletter and magazine.

Communicating Department policy is essential to any effective affirmative action plan. For any program to work, participants must be aware of management's commitment.



# Where will it go from here?

Throughout the years Arkansas has been able to take advantage of several special federally funded highway programs. These programs have enabled the highway and transportation department to make many improvements that otherwise would have been a long time coming, if at all.

One of these special programs, the Great River Road, may be on the way out if efforts by department officials and the state's congressional delegation fail to persuade the administration or congress to continue funding past this year.

In October, \$25 million in deferred Great River Road funds were released and Arkansas received approximately \$2.2 million. The Great River Road program has not been included in any of the proposed highway acts for the future.

Arkansas' two senators, David Pryor and Dale Bumpers, joined with senators from the nine other states benefiting from the Great River Road program in urging the administration to reverse its position and release the funds.


The beginning of the Great River Road dates back to 1936 when Missouri's Governor Lloyd Stark authorized the Missouri State Planning Board to conduct a recreational survey which recommended that a parkway be established along the west bank of the Mississippi River. It was also recommended that the Board meet with its immediate neighboring states to discuss the possibility of extending Missouri's parkway plan to the other Mississippi River states.

Interior secretary Harold Ickes reacted favorably to the concept and suggested that the governors of each state name a ten-member commission to represent their state on the Mississippi River Parkway Planning Commission. These ten State

Parkway Commissions now form the National Mississippi River Parkway Commission. (The ten states involved in the Great River Road program are: Arkansas, Illinois, Iowa, Kentucky, Louisiana, Minnesota, Mississippi, Missouri, Tennessee and Wisconsin).

Hearings on the proposal were held in 1939; however, further action was delayed as America became involved in World War II.

Following the war, congress authorized funds for a feasibility study of the proposed Mississippi River Parkway, which was completed in November, 1951. The re-

port concluded that developing a national parkway system on an entirely new location along the Mississippi River was not advisable primarily for reasons of land acquisition and construction costs, and duplication of existing highways. Instead, it was recommended that a plan for a scenic route should be developed by the states and administered by the various state highway departments by improving suitable existing highways to parkway-like standards.

The Federal Aid Highway Act of 1954 included an appropriation of \$250,000 for Phase I Mississippi River Parkway planning. The Phase I reports recommended that each of the states should determine one specific route within its boundaries for the Mississippi River Parkway.

Phase II planning studies on the specific features of the Mississippi River Parkway route began shortly after Phase I studies were completed. Funds for initial development of Phase II studies were provided from the remaining portion of the \$250,000 continued in the Federal Aid Highway Act of 1954 for Phase I planning, combined with an additional \$250,000 for Phase II planning provided by Congress in the Federal Aid Highway

Act of 1964. These detailed Phase II planning studies were developed throughout the next six years and provided recommendations with regard to land acquisition, scenic easements, and controlled access.

With the completion of Phase II reports in the early 1970's, the States had reached the point where actual development was ready to begin. Congress then took further action to realize and implement the objectives of the Mississippi River Parkway program, soon to be known as the National Scenic and Recreational Highway (Great River Road).

Legislation to fund the development of the Great River Road was first included as part of the Federal Highway Act of 1973. This measure was approved by Congress in April, 1973 and later signed into law by President Richard Nixon. The Act authorized \$90 million for Great River Road development projects.

President Nixon later impounded all Federal highway construction funds in 1973 for anti-inflationary reasons and the \$90 million was not released.

A change in the Administration brought with it a new delay in the obligation of Great River Road funds. President Gerald Ford did not include funds for the development of the Great River Road in the fiscal year 1975 budget because of the lack of cost data for the formula used to apportion the funds among the ten Mississippi River states.

Early in 1976, Congress voted to release and distribute the \$90 million for Great River Road development, based on obtaining the necessary cost data.

In addition to providing the funds contained in the 1973 Federal Highway Act, Congress authorized additional funds for the development of the Great River Road in 1976. Arkansas Congressman Bill Alexander and Minnesota Congressman James Oberstar worked to include an authorization of \$78.75 million for Great River Road development in the Federal Highway Act of 1976.

During Congressional action on the 1976 Federal Highway Act, the concept of the Great River Road was clarified. Specific language was adopted and approved stating that "the Great River Road is not meant to be a major roadway along the entire length on both sides of the Mississippi River. It is to be one road that criss-crosses the River several times." Congress also reaffirmed that the existing roadbed

along the Mississippi River "should be used feasibly except where there are significant breaks in continuity in the Great River Road."

In the summer of 1978, a proposed four-year authorization of \$140 Million for the construction and reconstruction of the Great River Road was included in the Federal Highway Act of 1978.

Specifically, the Act authorized from the Highway Trust Fund \$25 million per year for fiscal years 1980, 1981, 1982 and 1983 for construction or reconstruction of roads on a Federal-aid Highway System. The 1978 Federal Highway Act also authorized from the General Fund \$10 million per year for fiscal years 1980, 1981, 1982 and 1983 for construction or reconstruction of roads not on a Federal-aid Highway System.

With the authorization of funds by Congress for the development of the Great River Road, implementation of the program began. Over \$300 million has thus far been authorized to implement plans that were initiated over 40 years ago for the development of a Mississippi River Parkway System. The Arkansas portion of the Great River Road enters the state at West Memphis across the Interstate 55 Bridge and leaves the state through Shives on Highway 82 across the Greenville Bridge. The 254 miles of Arkansas Great River Road includes 220 miles of main line existing roadway, 22 miles of new location, and 34 miles of spur routes.

So far to date Arkansas has received an allocation of \$25.35 million for an average of \$4.23 million per year over six fiscal years.

Arkansas has utilized Great River Road funds for a number of highly successful road and amenity projects. However, two projects are particularly notable: the St. Charles White River Bridge and the Lake Village Tourist Information Center.

The St. Charles White River Bridge, a project first suggested in 1953, became a reality with ground-breaking ceremonies on November 6, 1979. The bridge and approaches, to be completed early in 1982 at a cost of a little over \$10 million, will replace a White River ferry that is frequently out of operation due to high water. Without the ferry, local

people and tourists alike have to extend their trip an additional 50 miles to reach the other side of the river. The new White River Bridge will eliminate detours and inconveniences, while saving energy.

The Lake Village Tourist Information Center is a unique \$419,633 structure built of wood and glass on pilings over Lake Chicot. The Tourist Information Center is a solar heated building that allows the visitors to see how the solar energy equipment operates. The Tourist Information Center was dedicated July 17, 1980, and provides information to travelers entering Arkansas from both Louisiana and Mississippi. The Center is staffed with personnel from the State Department of Parks and Tourism.

In November the Highway Commission awarded a contract for the completion of approaches on State Highway 1 using the funds that were just released.

Another top priority is the improvement of U.S. 165 (formerly S.H. 1) north from the Pendleton Bridge over the Arkansas River to near Gillett. The road is in a lowlying area and becomes flooded

Welcome back to John Millican. John was in the hospital for several weeks for surgery on his leg. He's doing fine now and we're glad to have him back.





## Gray and Thomasson Elected AASHTO Officials



Highway and Transportation Department Director Henry Gray was elected Vice President of the American Association of State Highway and Transportation Officials at the association's annual convention in Chicago, October 5.

Gray succeeds John Clements of New Hampshire, who moved up to assume the presidency of AASHTO. Gray will become president of the organization in 1982, a year in which it is anticipated that major federal transportation legislation will be debated in Congress.
