

A MESSAGE FROM THE DIRECTOR

Weight-Distance Tax and AGR/TC Meetings Dominate Summer

This past summer has been one of the busiest we've had in a number of years.

The two issues that dominated the summer were the Weight-Distance Tax and a series of meetings aimed at removing the sales tax exemption on motor fuels.

The Weight-Distance Tax became law earlier this year and the department began collecting the tax from out-of-state trucks and issuing decals. The Revenue Department is collecting from Arkansas based trucks.

The American Trucking Association and several out-of-state trucking firms filed suit challenging the constitutionality of the law. Although the issue is not settled, the department was allowed to continue to collect the tax and deposit it in the State Highway Fund to be used for highway construction projects.

While the issue of constitutionality is being challenged, several Arkansas trucking firms have been complaining about retaliatory taxes being charged by some other states. These trucking firms are asking the Governor and the Legislature to repeal the Weight-Distance Tax.

At the Governor's request, the Highway and Transportation Department has agreed to challenge the retaliatory taxes in the U.S. Supreme Court.

In the meantime, Governor Clinton has said he will propose an amendment to the Tax law that will allow the Arkansas truckers to be reimbursed for any retaliatory taxes they have paid.


Nearly \$12 Million has been collected so far under the law. It has been estimated that \$21 Million will be collected each year.

The Arkansas Good Roads/ Transportation Council has been sponsoring a series of meetings at each of the ten Highway District Headquarters to promote the removal of the sales tax exemption on motor fuels. Legislators, County Judges, Mayors, and other community leaders were invited and presented with facts about the department's funding problems.

If the sales tax was applied to motor fuels, approximately \$40 Million would be raised. Under the current distribution formula, \$28 Million would go to the State Highway fund, \$6 Million to the cities, and \$6 Million to the counties. It is the Highway Commission's intention to use this additional money on the state's rural farm-to-market roads.

Nearly 6,000 miles of our 10,000-mile Secondary System is not eligible for Federal funds. Therefore, any improvements must be made with 100% State funds.

If we had an additional \$28 Million in State money, a tremendous amount of work could be done on our rural roads. As it is



We are asking the Governor to include the removal of the sales tax exemption in a call for a Special Session. At this time, the Governor has not reached a decision on this matter.

These are very difficult times for the department. Our revenues are not keeping pace with the growing needs. We must not only maintain our current source of funding, but we must also increase it. We cannot afford to lose the income being produced by the Weight-Distance Tax.

The Highway Commissioners and I are very concerned with the dilemma we face and we are continuing to work to solve these problems.

AGR/TC and AHTD Conduct Statewide Meetings

The Arkansas Good Roads - Transportation Council and the State Highway Commission have spent the summer meeting with Legislators, County Judges, City officials and community leaders throughout the state in an effort to rally support for removing the sales tax exemption on motor fuels.

The statewide effort began in June at the District One Headquarters in Wynne and continued through the summer with meetings at each of the ten district headquarters and Springdale.

At each meeting the invited guests were given a briefing on the financial plight of the Highway and Transportation Department and they were urged to support the AGR/TC and the Commission in their effort to have the sales tax exemption removal included in a call for a Special Legislative Session this Fall.

Gasoline and diesel fuels are now exempt from the state's 3% sales tax. Lifting that exemption at the wholesale level would produce about \$40 million a year. Under the current distribution formula, the Department would receive about \$28 million and the cities and counties each would get about \$6 million.

The Highway Commission wants to dedicate the additional revenues for use on the rural farm-to-market roads.

Commission Chairman, David Solomon of Helena told those in attendance at Wynne and Para-

gould that the state's secondary highways were being hurt the most by the lack of adequate state funds.

"Of the 10,000 plus miles of secondary highways in Arkansas, nearly 6,000 miles are not eligible for federal monies and must be improved with 100 percent state funds," he said.

Speaking to over 300 people in Pine Bluff, Vice Chairman Patsy Thomasson said the Department faces a funding crisis and needs more state revenues.

"Our financial position is much worse today than it was in 1977, when I was first appointed to the Commission," she said.

Commissioner Raymond Pritchett told a crowd of about 200 at Batesville that few people understood the complex highway funding system and most don't realize that the Department receives no money from the sales tax or state income tax.

He also stressed the importance of having adequate state funds to take care of the pressing needs on the secondary system. "This road system will not stay together by itself. You can only seal cracks so long," he said.

AGR/TC President, Dr. Silas Snow, said his organization was sponsoring the meetings to get grassroots support for the proposal. He stressed that it was very important for people at the local level to understand the problems and urge their elected representatives to support it.

Roads in poor condition can cost a motorist up \$186 a year in the form of damage to shock bsorbers, suspension systems, wear and tear on tires and additional fuel usage. In contrast, lifting the exemption on motor fuels would cost a motorist only about \$24 a year.


Dr. Snow said the AGR/TC believes the benefits derived from the additional revenues would be well worth the small increase in costs to the motorists. He pointed out that traditional sources of funding (a fixed cents per gallon fuel tax and registration fees) have been declining while construction, maintenance and other road related costs have been rising.

Of the state's 16,100 miles of state highways, 23 percent are good, 38 percent fair and 39 percent poor.

The AGR/TC and the Highway Commission contend that the situation will get worse in the years to come if additional State funding is not available.

Boy Staters Tour AHTD Complex

Thirteen delegates to the American Legion Boys State Convention visited the Highway and Transportation Department Central Office complex in June.

The young men went on an orientation tour of the various divisions and sections and were shown a lide presentation on the department's activities.

Public Affairs Officer Bill Looney briefed the delegates on the department's responsibilities and answered questions pertaining to highway matters.

In the Roadway Design Division the delegates

went over a set of construction plans with Division Head Bob Walters and then toured the various design squads to get a first hand look at how plans are prepared.

Another stop on the tour included the Materials and Research Lab. Research Engineer Jerry Westerman explained the functions of the Division and the delegates were able to see for themselves how the various tests are performed on materials used in highway construction.

Bridge Replacement Is A Top Priority In Arkansas

The collapse of a bridge on I-95 near Greenwich, Conn. in June rekindled the national concern over the condition of our highway bridges. Three people died when a span dropped into the Mianus River.

It was a similar incident, the collapse of the Silver Bridge between Point Pleasant, West Virginia, and Kanauga, Ohio in 1967, that first focused national attention on the problem of bridge deterioration and aging. The Silver Bridge tore loose from its supports and thundered into the Ohio River during the evening rush hour, killing 46 people.

The federal government created the Special Bridge Replacement Program in 1970 and required that all bridges on the federal-aid system be inventoried to determine their condition and assign priorities for replacement or repair. The Surface Transportation Assistance Act of 1978 expanded the inventory to include all bridges off the federal-aid system.

The bridge inventories are conducted by the states themselves which report the results to the Federal Highway Administration.

About 60 trained bridge inspectors are responsible for checking on the condition of Arkansas' 14,708 bridges. State highway bridges and city and county bridges are inspected at approximately two year intervals.

There are 6,691 bridges on the state highway system. Of this number, 1,777 are deficient, or 26 percent of the total.

Of the 8,017 city and county bridges, 6,522 are deficient.


However, a deficient bridge is not necessarily in danger of collapsing.

A structurally deficient bridge is one that has weakened or deteriorated to the point that it cannot support all types of vehicles. Such bridges must be restricted to light vehicles, closed to traffic, or immediately repaired to prevent further deterioration. There are about 650 state highway bridges in Arkansas posted for weight limits of less than 73,280 pounds. Four bridges are closed because of recent flood damage.

A functionally obsolete bridge may be structurally sound, but can no longer safely serve today's traffic because of outmoded design features such as the alignment of the approach roadway or the bridge width.

Arkansas does not stand alone in fighting the bridge replacement problem. Nearly half of the nation's bridges are deficient, and 18 states report





more than half their bridges deficient. In Arkansas, £6.4 percent of all bridges are deficient.

Fifty-one percent of the state highway bridges in Arkansas are less than 25 years old. Thirty-two percent are 25 - 30 years old, and 17 percent are over 50 years old.

It is estimated to cost over \$300 million to replace the deficient state highway bridges and another \$600 million to take care of the city and county bridges in the state.

The Surface Transportation Assistance Act of 1978 provided an average of \$13 million a year over a four year period for bridge replacement in Arkansas. The 1982 Act increased the funding level to about \$30 million a year over the next four years.

Although this increase in funding will help, it is still not enough to meet the need. Additionally, it places a burden on the state to come up with its 20 percent matching money. In 1982 only 25 state highway bridges were replaced. It is the department's goal to replace 100 bridges in 1983. This will depend on whether or not the state is able to match all available federal aid. At the rate of 100 bridges a year, it

will take about 18 years to replace all of the deficient bridges presently on the state highway system. Of course, as each year goes by, other bridges become older and more deteriorated and are added to the deficient list.

The fact that Congress has recognized the problem and increased funding for bridge replacement is certainly a good sign. However, the problem is so widespread that a continuing effort will be needed at both the federal and state levels for the orderly replacement or repair of the nation's deficient bridges.




Summer Flooding Destroys Bridge

As work was progressing in July to repair or replace several bridges in northeast Arkansas that were damaged by floods last December, heavy rains and flooding took its toll on five counties in southwest Arkansas.

The Mine Creek Bridge on Hwy 355 south of Mineral Springs was lost as a result of the storms.

Two spans on the 254-foot structure gave way and crashed into the rushing water. One woman was killed when her car ran off the bridge and was washed downstream.

Initially, it was thought that the damage could be repaired by building a new pier and replacing the



missing spans.

However, after the water receded, more damage was found under the remaining piers. The damage was so great the department had no alternative but to completely replace the bridge.

A detour bridge is being built first in order to carry the traffic around the existing bridge location.

Plans are being prepared for the new structure and it will go to contract as soon as possible. The department will use 80% federal Bridge Replacement funds and 20% State matching funds to construct the new bridge.

Four-day Work Week Proves Effective

What started out three years ago as an experiment to cut costs has developed into an on-going program that has proven its effectiveness.

The ten-hour, four-day work week is not a new idea, but it was a different approach for the Highway and Transportation Department to take when it began looking for ways to reduce costs and increase productivity, according to Chief Engineer Bill Cooper.

"Faced with the problem of declining revenues, the department began taking steps several years ago to cut back. Equipment purchases were reduced, overall employment was reduced through attrition, some services such as mowing and litter pickup were reduced, and many of the field personnel were put on the four-day week from April to October," Cooper said.

According to estimates prepared by the Maintenance Division, the four-day week has resulted in a 6.7% increase in production of work with existing forces. This increase is equivalent to an additional 95,000 productive man-hours worth an estimated \$900,000 to the department. The new schedule means a 20% reduction in travel to and from the various job sites and will save approximately \$154,000 in fuel costs. Other expenses related to reduced travel are estimated to save \$130,000.

Maintenance crews, as well as some personnel in the Surveys, Planning, Traffic, and Materials Divisions, are affected by the schedule.

In addition to increasing productivity an saving money, the four-day week has also improved employee job satisfaction.

Fred Doles, Pulaski 2 Area Foreman, said everybody on his crew liked the work schedule. "They like having Friday off," he said. "It gives them a chance to take care of personal business that they would otherwise have to take annual leave for."

Doles has been Area Foreman for four years and has worked for the department a total of 11 years. He said the four-day work week is "one of the better things that has happened" since he has worked here.

"I'd like to see it continued. I wish we could do it all year, but I know that may not be practical during the winter months when there is not as much daylight time," he said.

On occasion emergencies occur on Fridays and Doles may have to spend part of a day off working. "That hasn't happened much and it's not been a problem rounding up a few guys to go out and work," he said.

A side benefit that some supervisors have noticed is an improvement in attendance.

"I've noticed we don't have a problem with people abusing sick leave," said Verlin Brown, district wide Crew Leader at Paragould.

"The morale is better. It's great. Most of the people on the crew really like it," he said.

Brown believes they are getting more work

done in a ten-hour day, four-day work week than ey were on the five-day schedule.

"Since we work district-wide, we have more territory to cover. Our work may be two counties over from here. This way we spend less time traveling each week and more time on the job. We are getting about two hours more productive work time per man per week this way," Brown said.


The four-day schedule will end October 1 and Brown said he would like to see it extended in the future at least to the end of October to take advantage of Daylight Saving Time.

Greene County Area Foreman Darrell Hyde also likes the schedule. "Attendance is better and the crew members are saving their vacation time, too," he said.

Backhoe Operator Charles Harvill of the Greene County Crew agreed with his boss. "I'm saving my vacation time this summer because I love to duck hunt. I'll take those days off this winter and get in more hunting," he said.

Harvill is using his extra day off each week to take care of personal business, such as getting his drivers license renewed or other things that can only be done during the week.

Overall, he likes the four-day week, and said he looks forward to it every year. The only problem has een with the heat late in the afternoon. "Maybe we could come in an hour earlier in the morning and get off earlier in the afternoon to avoid some of the heat," he said.

David Tenner, an Erosion Controller at the Pulaski 2 Area Headquarters, said his attitude toward his family and job has improved since he started on the four-day schedule.

"I have more time with my family when I'm off three days and I enjoy that," he said. "I also feel more rested after the weekend and that has left me with a better attitude about my job," he added.

Tenner said his co-workers all like the fourday week and would like to see the department continue it.

Overall, the program has been a success for the department in terms of savings and productivity, according to Dan Flowers, Assistant Chief Engineer for Operations.

"I believe we are utilizing it in the best areas," he said, referring to the maintenance employees and other field personnel.


"It would be difficult to include other employees in the program since we must operate so many functions on a five day basis to serve the public," he said.

The department plans to continue the four-day schedule each year, Cooper said.


"We will probably continue to operate during April to around the first of October. Seasonal limitations come into play later in October for certain types of work, so it is not practical to continue the 10-hour days much longer than we presently are," he said.

Todd Wetzell, Highway Police Patrolman with 2 years service, talks to a truck driver at the Lehi Scales.













AHTD Completes First Rail Rehabilitation Project

A day-long celebration marked the completion of the rehabilitation of the Arkansas Western Railway Company's Waldron, Arkansas to Heavener, Oklahoma line, July 11.

The celebration started at 9:00 a.m. when the first of about 300 people rode by bus from Waldron to Heavener to board special railroad cars decorated in red, white and blue for the 35-mile train ride back to Waldron. For many it was the first opportunity to ride a train. It was a treat for both the young and old and the Kansas City Southern Railway Company made numerous trips during the day for those who wanted to ride the train.

The Arkansas Western Railway, a subsidiary of KCS has operated the line since 1902. Scott County residents had gathered near the same spot 81 years ago to drive a silver spike commemorating the completion of the line. The 1983 celebration was just as meaningful.

Just a few short years ago this line was being considered for abandonment by the railroad. This would have been disasterous for the Waldron area since many of the major businesses depend on the railroad for transportation of their products and possibly would have been forced to relocate without the services of the railroad.

The dedication ceremony started promptly at 3:00 p.m. at the Tastybird Corner crossing. Gov. Bill Clinton, who rode into Waldron by rail, said the future growth of Scott County rested with completion of the work, the first project of its kind under the federal railroad rehabilitation act.

The \$4.7 million project began during Clinton's first term as governor and he credited State Rep. Bud Rice of Waldron and former State Senator Gene Rainwater of Greenwood as having been instrumental in arranging the railroad improvement package.

The Waldron to Heavener project was selected as the top priority for rehabilitation in Arkansas and as such was the first rail project let to contract by the Highway and Transportation Department under the Railroad Revitalization and Regulatory Reform Act of 1976, Highway and Transportation Director Henry Gray noted.

Funding for the project was a cooperative effort involving the Federal Railroad Administration and the KCS. The Highway and Transportation Department's Rail Plan Section handled the administrative details and the project construction activities were monitored by Resident Engineer Dale Spencer and Resident Inspector Pete Page.

Gray told the audience the KCS had invested

nearly \$3 million of its own money in the project and had committed itself to the people of Waldron and Scott County.

Nearly 10 miles of the line is located in Oklahoma and the Oklahoma DOT made available \$1.3 million of its 1979 allocation of FRA funds, through a Rail Funds Transfer Agreement, to the AHTD for use on this project.

It took the cooperation of many - federal, state, local and the railroad to get the jobs done, J.E. Gregg, vice president of operations for KCS noted.

"It took almost a perfect situation to come to the fruition of today", Gregg said.

Waldron Mayor Carlton Roberds called the rehabilitation of the KCS rails more important than the opening of the section of line 81 years earlier.

The dedication site was adjacent to Valmac

Industries, one of the prime users of the Heavener-to-Waldron line. The company receives from seven to eight train car loads of grain weekly.

The days festivities continued with a "Fun-Food-Fellowship" including fried fish, chicken, hush-puppies and all the trimmings at the Waldron St. Judes Church grounds.

The 35 miles were rebuilt with 43,540 cross ties, 120,092 rail anchors, 92,035 tons of base aggregate, 29 new timber trestles and 15 repaired trestles.

Primary track work of ditching, tie replacement, ballast rail surfacing and alignment, and laying of continuous welded rail was done by KCS work forces. Subcontracts for replacing timber bridges with metal pipe culverts were let to Weaver-Bailey Company for the Oklahoma portion, and Hamilton-Patton Company for the Arkansas portion.

Jackson Heads Right of Way Division

The Federal Highway Administration along with the assistance of the Arkansas State Highway and Transportation Department presented a Business Relocation Course the week of July 11th - 15th. Pete Becker from the Fort Worth Regional Office of FHWA and Jack Wineberg from the Washington Office were the class instructors. Federal Highway Administration officials and State Highway Department personnel from six states: Kentucky, Oklahoma, Texas, Louisiana, Tennessee and Arkansas attended.

Dick Rohwedder from SCORE gave a speech on the activities of his organization. The SCORE organization stands for Service Corps of Retired Executives. They have branches in Arkadelphia, Fort Smith, Rogers and Little Rock. He also explained the services available through ACE which is Active Corps of Executives. These organizations are nationwide and can be of real benefit in helping businesses relocate.

Jack Cox of the Farmers Home Administration and Ross Nesheim of the Small Business Administration, both explained different programs their organizations could offer in assistance to businesses that are relocating.

The purpose and intent of this Course was to inform the participants how to more effectively relocate businesses. The Course was put together in the form of Case Studies. Each day different groups read and discussed the different approaches and solutions to solving the problems of a Business move and the different types of payments they would be eligible for.



Lime-Fly Ash Injection Being Tried For Embankment Stabilization

A Federal Highway Administration Regional Demonstration of lime-fly ash slurry injection for embankment stabilization was sponsored by the FHWA in West Memphis in July. The attendance of 42 included representatives of the State Highway and Transportation Department, six other state highway departments, the FHWA, the Corps of Engineers, Valley Forge Labs of Pennsylvania, Chem-Ash Cororation, Woodbine Corporation, and the University of Arkansas at Little Rock. This meeting was in conjunction with a project to demonstrate the correction method on the southeast embankment slope of Bolling Road Overpass on I-40 near West Memphis. The objective of this project is to demonstrate the benefits of utilizing a fly ash (from White Bluff at Redfield, Arkansas) with low pressure lime slurry injection by collecting information on the design, construction, and performance of an embankment stabilized by this method. Successful results will lessen the waste of one of the nation's resources while providing an abundant materials source. It will also allow conservation of a scarce and expensive good quality material by serving as a cost effective stabilizer for cheaper, more abundant, lower quality material.

The project is funded through the FHWA Demonstration Projects Program Project No. 59, "The Use of Fly Ash in Highway Construction". The contract is between the AHTD Maintenance Division and the FHWA Demonstration Projects Program, with a subcontract between the Department and Woodbine Corporation, who will perform the injection with their patented process. The contract also funds the use of Department personnel and equipment for slop dressing, construction inspection, instrumentation, monitoring, and reporting for a five year evaluation period.

The reports portion of the meeting included

presentations and discussion of the history of embankment stabilization, the design and application of this method, and the monitoring plan for evaluating the success of the project.

The field demonstration included the stabilization of the southeast side slope of the south approach embankment of the Bolling Road bridge structure overpassing I-40 near West Memphis. The process involves the injection of a lime-fly ash slurry into the embankment on a predetermined grid pattern to a depth of 10 feet.

Arkansas currently has three coal fired electric generating plants in operation which produce an estimated 375,000 tons of fly ash annually. Fly ash, a by-product of the coal combustion process, is the lighter portion of the residue recovered during the filtering of flue gases from the plant. The chemistry of some fly ashes is such that in the presence of lime and moisture, these fly ashes are suitable for use as a supplement or replacement for lime and portland cement. With the current emphasis on greater use of coal in this country and the resultant increase in the supply of the by-product, attention has been focused on possible beneficial utilization of this material rather than mass waste disposal.

In the West Memphis area of eastern Arkansas, the supply of local, good quality construction materials has dwindled to the point of being scarce or non-existent. Many of the approach embankments for the interstate system were constructed of local, lower quality fill materials and have, on occasion, failed requiring costly, yearly maintenance. Rather than import good quality materials for replacement, the area was selected to evaluate the ability of a lime-fly ash combination to stabilize an embankment slope by pressure injecting the combination into the fill material.

A Word About S-A-F-E-T-Y

James Mansfield, Safety Officer

Over and over again, we hear the phrase "I don't like your attitude" or "You've got a bad attitude". ATTITUDE—What is it, or more specifically, how do we develop a good safety attitude?

The dictionary defines attitude as "a state of mind or feeling with regard to some matter". The National Safety Council defines safety attitude as "a readiness to respond effectively and safely, particularly in tension producing situations". Supervisors play a very large part in spawning and forming the safety attitude of their personnel. However, before you can develop this attitude in your personnel, you must first look at yourself. How do you view your safety responsibility?

The primary purpose of the Safety Office is to aid in the prevention of accidents primarily among AHTD employees with the objectives of saving human lives, reducing human suffering and curtailing financial losses to the State.

PRIMARY RESPONSIBILITIES:

To Prevent Accidents and thereby protect the lives of AHTD personnel, as well as the lives of the public whom we are hired to serve through the maintenance and construction of highways.

To Reduce Costs by promoting the safe and efficient operation of Department activities.

To Improve Morale and increase the efficiency of AHTD employees by creating attitudes and encouraging discipline which will reflect the professional status of our employees.

To Encourage our employees to enhance the AHTD's position in the communities in which they reside and work. We must not forget that our AHTD exists through public permission and good safety practices do much to create a good public attitude toward our organization.

To Reduce off-the-job accidents of our employees by having on-the-job safety training programs.

To accomplish our objectives all employees who work for the Department should be trained so they can develop maturity, sound logical thinking and, above all, courtesy to the public. The high cost of equipment, insurance, medical aid, and lost work days make it essential that this program be as effective as possible.

Each employee of the Arkansas State Highway and Transportation Department plays an important role in the building and maintenance of our great system of highways. Your presence on the job at all times is therefore essential. Because of this, as well as in the interest of your own and your family's well being, Safety should be foremost in your mind at all times.

Proper job performance not only involves knowledge and skill but also requires a constant awareness of the importance of Safety. No job is so important and no service so urgent that time cannot be taken to work in a safe manner.

A good safety record depends upon the interest of the individual employee in observing safety rules, keeping his mind clear, and going out of his way to do the common sense things which make for a perfect record.

If an employee is conducting an operation in a manner dangerous to himself or others, his attention should be immediately called to the danger. Everyone should be constantly watching for hazards along the highway. If one is noted, prompt action must be taken, either to have it removed or to notify the proper supervisor.

In our efforts to achieve an attitude of safety as employees of the Arkansas State Highway and Transportation Department, we are required to maintain courteous, businesslike relations with the public. A courteous act is invaluable. Courtesy and tact in these relations with the public and AHTD employees will be reflected in increased respect and good will for the entire Arkansas State Highway and Transportation Department.

New Radio Equipment Installed

A four-year program for the replacement of the Department's radio equipment was completed in July with the installation of a new microwave and multiplex system at the Central Office, according to Cal Porterfield, Radio Section Head.

In the early 1960's the Arkansas State Highway and Transportation Department installed a statewide radio system which provided communications with

the ten Districts, Area Headquarters, Weigh Stations, and some of the Resident Engineer Offices. This system provides the AHTD with a vital service which is necessary for the efficient operation and maintenance of our highway system.

In 1979 the Highway Commission approved a four-year program for the replacement of radio equipment which, because of age, nonavailability of some

critical replacement parts, frequent breakdowns, and deterioration of system quality, had made much of the equipment obsolete.

The first phase consisted of the replacement of control stations at Area Headquarters, Weigh Stations

and Resident Engineer Offices. Phase two and three provided for approximately 350 mobile radio units.

The fourth-and final--phase provided replacement equipment for the Central Office, providing communication links between the ten Districts and the Central Office control console. The new equipment which was purchased from Motorola, Inc. and installed by the AHTD Maintenance Division-Radio Section personnel provides the Department with the most advanced state of the art equipment available. A teletype receiver located in the Communications Center provides current weather information to the operators which may be transmitted immediately to any area of the state which may be affected.

The entire system has been installed and is maintained by the Department's staff of communication specialists.

Harold Harrison is the daytime radio operator and has been manning his station since 1969.

Ronald Jackson works evenings from 3:00 p.m. until 10:00 p.m. and Saturday from 7:00 a.m. until noon while attending Arkansas College of Technology.


Evelyn Kiernan is secretary for the Section and is sometimes pressed into service as a radio operator.

Highway Planners Collect Truck Data

Providing the necessary data used to plan and design an efficient and convenient highway system requires continual effort. Data collection activities for the Planning Division's Technical Services-Field Operation is a daily way of life, especially during the summer months. One such activity is the ongoing "Truck Weight Study", employed to obtain information about truck weights and commodity movements.

Summer employees under the direction of Technical Services field personnel and assisted by the Arkansas Highway Police conduct truck weighing operations at various locations around the state. Weighing procedures are performed using platform scales at permanent enforcement stations and portable scales at other selected sites. These activities are directed toward producing reliable data efficiently, while maintaining safety of the traveling public and field staff.

The information collected is necessary for transportation planning at both state and national levels. The data are used to determine range and frequencies of loads imposed upon our highway facilities, dimensions of the vehicles, and the commodities carried. At the national level, data collected by the states are the basis for estimating annual travel by type of truck, ton-miles of cargo hauled by type of highway, and changes in axles and gross weights.

Commissioner Hopper's Daughter Chosen As Miss Arkansas 1983

Highway Commissioner Bobby Hopper and his wife, Lois, have a lot to be proud of these days. Their daughter Regina was crowned Miss Arkansas 1983 in July.



National Research Council To Conduct Study On The 55 MPH Speed Limit



The Department of Transportation has announced that the National Research Council of the National Academy of Sciences has initiated a comprehensive study of the benefits and costs of the 55 mile-perhour national maximum speed limit.

A 19 member panel has been selected to assess the safety, energy and economic effects of the 55 mph speed limit law.

The Academy panel will deliver a study report containing conclusions and recommendations to the Secretary of Transportation and the Congress in August 1984. The department's National Highway Traffic Safety Administration is funding the study.


The Congress directed that the study be undertaken with passage of the Surface Transportation Act of 1982, enacted January 6, 1983. Section 204 of the Act requires a comprehensive study and investigation of (1) the benefits, both human and economic, of lowered speeds due to the enactment of the 55 mph national maximum speed limit, with particular attention to savings to the taxpayers, and (2) whether the laws of each state constitute a substantial deterrent to violations of the maximum speed limit on public highways within such state.

The 55 mph speed limit was initially established on January 1, 1974 as a temporary energy conservation measure during a period of

severe interruption in the domestic oil supply. During the first year of the 55 mph law, fatalities on the nation's highways declined dramatically with some 9,000 fewer deaths than the previous year. The law was made permanent in January 1975.

One major focus of the Academy study will be to assess the extent to which the 55 mph speed limit contributed to the decline in motor vehicle fatalities, and to estimate the likely contribution of the 55 mph speed limit in reducing fatalities now.

Legal Division Collects Over \$400,000 for Damages to State Highway Property



The Legal Division collected \$432,634.28 in this last fiscal year for damaged state property such as bridges, guard rails, and state vehicles.

Persons who negligently damage state property are responsible for the repairs. The collection process begins with a foreman checking the highways for damages. The damages are repaired, a police accident report obtained, and the costs are sent to the Legal Division.

Ted Goodloe and Laverne Thompson process the costs against the appropriate insurance companies and individuals. The collection process can be as simple as a letter to the appropriate insurance company or as complicated as a court trial. Some individuals have no insurance and pay the damages over a period of time. The money collected is placed into the district or division budget.

FHWA Reports Over 95% of the Interstate Highway System Is Now In Service

According to the Federal Highway Administration, 95.9 percent of the nation's Interstate Highway System is now open to traffic.

FHWA Administrator Ray Barnhart reported that a total of 40,752 miles of the 42,500 mile Interstate System have been brought into service. Included in the total are 223 miles that were put into use since December 31, 1981.

He said various improvements are still required on some portions of the open Interstate System. These improvements range from the construction of additional lanes and control of access to the posting of signs along roadsides and other final phases of construction.

"Currently, construction is underway on 566 new miles of Interstate highways," Barnhart said. "Engineering or right-of-way acquisition prior to actual highway construction is in progress on an additional preliminary 912 miles." In addition, route location approval is pending on 148 miles for which public hearings have been held, while 122 miles have not yet advanced to the public hearing stage.

When completed, the Interstate system will consist of 32,982 miles of rural and 9,518 miles of urban highways. Currently, 31,886 miles, or 96.7 percent of the rural mileage and 8,866 miels of 93.1 percent of urban mileage are open to traffic.






