

A MESSAGE FROM THE DIRECTOR

DEDICATED EMPLOYEES REASON FOR CONTINUED PROGRESS

As another construction year nears an end and before the advent of the approaching Legislative Session, it is a good time to reflect on where we are and our future.

During this past year, I have attended meeting after meeting with Directors and Administrators of other Highway and Transportation Departments, analyzing and discussing our respective successes, problems and solutions. Each time, it becomes more obvious to me that we do more for Arkansas with a lot less than most Highway Departments – and it makes me very proud.



Despite our limited funds, extreme weather conditions, and natural disasters, we have been able to hold our own. Our citizens, for the most part, can travel on reasonably good hard-surfaced roads; we have been able to accommodate the needs of agriculture, tourism, and industry; and to date, we have not lost one nickel in federal aid, either because of lack of matching funds or inability to get plans ready. As a matter of fact, we always request and often receive federal funds for construction projects that other states are unable to obligate.

There is just one reason for this efficiency, and that is dedicated Highway Department employees. Maintenance crews, office staff, construction personnel and highway engineers all have displayed the innovation and initiative to conserve our limited resources that has permitted us to provide good roads during these demanding times.

The Highway Commission and I are not unmindful of the fact that our salary increases have been seriously inadequate during this present biennium. However, until corrections can be made that will provide salaries consistent with the efforts being produced, we think it is important that you know we recognize and appreciate the work you are performing and the extra effort you are giving to make this happen.

This coming Legislative Session brings opportunities, and you can be sure that we will be doing everything we can to strengthen our highway program and give proper consideration regarding adequate competitive salary levels.

PUBLIC HEARINGS

HIGHWAY 62 BYPASS

A second design public hearing on the proposed Highway 62 Bypass at Mountain Home was held June 21.

Since the time of the first design hearing in October 1980, a change in the provision of access to the facility was made. The original design allowed at least one access point to each parcel of property along the highway. Following that hearing the Department studied other similar facilities in the State and found that as traffic increased and adjacent land development occured, conflicts would arise which adversely affected not only the safety factor, but also the operational characteristics of the bypass. A decision was made to restrict access to the

Highway 62 Bypass, so a second hearing was held to receive public comment.

The facility is designed to ultimately be a fourlane highway. The first stage of construction, however, will be to build two lanes, and then as traffic increases, the additional two lanes will be built.

Because access will be limited to public roads and streets only, frontage roads will be constructed to serve traffic where feasible.

Twenty-five people spoke at the hearing and all expressed their support for the project which many said was badly needed to relieve the traffic congestion in Mountain Home.

MABELVALE WEST

Although the proposed revisions for the Mabelvale West Interchange with Interstate 30 in Little Rock are being funded with private money, the project must comply with all State and Federal laws and regulations. Therefore, a public hearing on the project was held

July 10 to receive citizen input. Garver & Garver, consulting engineer firm in Little Rock, is handling the design of the project under a contract with the developer of the proposed Otter Creek Mall which will be built near Interstate 30.

The interchange revisions, as well as a partial interchange on Interstate 430 near the development, are necessary to handle the anticipated traffic that the new mall will generate.

The project will be constructed in three stages. The first stage involves minor relocation and adjustments to the intersection of Mabelvale West Road and the east frontage road on Interstate 30. The second stage is the construction of on and off ramps to Interstate 430 at the proposed Otter Creek Mall Drive, on and off ramps to the westbound lanes of Interstate 30, the relocation of Otter Creek Road, and the relocation of the west frontage road. The third stage consists of constructing a new bridge across Interstate 30, new on and off ramps to the eastbound lanes, and the relocation of the frontage road.

According to the consultants, the road system outlined in stages one and two will adequately handle all traffic until the mall is 75 occupied. It is anticipated that it will be three to five years after the opening of the mall before all of the improvements in stage three are required.

HIGHWAY 1B IN DEWITT

The Highway 1 — Business Route is the main east-west arterial in the city of DeWitt. Current traffic counts show a little over 5,000 vehicles per day use this two-lane road. An accident study conducted in 1981 revealed numerous right-angle, rearend, and side-swipe accidents on this route. The construction of a third lane for left turns was recommended and approved by the Federal Highway Administration for funding with Federal Aid Highway Safety funds on a 90/10 matching basis.

The proposal calls for each lane to be 12 feet wide. In addition to the widening, a curb and gutter will be constructed and an underground storm drainage system will replace the open ditches which now exists.




Highway 1B in DeWitt

WHITE RIVER BRIDGE AT COTTER

About 100 persons turned out August 7 at Cotter for a public hearing on the Department's plans to construct a new White River Bridge on U.S. Highway 62 at Cotter. The proposed project would cost about \$5.3 million. Only a handful of persons spoke at the hearing, but no opposition to the project was voiced.

The plan calls for a new two-lane route for U.S. 62, beginning a mile west of the existing White River bridge, running along a ridge on the Marion County side of the river and across a new 274-foot bridge on Fallen Ash Creek, then turning east across the river on a 1,300-foot bridge just north of Bayless

Island and connecting with the current U.S. 62 route at its junction with Denton Ferry Road. From beginning to end, the route would cover 3.3 miles.

The existing White River bridge at Cotter would be kept in service, and the current route of U.S. 62 from the start of the new route to Denton Ferry Road would be a business route.

Highway and Transportation Department Surveys Engineer Charles Mitchell said the earliest bids could be let for the project would be mid-summer 1985, although right-of-way acquisition could begin next spring. The project would use 80 percent bridge replacement funds from the federal government and 20 percent state funds.

Mitchell said traffic projections show an increase from 5,000 cars per day across the bridge now used to 8,800 by the year 2002. There already is a high accident rate along the current route, and that would climb higher with increased traffic, which is a factor in determining the need for replacement for the 34-year old Cotter bridge.

Among those who spoke at the hearing was State Senator Vada Sheid, who called the project a "shot in the arm" for the area and one which is needed to relieve traffic congestion.

Cotter Mayor Rex S. Bayless said the City Council supports the plans. He said the project would have an effect on Cotter "like the railroad before the bridge and the steamboats before that."

ARKANSAS HIGHWAY POLICE

DIVISION BEGINS IN-SERVICE TRAINING

The Arkansas Highway Police Division has began an intensive in-service training program directed toward maintaining a high proficiency level for all officers.

The program is designed to provide annual review and certification in all aspects of law enforcement, including: firearms, radar, changes in statutory law, CPR, police tactics, and supervisory level courses.

Although all officers in the Division are certified law enforcement officers with full arrest powers statewide, the primary responsibility focuses on the regulation of commercial vehicles on Arkansas highways, according to Chief Roy Johnson.

This includes the enforcement of laws concerning truck weights and dimensions, vehicle and operator licenses, motor fuel taxes, highway use taxes, transportation of hazardous materials, and speed enforcement.

The Division has 197 employees assigned to 17 weigh station facilities and 44 roving units which are operated 24 hours a day.

All personnel hired by the Division as patrolmen must attend the basic police course at the Arkansas Law Enforcement Training Academy in Camden. This course provides the basics in law enforcement techniques. However, since the Highway Police officers deal in a specialized area, additional training is necessary for them to become familiar with their various responsibilities.

Captain George Coffman has been assigned as the Training Coordinator for the Division and works with the District Commanders and District Training Instructors to insure that all officers remain current in the training program. Coffman also serves as an instructor for many of the phases of training.

Assistant Chief John Bailey said one of the first things all new officers are briefed on is various state and federal laws and regulations that apply to commercial vehicles.

"We bring the officers to the Central Office and go over these regulations to be sure they are understood and uniformily enforced," Bailey said. "In addition, we hold annual refresher courses and update any changes in the laws," he said.


The enforcement of truck weight, height, and width restrictions is a major function of the Division. In addition to the 17 permanent weigh stations operated by the Highway Police, each of the 44 roving units are equipped with portable scales for weighing trucks throughout the state. This past year, more than 4.4 million trucks were weighed.

Speed enforcement is another area of major concern. Because of this, all officers must certify to operate radar and receive recertification training at least once every three years.

The application of radar enforcement falls within two primary categories: speed compliance enforcement of all motor vehicles and, speed/weight restriction on posted secondary highways.

At least one officer in each of the Division's five districts will be trained as a radar instructor and will conduct the recertification training in his district.

In addition to the use of radar, the Division is also using detector loops at selected locations around the state. Basically, the detectors are the same typo froad tubes, or hoses, used in taking traffic counts. However, in this case, two tubes are placed across the roadway several feet apart. The tubes are connected to a control unit which calculates the speed of a vehicle as it passes between the tubes. A Highway

Police officer and a technician operate the control unit and radio ahead to other officers the description and speed of any vehicle exceeding the speed limit.

The proper use of firearms is an essential element for all law enforcement officers. They must be prepared at all times for the unexpected and react accordingly.

Initial certification in the use of firearms is received at the training academy. Once on the job as Highway Patrolmen, the officers will be required to recertify annually.

The Police Practical Combat Course developed by the Division requires all officers to achieve a

qualifying score of 70% while firing at targets at various distances, around barricades, kneeling, prone, and standing positions. The officers have quarterly qualifications each year with each session being in a different phase of training.

In November of this year, five officers will attend the National Rifle Association's Firearms Instructors School in conjunction with the F.B.I. These officers will be responsible for conducting firearms training in each of the A.H.P. Districts.


Division officers are also receiving training in police tactics from the U.S. Air Force at the Little Rock Air Force Base. This course includes proper

search and seizure techniques and instructions on how to properly approach violators.


Assistant Chief Bailey said the Division has established an excellent working relationship with the Air Force personnel at the base and plans to continue using the firing range and other facilities at the base in the future. He said the assistance received by the Air Force has been instrumental in developing the training program.

Supervisory personnel in the Division are also assigned to attend the various courses offered by the Department and other state agencies. All supervisors have attended the T.H.E. (The Human Element) Course.

"The in-service training program was established to keep the quality of law enforcement at the highest level for the Highway Police at all times. By the end of this year, our personnel should be as well trained as any law enforcement agency in the State", Bailey said.

ENERGY COSTS REDUCED

SOLAR-POWERED COUNTERS SAVING MONEY

During the past two years, the Technical Services Section, Planning Division of the Highway and Transportation Department, has been replacing obsolete mechanical ATR (automatic traffic recorder) machines with modern electronic units powered by solar energy.

"The solar powered ATR's provide us with much greater site location flexibility and eliminate electrical hookup costs and monthly power charges," Jim Gilbert, Technical Services Section Head, said.

"In the long run, solar powered ATR's will mean a substantial savings to the State, as well as conservation of our electrical energy," Gilbert added.

Presently 24 of the 26 ATR locations are operating on solar power. The savings offset capital costs after approximately eight to ten months of operation. "This has reduced our operating expenses and should eventually result in a cost savings of approximately \$4,000 per year," Gilbert said.

ATR's are used to count and record the traffic at a particular location automatically, continuously, 24 hours, 7 days a week. They bring about a substantial savings in manpower, time and expense if this counting were to be done manually.

Gilbert said the Department will replace the remaining two electrical ATR's as part of construction projects planned on the routes where they are located.

A small solar panel is attached to the top of each ATR. The system converts sunlight directly into electrical


energy suitable to meet the requirements of the electrical load. Solar cells produce no noise, no heat, no fumes and no waste products.

In a solar installation, one 12-volt battery is used to assure power during cold, cloudy days. These batteries are charged by the solar energy and are not affected by electrical storms or other power outages.

"Anyway you look at it, solar powered ATR's are the way to go," Gilbert said.

ARCHEOLOGICAL RESEARCH

SITES PROVIDE HISTORICAL INFORMATION

The most desirable situation for the Highway and Transportation Department in relation to archeological sites is to avoid them completely. This is not always possible, and in those cases where a significant archeological site will be damaged by a highway project, some form of mitigation is required.

In the last four years, the AHTD in conjunction with the Federal Highway Administration, has been involved in three mitigative actions which have contributed significant knowledge of the history and pre-history of Arkansas.

In 1980, the replacement of the Bayou Macon Bridge on Chicot County Road 76 threatened a portion of an archeological site known as the Powell Canal. This site, recorded in 1967, was a prolific location and sizeable artifact collections had been made there. A small amount of testing had been done in 1971 by the Arkansas Archeological Survey. All this prior activity allowed the Department to recognize immediately the significance of the site, and to formulate a strategy whereby extraction of the maximum amount of data could be performed in the least amount of time. Testing and excavation was done in October 1980 by the Environmental Division, and excavation was done by the Sponsored Research Program of the Arkansas Archeological Survey in May 1981. The results of this project appeared as a monograph, "Powell Canal", by Mr. John H. House. About this volume, Dr. John Belmont says in his review: "It is the only such site yet excavated in Arkansas and one of the very few fully reported Troyville sites from any state. It is of signal

importance for the understanding of the culture history of the southern lower Mississippi Valley. The data included here are the most welcome addition to the archeological corpus."

The relocation of U.S. Highway 71 in Washington and Benton Counties, of northwest Arkansas. prompted the archeological survey of the proposed corridor in the late 1970's by the AHTD Environmental Division. This survey located a number of archeological sites, but through coordination with other AHTD divisions, all of these sites were avoided. A supplemental survey in 1981 discovered the Moser site, a late 19th, early 20th century farmstead in Benton County. Archeologists are always in search of sealed subsurface deposits, representing accidental time capsules. Three of these sealed deposits were found in the initial testing of the site and there were indications others might be present. These "time capsules" give us a unique view of life on an Ozark farm at the turn of the century, a view which cannot be found under other circumstances. In addition to the archeological work, oral interviews with members of the older generation were done. Some of the people interviewed had actually lived at this site as children. The results of this work are, as the time of this writing, at the printers and due to be published in the fall of 1984. This volume is entitled, "Independent But Not Isolated; The Archeology of a Late Nineteenth Century Ozark Farmstead," by Dr. L.C. Stewart-Abernathy, Beverly Watkins and John House. This is the first in-depth report on the archeology and history of rural life in the Ozarks during this time period, and as such will furnish a large amount of base line data for future research in the area.

The proposed Northbelt Expressway in northern Pulaski County prompted environmental studies of the alternate routes in 1983. The Ink Bayou archeological site was discovered in March 1983. Preliminary tests by the Environmental Division indicated the site was potentially significant. More intensive testing was scheduled by the Arkansas Archeological Survey and is still underway at this time. The Ink Bayou site is relatively small in size, but it has produced a great deal of material. This material indicates that the site is a small, prehistoric farmstead of one or two families. These people were part of the large, wide-spread population which used the Toltec Mounds as a ceremonial center about A.D. 600. Apparently this site was occupied for a relatively short time and is the only occupational site directly related to the Toltec Mounds site which has been examined. The report of this work is scheduled for publication in the summer of 1985.

In the last few years there has been a number of highway projects where archeological sites have been discovered as a result of standard environmental studies. In almost all of these cases it has been possible to avoid the sites because they were recognized early in the planning process and proper steps could be taken to circumvent them.

The three instances discussed are the three cases where sites were determined to be significant, but avoidance simply was not possible or feasible. More importantly, it worked out that the sites themselves

were not only significant, but unique in some respect.

The Highway and Transportation Department is not often thought of as an archeological operation, but it is certainly worth notice that through AHTD planning and sponsorship, three important archeological reports are acknowledged as major contributions to the body of knowledge in Arkansas and the southeastern United States. Because of them, a great deal is known which was not known before.

A WORD ABOUT SAFETY

THE USE OF SAFETY VESTS

A cooperative research study sponsored by the Texas Department of Highways and Public Transportation and conducted by the Texas Transportation Institute in cooperation with the Department of Transportation, Federal Highway Administration, relayed the following information concerning the use of safety vests.

Data collected for a two and one-half year period on Texas Department of Highways and Public Transportation employees show that 44 personnel were involved in site construction pedestrian accidents. The research source presented the following facts:

75% were not wearing safety vests,

52% were inside a barricaded/coned area,

Of the 48% of the personnel outside a protected area, 71% were not wearing safety vests,

36% were fatalities. (16 personnel) of whom:

56% were not wearing safety vests,

62% were outside protected area.

The study further revealed there is an increasing trend in pedestrian accidents at maintenance and construction sites. In all accident situations the larger percentage of injuries were received by the personnel NOT wearing safety vests. The Texas Department of Highways and Transportation encourages the use of safety vests by all personnel at maintenance and construction sites. There is, however, an apparent disregard for the recommendations.

A common reply by the driver in pedestrian accidents is "I just didn't see him/her." It is a proven fact that the pedestrian (even in a work zone) needs to be brightly attired in order to stand out to the approaching driver. The careless driver needs a bright reflective object, such as the safety vest to alert him of potential hazards presented by pedestrians and workers. The problems of pedestrian worker visibility is compounded by inclement weather, such as: fog, rain and haze. Be courteous, be bright, be safety conscious and "alive", by wearing your vests in all traffic related situations.

ACHIEVEMENTS CITED

CERTIFICATE OF MERIT PRESENTED

The Arkansas Good Roads/Transportation Council was awarded the Certificate of Merit for professional achievement by the national Better Roads/Transportation Council at the National Transportation Public Affairs Workshop in Hershey, Pennslyvania July 31.

The Award was presented to recognize the outstanding efforts of the AGR/TC in 1983 to promote better roads in Arkansas by conducting a series of statewide informational meetings.

AGR/TC President, Dr. Silas D. Snow, who was unable to attend the workshop, was presented the certificate by Highway Commission Chairman David Solomon at the Commission's August 23 meeting.

The Council and the Highway Commission jointly sponsored meetings at each of the ten Highway District and at Springdale during the summer of 1983 in an effort to rally support for removing the sales tax exemption on motor fuels.

At each meeting the invited guests, which included legislators, county judges, municipal officials and community leaders, were given a briefing on the financial plight of the Highway and Transportation Department. The guests were urged to support the AGR/TC and the Commission in their effort to have the sales tax exemption removed.

Gasoline and diesel fuels are now exempt from the state's sales tax. Removing the exemption at the wholesale level would produce about \$54 million. The cities and counties would each receive about \$8 million in additional turnback funds and the state would receive the remaining \$38 million.

The Highway Commission has gone on record to dedicate this additional revenue for use on the rural farm-to-market roads. There are about 10,500

miles of secondary highways in Arkansas and nearly 6,000 miles are not eligible for federal monies and must be improved with 100% state funds.

The National Transportation Public Affairs Workshop, which is an annual event, is sponsored by the American Association of State Highway and Transportation Officials (AASHTO) and the Better Roads/Transportation Council (BR/TC).

VAN POOL PROGRAM WINS AWARD

The Arkansas State Employees Association is one of the ten organizations throughout the United States to receive the Administrator's Award for Ridesharing in 1984, established by the Federal Highway Administration.

The award was presented June 18 by FHWA Regional Administrator Wesley S. Mendenhall, Jr. of the Fort Worth, Texas Regional Office. Representing the Governor's office was Maurice Smith, Executive Secretary to Governor Clinton, and accepting the award on behalf of ASEA was Execu-

tive Dierector L.D. Owen. Highway and Transportation Director Henry Gray represented the Department at the ceremony.

The Association is a private non-profit organization, which operates 40 vans carrying 600 commuters per day. The Van Pool program began in July 1979. The Highway and Transportation Department agreed to loan up to \$200,000 from Federal Urban System funds to the Association to purchase the vans. The initial loan was paid off in November 1982. (Continued on next page)

A significant achievement of the program is the number of accident-free miles. Recently, seven drivers were honored by Governor Clinton for each accumulating at least 50,000 miles of accident-free driving.

The award was established in 1982 to honor organizations that have made significant contributions to advancing ridesharing as a cost-effective transportation system.

More than 40 nominations were received for the 1984 award. Judging was based on achievement, innovation, comprehensiveness, and commitment.


TRANSPORTATION PLANNING DATA RECEIVED

Although the 1980 Census was several years ago, it is still generating excitement among transportation planners. The excitement is caused by arrival of the Urban Transportation Planning Package (UTPP) which was developed in conjunction with the FHWA and purchased jointly by the AHTD and the five Metropolitan Planning Organizations around the state. The UTPP is a set of special tabulations of transportation related data taken from the long form of the 1980 Census. A separate package is produced on computer tape, paper, and microfiche for each area designated as a Standard Metropolitan Statistical Area (SMSA) prior to 1980. This data will serve as the prime data source for urban transportation planners during the next ten years. No wonder its arrival has caused excitement!

The UTPP is divided into six parts of varying content and geography. Three parts are tabulated by the locally determined traffic zones which are used for transportation planning purposes. Totals are also given for block groups, tracts, cities, urban areas, and counties in each SMSA. Information consists of vehicle availability and use; family characteristics which determine transportation use patterns; and various work-trip characteristics. Work-trip commuting patterns shown by the UTPP's are particularly welcome because the collection of such origin-destination data is a very difficult and costly procedure now rarely undertaken. Commuting data is available for both trips internal to the SMSA as well as to and from the SMSA and the surrounding counties.

AHTD has arranged to purchase copies of the package for Little Rock-North Little Rock, Fort Smith, Fayetteville-Springdale, Pine Bluff, and

Texarkana through a cost sharing arrangement with the Metropolitan Planning Organizations in each area. We will also receive a copy of the Arkansas portion of the Memphis-West Memphis UTPP through an arrangement with the Mississippi-Arkansas-Tennessee Council of Governments.

IT'S BEEN A BUSY YEAR

The past year was a year of excitement, anticipation and concern in Data Processing. With the appearance of the personal (micro) computer, AT&T divestiture, and the changes that occurred daily, the Data Processing arena was stunned. It appears that it will experience more of the same this year. Industry analysts/experts are advising to plan a deliberate approach and devise patchwork solutions for communications and DP problems for the next couple of years. During this time, acquire equipment that can be put into an integrated environment when the time arrives. Standards for a hardware and software product for the larger computers are fairly well established. However, for micro computers, each vendor has a somewhat different set of standards. The normal pattern for acquiring a micro is for the solution to an existing problem, but soon the desire to share peripherals and files comes to the foreground. Suddenly, the solution to the original problem is now the problem.

Two important factors should be considered for any potential micro-mainframe computer connection products; integration and data transfer capability. Integration is the ability to interact with other products and data transfer is the various


methods used to move data from place to place. Recent reports indicate both are in need of improvement. The future will bring accelerated development of the much needed micro-mainframe technology.

If the function of the product is such that it will never be connected to other equipment, then integration is of no concern. However, if integration is a possibility, require the vendor to make available necessary hardware/software to communicate with the Department's main computer. Such integration is being accomplished in the vendor and research communities, but is complex and relatively expensive.

Due to the increased number of requests, the size of the projects, and the need for current information, Computer Services has plans to upgrade the Department's IBM 434l Computer to accommodate these needs. It will operate faster and have an additional 8 million bytes of memory. This will increase the performance for the remote user as well as routine production work. A more efficient communication controller will also be installed later in the year. This communication device will provide greater flexibility in the use of our communication network. We have installed several local CRT terminals within

the Central Office Complex for use in the Highway Use Equalization Tax, Pavement Management, and Voucher Systems. This provides the users an improved methodology for entering and retrieving data that is stored on the host center.

Over the past ten months Computer Services' personnel have installed 27 CRT terminals, 11 printers, and 14 modems at the District Headquarters and Jacksonville. This new equipment will allow on-line entry for improved performance and error checking for the new on-line systems (Parts Inventory, Equipment Management, Payroll, Fuel, and Rental) at each District. The District personnel have shown a positive attitude in helping us make these installations as easy as possible and also offering suggestions for improvement.

HART TURNS ADVERSITY INTO NEW CAREER

It is truly amazing when someone can go through events in their life that most of us feel would destroy us, and come through with strength and vigor. A good example of such a person is George Hart of Computer Services. He is no quitter to say the very least.

Hart was blinded in an accident seven years ago while turkey hunting. "I topped the ridge and turned to walk down the other side, and another hunter saw some movement in the brush, thought I was a turkey, and shot me," Hart said. Hart was shot from the waist up with a shotgun blast that blinded him instantly. Even though it meant the end of his sight, Hart holds no grudges or hard feelings toward the other hunter.

Other than being an avid sportsman, Hart enjoys his work in the engineering field. He graduated from the University of Arkansas at Fayetteville in 1964 with a Civil Engineering degree. Before the accident, Hart did engineering design work with Garver & Garver Engineers, Inc., where he had worked for 12 years. After he was blinded, he obviously could no longer continue working in engineering design, al-

though he did continued to work with Garver & Garver for about two years as the Coordinator of Surveys.


Doctors told Hart that he may regain his eyesight in his right eye, but after about three months he realized he would probably be permanently blind. He then went to the Arkansas Enterprise for the Blind to study braille and learned to use a cane. He later had to resign from work with Garver & Garver and decided to move to the country. "I really enjoyed it out there in the country, but there really wasn't anything to do, especially in the area of working your mind. I wanted something that would present problems to solve, and tax your mind," replied Hart.

He soon moved back to Little Rock and began taking computer courses. He felt that computers would be something he would enjoy, and realized the computer field had opened up to the blind with revolutionized improvements. "I find it very similar to Engineering Design because of the logical thinking process. You go step by step from point A to point B by a logical succession of steps," Hart said. Since

computers and engineering are similar in many areas, Hart's engineering background is very valuable. He may also get back into direct work in engineering through computers as well.

After contacting the Highway Department earlier this year, Hart was accepted for a Computer Services job. He uses a braille terminal that has the same function as a visual terminal, only with braille readout. It is called a "Braille Link" and is one of the most advanced pieces of braille equipment available.

Hart's seeing-eye dog, Dana, accompanies him to the office everyday. He is a labrador retriever, a breed of dog Hart has always wanted, but never imagined this might be how he would get one. Dana is well trained and very friendly, but is off limits to much attention from the other employees. Seeing-eye dogs are taught to be loyal to their masters, and the showing of affection should only

come from him, Hart pointed out.

"Not being able to drive myself to work is one problem that bothers me the worst," Hart said. James McCarthy, Chief of the Fiscal Services Division, lives several blocks from Hart, so he gives him transportation to and from work. Hart does have it difficult in

many areas, but to see the way he deals with the frustration of blindness is another story. George Hart has taken what most consider a severe handicap and has learned to deal with it with a strong, positive, and encouraging attitude.


"The kids had an easier time communicating with her than the adults did, but that's probably because they were around each other more," Cross said.





Congratulations to J.L. Owens, District Materials Supervisor, who has completed 35 years of service with the Department.


