

## A MESSAGE FROM THE DIRECTOR

# RURAL ROAD CONSTRUCTION PROGRAM ACT 456 OF 1985

The Arkansas Highway Commission wasted no time in putting the additional highway revenues produced by Act 456 to good use.

Effective April 1, the motor fuels tax was raised by 4 cents a gallon on gasoline and 2 cents a gallon on diesel fuel. The anticipated \$34.2 million it will produce is earmarked for the improvement of 4,850 miles of rural highways over the next 10 years.



On April 18 the Highway Commission awarded contracts on 29 projects totaling about \$13.3 million to overlay approximately 242 miles of rural roads. By the end of the summer some 700 miles of highways will have been resurfaced and work should be underway on several more miles of reconstruction and paving of gravel roads.

The Rural Highway Program was approved by the Arkansas Legislature in an effort to deal with the State Highway System's most serious needs. The additional revenues will be used for construction work which will be performed by contract.

The slated improvements are essential to the State's economic development. All gravel roads on the State Highway System will be paved, and the backlog of previously approved industrial access roads will be constructed.

Safety will be enhanced through the construction of improved highway intersections and the building of badly needed passing and climbing lanes.

This, along with scheduled Federal Aid contracts, will improve approximately one-third of the State Highway System. Other important Federal Aid projects will also be undertaken, including bridge replacement, urban road work, safety projects, rail-highway crossing and emergency projects.

Bad roads cost the Arkansas motorist an estimated \$186 per year in increased fuel use and vehicle maintenance, whereas the additional motor fuels tax will cost only about \$25 to \$35, depending on individual driving habits. The rural construction projects will improve safety and complete highway improvements that are essential to the State's continued growth.

## COMMISSIONER INTERVIEW

## FARMER CONCERNED ABOUT RURAL ROADS

Dalton Farmer, of Jonesboro, has been on the job as a Highway Commissioner since his appointment by Governor Bill Clinton January 29. During that time he has been very active in meeting with the public to explain the Rural Road Program and discuss other concerns.

His interest in highways goes back several years. He has served as chairman of the streets and highways committee of the Jonesboro Chamber of Commerce and is also on the Board of Directors of the Arkansas Good Roads/Transportation Council.

He has several farming operations in Craighead County and also operates a real estate investment firm.

He and his wife, Nora Dean, have ne son, Alec, 21.

Farmer was recently interviewed by Assistant Public Affairs Officer Bill Stanton.

STANTON: Prior to your appointment to the Highway Commission there was speculation concerning who

would be appointed. What were your feelings when Governor Clinton called you and asked you to

serve on the Commission?

FARMER: Well, I was delighted that I was going to get the opportunity. I've been interested in roads for 12 or

15 years. I was working for the Chamber of Commerce, and I worked on the Metropolitan Planning Commission. I worked with Mr. Joe Martin up at Jonesboro. He was actually the chairman of the streets and highways division of the Chamber, and had done a lot to influence my thinking. I think one thing that happened to us in northeast Arkansas, that the people of central Arkansas weren't aware of, is that we didn't feel like we had as good communications with state agencies that we should have. We have some very strong feelings that we ought to have been better represented. I think it was Craighead County and northeast Arkansas' strong feeling to have representation that

was the Governor's reason for appointing me - rather than a personal thing, for me individually.

STANTON: Did you have any conversation with the Governor prior to the appointment regarding some of the

things that concerned him for northeast Arkansas?

FARMER: No. Most of the conversation was with members of the northeast Arkansas Legislative delegation

and others. Like I said, they felt like they didn't have representation in all state agencies, not just

the Highway Department. They felt like this was one they definitely wanted more representation in.

What is there about being a highway commissioner that makes the job appealing — because you're

not serving for pay and you're putting in a lot of time?

FARMER: I think everyone would like to serve at a higher level in something they have an interest in. I've

been involved with streets and highways for at least 12 or 15 years representing the community side of it, and being in industrial development and commercial real estate, I've been interested in it for another 15 years, so actually I've been interested in it for 30 years. That's one reason I got involved with the Chamber of Commerce, and the reason they made me chairman is because I'd been pretty successful about guessing traffic patterns and trends.

STANTON:

Now that you're in a position where you can do something about it, what are some of the things

that you think Arkansas needs in the way of highways and transportation?

FARMER:

I think probably my first concern is economic development, besides the highway system. Making an impact and creating any kind of positive life style or increasing the income basis of Arkansas.

mainly creating a better quality of life in all aspects, that's what concerns me.

STANTON:

What about the specific needs of the northeast and the eastern part of the state, what are your

priorities that you would like to see there?

FARMER:

In dealing with local representation, such as Chambers in the area - elected officials in the area everyone has pretty well set priorities and I am basically familiar with everyone's priorities in the area. Probably Highway 63 is the first priority of the area that I immediately serve and I think Highway 63 and Highway 67 are both major priorities for the southern counties. Things are changing. One thing that's happened to us up there is that Wal-Mart and McDonalds get side by side and it seems we generate 12,000 cars real quick and it overloads everything we've got. Most of these places are just two-lane roads and we now need a four-lane with some traffic controls real quick. On Highway 63, the centerline is already established in Jonesboro. The current concern on Highway 63 is speeding up the project and getting it constructed as fast as possible and then going back and eliminating the traffic hazards. We've had several intersections where we've have a number of deaths and a number of injuries and considerable property damage. On the relocation of Highway 67, serving the major part of the population and keeping from doing damage to the area that is currently served, is probably the major interest. I noticed that everyone in that area would like to have access to some kind of an interstate at some point in the future all the way from Interstate 55 to Interstate 30. I think they see it at some point in the future as being a connection with an interstate corridor and it opens up a lot of things even for central Arkansas. Highway 67, if opened on up to the bridge

at Cape Cirardo or Caruthersville in Missouri, would open up all of Kentucky, Ohio and up through there.

STANTON: How do you think your experiences in farming and real estate are going to help you now that you are a highway commissioner?


FARMER: The real estate end of it is critical to traffic flow. The value of property is directly in proportion to the amount of traffic that's in front of it and has access to it, so I think it's critical to understand those concerns. On the farming end of it, farmers usually hate any kind of division of agricultural property and dividing operations up, so understanding their feelings is important.

STANTON: The rural road program is probably one of the most significant pieces of legislation that's come along in a long time. What effect do you think that program is going to have on the State?

FARMER: For the last four years the physical appearance of the roads seems to have been going down some and I think it was mainly money. The lack of mowing and upkeep I think is visible to everyone. I think the money will help. This money is programmed for particular projects. It will help loose up some of the money that we can use to carry on the Federal-aid Program and we can go on to build a better perception for the State of Arkansas. Tourism is a major industry. When you're talking about perception of a state and what people carry back to their communities where they live, it's critical as to how many more people will come back.

There was some concern expressed by the Governor, and others as well, that the people of Arkansas were not sufficiently aware of the need for the increased funding for highways. What can be done to make people more aware of the problems that are facing us and the needs that we have to meet?

I've been on the road since before the legislative session, first - carrying the proposed rural road package - and since then, carrying the approved ten-year rural road program - and I've gone to every Rotary Club, Kiwanis Club and Exchange Club that has asked me, trying to explain and get the point across that this was a portion of the 16,000 miles of highways that we have in the State of Arkansas, and that this money was just to bring up to standard, 6,000 miles. And one thing that I've done to try to get that point across is carry a map that puts these projects in perspective to the State of Arkansas and when you get all the projects scattered out on the map and present that to the public, they get a better perception that this is money being spent to improve roads scattered throughout the State of Arkansas.

STANTON: What are you hearing from the people? What do they say about the rural road program?

FARMER: That varies from district to district and county to county. Down in Highway District 1, they seem to be very content and there are no concerns about it. They seemed to be well pleased with where we are. Up in District 10 it's altogether a different story. Nobody's happy with where they are and what they've got. Everybody's got a little project that they want done. I'm not so sure why, I would think probably because there is more population, but basically, in District 10, it seems like they just want a little more attention. Most of the time when I go into a meeting, the first thing I ask is. . .have you heard about the ten-year program and have you heard about the tax that funds it? And in some cases I have gotten objections. I usually go over the program and at the end of the discussion I usually ask if they still have objections, and to this point, I have not had a person that has objected to it after the program has been explained.

STANTON: There has been some criticism that the Department has enough money - that we just weren't using it right. Over the years the Department has reduced the number of employees, reduced equipment purchases and various other things have been done to keep the costs down. Is there anything else that can be done to further reduce the overhead?

FARMER: I don't think so at this point. I understand the public perception and the very high visibility of state employees working on the roads. It's very obvious in some places that the amount of weight that the roads are carrying now and the amount of traffic that they are carrying, are causing them to deteriorate very fast. I don't think there's anything else that could be cut. I think that since we've had the license tag fees decrease, we've been going downhill ever since. That was one of my major concerns about passing the rural road program, that we'd get some things done and have some money for industrial access and money to improve the traffic flows and ease congested areas.

STANTON: The Highway Use Equalization Tax was passed two years ago to compensate for the increase in the damage that would come about as a result of heavier trucks. This year, we had the motor fuel tax increase. Do you think these measures are going to be adequate to handle the growing needs?

I think that comes back to growth and public demand again. At this point I think we have enough money, without inflation, to keep us up and to go on and complete the rural road program, and provide industrial access and move that traffic along where you have commercial build-up. I don't think we, by any means, have an overflowing amount of money and I don't think we can go out and hire a tremendous amount of new employees. At this point we need to watch it for at least four or five years, to see what happens as far as growth of inflation.

STANTON: What is your opinion of the method of selecting highway commissioners by gubernatorial appointment as opposed to electing them?

I think that would go back to individual commissioners and their attitude of what was in the best interest of the public. I think either one could serve either way. If I have a good attitude toward being responsive to the public, I can do as good a job as someone that was elected. However, I think anytime that you have one person appointed from an area for ten years, then he can go on and develop for that particular area and follow through with construction for that area. As slow and as expensive as roads are, there is just no way that you can do it in what a normal term would be, 2 years or 4 years for an elected official or someone serving at the pleasure of the Governor that is newly elected every two or four years.

STANTON: What about the number of commissioners? Should there be an increase or decrease, or is five a good number to work with?

FARMER: Well, to this point, I am fortunate enough that I've come in with a good working relationship with the other commissioners. I think probably that goes back to the personnel on the commission and how well they work together. With major projects, as I said before, as expensive as they are, if there

was any more you just wouldn't show any progress.

STANTON: Have you had an opportunity to visit with many of the Department's employees? What is your

impression of the employees that you have met?

FARMER: Well, I haven't had - really, I've been so doggone busy trying to take care of public relations and I

have been on the road. I spent the biggest part of the time with the members of the General Assembly right after I was appointed and since that time I've been on the road trying to get the public better informed about what the rural road program was. I have not had the tour yet. Of the employees that I've met over the years in a working relationship, I have not had an unfavorable experience. I won't say that I got everything I wanted but it's been very pleasant working with

them.

STANTON:

STANTON: Being a highway commissioner can be very time consuming. What effect has this had on your per-

sonal life?

FARMER: I had a full-time job before and now I've got another full-time job. I have been on the road a lot

more. I've got a car that's roughly six months old and I've got 45,000 miles on it, making three visits in three towns for three meetings in one day. As far as its effects on my personal business, I think I've got people that are capable of handling things in my absense. I think I probably need a full-time assistant, just to go wherever I go and then follow up on the details. The District Engineers have done a good job and I should put them in front of myself. They do most of the work.

Your wife works in your business with you, doesn't she? What effect has this had on your family relationship, being gone this much more and all of the traveling?

FARMER: She has had to take a more active part in running the business. She's the chief means of organiza-

tion. As far as the personal end of it, we usually take what time we can. I came in Sunday night from Little Rock and I got in probably 6 or 7 o'clock and we ended up on the road going back out, and we drove another 50 or 60 miles to go to dinner that night. It seems like I'm getting accustomed to living on wheels. I'm moving all the time in so many directions. About the only

time I'm not moving is when I'm sleeping.

STANTON: Are there any other comments or observations you want to make?

FARMER: Well, I'm gonna say my original perception of being a highway commissioner and where I'm at now

is probably completely on the opposite end. I had not expected immediate exposure and I had not expected to spend the number of hours and time on it. I think two things mainly brought that on me. One was the controversy out of the Governor's appointment which got a lot more media

attention and the other thing was the rural road package.

## HAZARDOUS MATERIALS TRAINING UNDERWAY

With over 70,000 toxic materials in existence, and hundreds being added each year, the potential for life-threatening chemical spills is increasing at an alarming rate.

In order to respond to such an incident, all Arkansas Highway Police (AHP) officers are receiving training in the identification and handling of hazardous materials. In addition, many of the Highway and Transportation Department's maintenance supervisors and area foremen are also receiving the training.

During February and March about 250 officers and maintenance personnel received the first phase of the training, according to AHP Corporal Paul Claunch of Benton.

Claunch, who serves as chairman of the AHP ten-member Hazardous Materials Committee, has received training in chemical control at a school sponsored by the U.S. Department of Transporta-



tion in Austin, Texas. About a dozen other AHP officers have also received similar training at other DOT schools.

Claunch said the training program, which was developed by the Committee, is structured for personnel who have no previous training in this area.

"The purpose of this phase of training was to make the participants aware of the potential dangers, both short and medium range, of a hazardous materials incident. A basic knowledge of hazardous materials is essential in order for them to respond properly," he said.

The course specifically addressed the recommended initial action of AHP Patrolmen involved in a hazardous materials incident on the State's highways or at one of the AHP weigh stations, along with the potential hazards to AHTD personnel responding to such an incident.

The next training phase will cover tanker and cargo trailer inspection and motor carrier safety as it pertains to hazardous materials transportation. This includes the condition of equipment (trailers, tires, etc.) and the proper use of logbooks.

AHP officers, the State Police, and Transportation Commission officers, have authority to enforce provisions of Act 421 of 1977, the Hazardous Materials Transportation Act.

AHP Assistant Chief John Bailey said the Department will be collecting data on the movement of trucks that are carrying potential hazardous chemicals. The information will be collected at weigh stations and by stopping trucks throughout the State to determine what chemicals they are carrying.

The Department's Technical Services Section has determined that approximately 5.3% of all trucks traveling on Arkansas' highways are known to be carrying hazardous materials. Flammable liquids make up 72% of all hazardous loads, followed by corrosives (9.4%) and radioactive materials (6.8%).

Three incidents over a recent two-week period point out the importance of being prepared to handle potentially dangerous situations.

On March 19 a tractor-trailer rig carrying poultry feed and copper sulphate, a toxic substance, overturned on Highway 71 in northwest Arkansas. One lane of the highway was blocked for about three hours until the spill could be removed.

On March 31, a tanker truck carrying synthetic rubber silicone was cordoned off at a truck weighing station on Interstate 30 near Benton when officers discovered the substance was leaking. The leak was found when the truck pulled into the station for a routine weigh-in.

The silicone was improperly identified by signs

on the truck and the driver was charged with operating a truck with improper chemical identification signs. AHTD maintenance crews were called to clean up the spill.

On April 2, oil containing polychlorinated biphenyls, or PCB's, an extremely toxic substance. leaked from a drum on a tractor-trailer rig traveling on Interstate 40 from Pulaski County to Memphis. Small quantities of the contaminated oil were found at Wheatly and at a weigh station at Lehi.

"Technical Services is working with the AHP now to come up with a method in which we can get a better handle on the volume of chemical substances moving through the State. They will modify their Origin and Destination Study forms to include questions about the substances, such as where they came from, where they're going, and what chemical they are carrying," Bailey said. "That's one of the big problems - we don't know, but we're going to know, and we will be in a better position to respond if something goes wrong."

### NEW COMPUTER SYSTEM AIDS AHP OFFICERS

What once was a time-consuming process that took up to ten minutes or longer can now be accomplished in a matter of seconds thanks to the addition of a National Crime Information Center computer system for the Arkansas Highway Police.

Two NCIC computer terminals and keyboards were installed at the Highway and Transportation Department in April. One system was placed in the Highway Police office and the other was installed in the Telecommunications Center.

Highway Police officers in the field can now receive vehicle and drivers' license license information, as well as bulletins regarding stolen vehicles and wanted persons, over the NCIC system.

Before the equipment was purchased AHP officers had to rely on the State Police or the local sheriff's office to assist them whenever they needed information pertaining to specific vehicles or drivers. Depending on the workload, this information sometimes took ten minutes or longer to obtain. A radio call would be made from the patrol unit to the Central Radio operator in Little Rock who would then have to phone the AHP office. The AHP would phone the State Police and request the information. Once the information was obtained, it was relayed back to

the patrol unit through the same channels.

Now, all a patrol unit has to do is request the information over the radio and the telecommunications operator at Little Rock can retrieve it from the computer and relay it to the unit in just seconds.

"It provides for a more efficient and timely operation," Assistant Chief John Bailey said. "It doesn't tie up the officer for long periods of time waiting to find out if a person is wanted for any other violations or if a particular truck is registered properly to carry a certain weight," he said.

Several AHP personnel in the Central Office and all telecommunications operators have been trained by the Arkansas Crime Information Center on proper use of the equipment.

The information available from NCIC is for law enforcement use only. The information cannot be released to unauthorized persons.

"It is a Class D felony to give this information to anyone other than a law enforcement officer or others in the criminal justice system," AHP Captain George Coffman said.

"Under state and federal laws, improper disclosure can result in a fine and/or imprisonment and removal of the computer terminals," he added.

## **EDGEMONT BRIDGE**

## REPLACEMENT STRUCTURE AHEAD OF SCHEDULE

Construction on a new bridge on Highway 16 across Greers Ferry Lake near Edgemont continues ahead of schedule.


Valco, Inc., of North Little Rock, and Jensen Construction Company, of Des Moines, Iowa, began work on the \$3.9 million structure late last year and all indications are that they will have the bridge opened to traffic well ahead of the June 1986 deadline.

The new bridge will replace the one that was destroyed by the March 15, 1984 tornado that swept through the area killing two persons.

On March 15, 1985, the small community of Greers Ferry dedicated a monument marking the first anniversary of the tornado. Located in front of the city hall, the monument bears the copper plaques that were on either side of the Edgemont Bridge.

Construction on the new bridge is over 50 percent complete. The concrete piers from the old bridge were found to be sound and are being used to support the steel girders for the new bridge.

Until the new bridge is completed a free ferry service is being operated between Edgemont and Greers Ferry. The service is operated by the Carter Construction Company of Benton under contract to the Highway and Transportation Department.

## RAILROAD PROJECT APPROVED

## REHABILITATION PROJECT TO BEGIN AT EL DORADO

The Arkansas State Highway and Transportation Department's application for funds to rehabilitate eight miles of the abandoned Rock Island Line from El Dorado, Arkansas to Catesville, Arkansas was approved in April by the Federal Railroad Administration.

The 26.3-mile line, which extends from El Dorado, Arkansas to Lillie, Louisiana, was purchased on August 6, 1984 by the East Camden and Highland Railroad (EACH).

AHTD Director Henry Gray and EACH President Don Ghent signed the contract at a ceremony held May 8 at the El Dorado Chamber of Commerce.

The line serves the following major shippers: Great Lakes Chemical Corporation South, Georgia Pacific Lumber Company, and Willamette Industries. The estimated cost for the eight-mile rehabilitation project is \$657,143 of which the Federal share is \$460,000. The East Camden and Highland Railroad Company will provide the remaining \$197,143. The project consists of improving drainage, replacing ties and rail as needed, renewing ballast, rail surfacing and lining and other related improvements to complete.

The railroad Revitalization and Regulatory Reform Act of 1976 (4R Act) and subsequent amendments, authorized financial assistance to qualifying branchline railroads for upgrading rail facilities to improve operations and financial stability on the line and submitted by the State Highway and Transportation Department to be approved for funding by the Federal Railroad Administration. The AHTD, as the designated agency for rail planning, has been successful in utilizing all available funding from the Federal Rail Service Assistance Program for rail projects. The rehabilitation of this line was considered a priority project by the AHTD and FRA due to the quantity of carbolic acid, chlorine, bromine and other hazardous materials being shipped over this section. The increased safety factor provided by rehabilitating this line was a major reason for its high priority. The State will benefit indirectly through lower maintenance cost for highways in the area, since it is estimated that 3,000 plus trucks would be needed to move the yearly tonnage presently being hauled.

## EOSE HELD AT DEPARTMENT

## EMERGENCY PREPAREDNESS PUT TO THE TEST

The best way to deal with an emergency situation is to be prepared for it and to respond accordingly. In order to be prepared, a certain amount of planning and training is necessary.

That was the purpose of the Emergency Operations Simulation Exercise (EOSE) held at the Highway and Transportation Department in May.

Representatives of the Federal Highway Administration (FHWA) and Leonard Chase of Eugene, Oregon, a consultant in emergency preparedness, devised a scenario to evaluate the AHTD's Highway Emergency Operations Plan.

The scenario assumed a worsening of world-wide tensions which eventually lead to an accidental launching of a nuclear missile by another country. The missile's warheads exploded at several locations in Arkansas. The AHTD's Emergency Operations Center (EOC) was activated to handle the various problems created.

Bridges throughout the state were closed due to damage, sections of highways were closed, traffic problems mounted due to people evacuating certain reas, and nuclear fallout was creating problems for

AHTD crews who were out trying to repair the damage.

The EOC was staffed by many of the Department's division heads, assistant chief engineers, and other key personnel. The ten district engineers were also called into address problems that occurred in their areas.


The first day of the exercise consisted of instructions and demonstrations on how to operate during an emergency situation. The second day was the exercise itself.

According to Jerry Shearer of the Federal Highway Administration in Washington, D.C., the exercise program began in the late 1960's and was designed to get government officials at the city and county levels together. Later it was modified to include the FHWA and the state governments. Shearer said 35 exercises of this type had been held in various states.

Dan Flowers, Assistant Chief Engineer for Operations for the AHTD, said this was the first exercise held in Arkansas.

"Our Emergency Action Plan was last revised in 1976, so this was very helpful in providing us information to use for an update," Flowers said.

Other training sessions will probably be held at a later date and will include emergencies created by weather-related problems such as tornados and floods.

## DESIGN AWARD PRESENTED TO COMMISSION

The American Institute of Steel Construction presented the Highway Commission with a plaque

in April to commerate the recent selection of the Norfork Bridges as winners in the AISC Prize Bridge Competition.

Fred Brown, representing AISC, made the presentation to Commission Chairman Patsy Thomasson and Director Henry Gray. Brown also presented a plaque to a representative of the U.S. Army Corps of Engineers. The Corps is the original owner of the bridges and awarded the contracts to construct them.

Howard Needles Tammen & Bergendoff of Kansas City, Missouri designed the bridges and received special recognition at the AISC's Fourth Annual Awards Banquet last December.

The Highway 62 and Highway 101 bridges were selected based on their overall effect. As noted by the jury: "The proportion of span to height, treatment of the piers, depth of the girders, even the railing, were done well. The gentle grade adds to the bridges' drama. Unpainted steel contributes to the total effect. The bridges contract nicely with the surrounding countryside."

## GEORGE HART AND DEPARTMENT HONORED

George Hart, a Programmer in the Engineering Section of Computer Services, received special tribute from the Arkansas Council for the Blind. On March 30, 1985, Hart was awarded a plaque designating him as "Employee of the Year." 


