

A MESSAGE FROM THE DIRECTOR

1985 - AN EVENTFUL YEAR

The year 1985 has been one of the most eventful years ever in regard to highways and transportation in Arkansas

Thanks to the hard work by the members of the Highway Commission and the Department staff, the Arkansas General Assembly approved one of the most comprehensive rural highway programs in the history of the State.

The legislation, which increased the gasoline tax by four cents a gallon and the diesel tax by two cents a gallon, went into effect April 1, and the Highway Commission immediately began to put the money to work.

Since the first of April, more than 600 miles of rural highways have been, or are in the process of being im-

proved. More than \$118 million in State and Federal funds has been obligated for use on these roads. (See related article on page 14).

The 1985 General Assembly also provided all state employees with a much needed salary increase. Legislation approving a 30-year retirement program went into effect in July.

The Arkansas State Highway and Transportation Department also was the host state for the 44th Annual Meeting of the Southeastern Association of State Highway and Transportation Officials (SASHTO). More than 700 delegates from the 12 SASHTO member states attended the meeting held in Hot Springs in September. The hard work by our employees was evident throughout the meeting. Many compliments regarding the meeting were received from our guests and that was a direct reflection on those of you who put in the time and effort to make the meeting a success. For all of the good things that have happened this year, there are still some nagging problems. Bridge replacement and Interstate Highway rehabilitation remain top priority items, as well as stepped-up maintenance work on our highways.

Throughout the years the Department has always been able to overcome the many obstacles placed before it. Much of our success is due to the fact that Highway and Transportation Department employees are dedicated to serving the public and making the most of what we have.

Our goal, as we enter a new year, is to continue to provide the citizens of Arkansas with the best highway and transportation program possible.

It has taken hard work to accomplish what we have over the years, and the Highway Commissioners and I want to express our thanks to you for your tremendous dedication to this never-ending task. We would also like to wish you and your family the very best for this holiday season.



ANNUAL MEETING CALLED "One of best ever..."

The 44th Annual Meeting of the Southeastern Association of State Highway and Transportation Officials held in Hot Springs September 15-17 has been called "one of the best ever" by many of the delegates from the 12-member states who attended.

Held at the Arlington Hotel in Hot Springs

National Park, more than 700 delegates and spouses attended the three-day event. It was Arkansas' fourth time to host the annual meeting since the state became a part of SASHTO in 1943. Highway and Transportation Director Henry Gray presided over the session.

In his welcoming address, Governor Bill Clinton said our infrastructure is important to the country. He stressed the importance of jobs for the economic development of the South and how the availability of jobs is dependent on our transportation system. "You can't have a strong economy without a strong transportation system," Clinton said.

The Governor also presented Arkansas Traveler certificates to Tom Larson, vice-president of the American Association of State Highway and Trans-

portation Officials (AASHTO) and to C. Leslie Dawson, the newly elected president of SASHTO.

BUMPERS: "For all the money we are spending, we are still trying to catch up."




U.S. Senator Dale Bumpers was the featured speaker of the Opening Session.

U.S. Senator Dale Bumpers told the delegates he believed the states needed more discretion in the use of Federal funds for highways. He noted that nearly \$50 billion a year is being spent on highways in this country. "From 1982 to 1984 there has been hore money added to the Trust Fund and the states have raised their taxes more than at any time in history. For all the money we are spending, we are still trying to catch up," Bumpers said.

Using the bridge problem as an example, Bumpers said there were 573,000 bridges in the country and 40% were either structurally or functionally deficient. "It would take over \$45 billion to address this problem nationwide," he said.

"One thing the Congress could do is to give the states more flexibility to transfer funds from one category to another. That would give you an opportunity to save money, simply because you know where it ought to be used," he added.

AASHTO Vice-President Tom Larson said there is still a big question as to what should be the states and the federal role in transportation. "I believe this is clearly a crossroads time for us. Working out this relationship is going to have an enormous impact on what we see in the future of this country," he said.

Federal Highway Administrator Ray Barnhart touched on a number of topics ranging from problems with the Davis-Bacon Act, environmental laws, the need for Congress to pass the Interstate Cost Estimate, and the inequities that exist because of the goals mandated for Disadvantaged Business Enterprises.

FRANCOIS: "we need better management now more than ever before."

AASHTO Executive Director Frank Francois also expressed the urgency to get a new ICE passed and said the states have a lot to do if they are to give the people the type of transportation system they need. "We are facing dynamic new problems and we need better management now more than ever before," he said.

DEDICATIONS

JACKSONPORT BRIDGE DEDICATED

Residents of Independence and Jackson counties had reason to celebrate September 4 when the new Highway 69 bridge over the Black River at Jackson-port was formally dedicated.

The new structure replaced a ferry that had been in operation for the past 31 years.

Former Highway Commissioner George Kell of Newport told the crowd of over 200 persons that the dedication was truly a historic event. "This new route will allow people to travel from Batesville to Newport twelve months out of the year. This is an all-time historic first," he said.

He recalled that when he began his service on the Commission in 1971, a most persistent question was "When are you going a build a bridge at Jacksonport?" He said he was Chairman of the Commission in 1977 when the Minute Order programming the bridge was approved. "It takes a lot of time and a lot of money to make a dream like this come true," Kell said

The ferry was often closed to traffic because of adverse river conditions and motorists had to detour any miles out of the way just to complete the trip tween Batesville and Newport.

He called the recently enacted motor fuels tax increase one of the most significant events regarding highways to come along in a long time. "We don't like to talk about taxes, but that's what builds roads like this," Kell added.

Commissioner Raymond Pritchett, acting as Master of Ceremonies, said the new bridge would

"significantly alter" transportation patterns in the area. "You have many reasons to look forward to further improvements to routes off the traditional four-lanes," he said.

Both Pritchett and Kell called for continued interest and support for the Commission as it focuses increased attention on rural roads.

Commission Chairman Patsy Thomasson said "This project is a symbol of the Department's determination to pursue feasible and viable projects on rural roads all over the State."

Highway and Transportation Director Henry Gray stressed that the Commission is making every effort to eliminate the ferry problem in Arkansas. Pointing out that four ferries remained on the State Highway System, Gray said the additional money received through the four-cent motor fuels tax increases will aid in the effort to replace the other ferries.

The Black River Bridge was built at a total cost of \$5.5 million. Foster-Creighton Company of Nashville, Tennessee was awarded a \$1.7 million contract in November 1981 for the substructure. Jensen Construction Company of Des Moines, Iowa received a \$2.1 million contract in April 1983 for the superstructure, and McGeorge Contracting Company of Pine Bluff was awarded a \$1.6 million contract in February 1984 for the roadway approaches. Right-ofway and utility adjustments totaled approximately \$112,160.

HIGHWAY 64 IN MORRILTON DEDICATED

A ceremony formally dedicating the recently completed four-laning of Highway 64 in Morrilton was held October 23 with state, county and city officials in attendance.

Highway Commissioner Raymond Pritchett told the crowd that something is ahead for Conway County "that many people thought they would never see." That is the paving of all state highways in the county.

Pritchett said that within six months, the Highway Commission would award contracts to pave the remaining two sections of unpaved state highways in the county.

The paving projects, along with about 58 miles of other overlay improvements to highways in the county, are a part of the Highway Commission's

Rural Road Construction Program which was approved by the Legislature earlier this year.

The Highway 64 project included about one mile of widening the existing two-lane facility to four lanes and installing new traffic signals at Broadway and Highway 64. Mobley General Contractors, Inc., of Morrilton, was awarded a contract in August 1984 for the construction, which was done at a cost of \$970,053.

The widening of Highway 64 was a top priority project for the AHTD and Pritchett told the audience that another long-sought after project, the reconstruction of Highway 9B in Morrilton, would be ready for contract sometime in 1986 at an estimated cost of \$2.3 million.

FINAL SECTION OF I-630 OPENS IN LITTLE ROCK

When the ribbon was cut to officially open the final segment of I-630 in Little Rock on September 30, it was the sixth time since 1969 that dignitaries has gathered to open various sections of the highway.

It was appropriate that former United States Representative Wilbur Mills was on hand to deliver the dedicatory address. Mills played a key role in securing the federal funding that finally lead to the completion of the project. In appreciation for his efforts, the City of Little Rock named the freeway in his honor. (See related story on I-630 history).

More than 250 persons parked their cars on the newly constructed west-bound lanes near the I-630/I-30 Interchange to listen to the speeches and take part in the event. Many then formed a single line caravan behind Arkansas Highway Police and City Police cars to travel the entire 7.4-mile length to the I-430 Interchange in west Little Rock.

Mayor Tom Prince praised the perseverance of local officials who worked for the east-west link over

he years. Among those mentioned was the late Werner Knoop, Little Rock's first mayor under the city manager form of government. A plaque honoring Knoop, who died in 1983, was presented to his grand-daughter by Mayor Prince.

Mills told the audience that the special significance of the dedication ceremony was that it would be the last for the state's basic Interstate Highway system. "There will be additional lanes, reinforcement, and even new construction, but for the opening of our interstate highway system in Arkansas, this is it," he said.

The former chairman of the House Ways and Means Committee said Little Rock benefits from an almost-unique situation. Most urban freeways have been bypasses, or loops that encircle a downtown area, he said. "Crosstown interstates have not been prevalent," he added.

Recalling that the work that went into the freeway would be one of his fondest remembrances, Mills remarked, "It's been said that the easiest way to grow old gracefully is to look back selectively."

He said the completion of the project was "a positive accomplishment, one of those that we can always point to and appreciate."

She said 27 separate construction projects, extensive utility adjustments and right of way acquisitions, and the relocation of an elementary school, brought the final cost of the project to \$130 million.

I-630 HISTORY:

"A DREAM BECOMES A REALITY"

The first conceptual appearance of the Interstate 630 Route in Little Rock appeared in a master street plan and highway improvement for Little Rock, reported by John Nolen and Associates of Cambridge, Massachusetts during the early 1930's. A rapid increase in east-west traffic in Little Rock was noted and a band between 7th and 14th Streets was recommended for development as a major thoroughfare.

Planning for the Little Rock "crosstown" route began to materialize locally in 1941 when the Pulaski County Planning Board issued a report that indicated a high capacity traffic artery would be needed near the center of the City to handle east-west traffic.

It was the Highway and Transportation Plan for Greater Little Rock in 1948 that first envisioned some type of controlled-access freeway, or expressway, in Little Rock.

Since 1948, virtually every planning or transportation proposal has included a highway facility in the corridor of which I-630 is now located.

In September 1958, the City of Little Rock petitioned the Arkansas Highway Commission to designate the East-West, or Eighth Street Expressway, as a part of the highway system. This meant the State would bear the responsibility for the construction and the City of Little Rock would be responsible for right-ofway and the relocation of utilities. In October 1959, the Highway Commission, by Minute Order, agreed to include the Eighth Street Expressway as a part of the Highway System and to construct the facility as funds became available. However, there was no schedule commitment of funds made by either the City or the State at that time.

In 1961 the Route Location Study was completed and approved by the City, State and Federal officials. During this time the Eighth Street Expressway corridor was protected by a zoning ordinance in the City of Little Rock. In the downtown area of Little Rock, most of the necessary right-of-way was purchased and cleared under the Urban Renewal Program. In April 1963, the Highway Department directed the consultant to proceed with the construction plans for the first phase of the Expressway from Dennison Street to University Avenue. The first contract was awarded for five overpass structures in 1964. Following this, a contract was awarded for the construction from Dennison Street back toward Pine Street. The initial planning was for a four-lane expressway. This section was opened to traffic in April 1969. As time went by there weren't any funds available to continue construction of the project from either the City or the State. However, this didn't keep the traffic from increasing and the traffic demands kept mounting.

In March 1970 the Highway Commission asked the Federal Highway Administration to accept the 7.4-mile "8th Street Expressway" into the Interstate Highway System.


In May of that year the FHWA advised the Department that the request was being denied — saying, the allocated Interstate mileage was all gone.

U.S. Congressman Wilbur Mills began working on the problem at this time and was able to get the Interstate mileage increased for Arkansas. The FHWA notified the Department, in November 1970, that the route had been added to the system and would be designated Interstate 630, thus making it eligible for

90/10 Federal funds. The City of Little Rock, grateful for Congressman Mills' efforts, named the route in his honor.

Also, during this time the National Environmental Policy Act of 1969 came into being. The first guidelines came out in 1970 and the final guidelines, or regulations, were published by the Federal Highway Administration in 1971. The first Draft Environmental Impact Statement on I-630 was completed in February 1972 and was approved by the FHWA in Jecember 1972. Following the initial approval, and adoption of the Environmental Impact Statement, construction contracts were awarded on the remainder of the section from Pine Street to University Avenue.

Additional lanes were added on the Dennison-Pine Street section and planning began for the project on the west, from University out to I-430. At the same time the plans on the western portion were being done, a consulting engineering firm, Garver and Garver, was hired to do the design from Dennison to I-30.

On November 9, 1973, a group of citizens, known as the Arkansas Community Organization for Reform Now (ACORN) filed a suit in Federal court to halt the construction of Interstate 630, contending that the State's Environmental Impact Statement was inadequate. The case went to trial on September 16, 1974. A decision was rendered by the Court on July 28, 1975, in which the I-630 Environmental Impact

Statement was found to be inadequate particularly in the areas of alternatives relating to the design of the project. The decision did allow work to continue on the western portion and to continue the acquisition of right-of-way on a voluntary basis on the eastern end.

A new Environmental Statement was prepared and the Federal Court released the State from its injunction, clearing the way for construction to begin on the eastern segment in May 1979.

The work included 12 overpass structures as well

as the I-630/I-30 Interchange. Because the highway forced the closing of several city streets, the work had to be completed in phases in order to maintain traffic with the least amount of inconvenience to the motorists.

Various sections of the eastern portion were opened to traffic as they were completed beginning in late 1982. The final section, the eastbound lanes from I-30 to Center Street, opened September 30, 1985.



ARKANSAS HIGHWAY POLICE

A program designed to slow down speeding trucks in Arkansas has caught the attention of police agencies in Texas and Oklahoma and they are making plans for a cooperative effort, according to Arkansas Highway Police Chief John Bailey.

"The Speeding Truck Offender Program, or STOP, as it is called, began in late August when we put two unmarked cars out on the road to clock speeding trucks. During the first month over 600 vehicles were stopped and ticketed," Bailey said.

Of those stopped, 477 were trucks. Of the truckers ticketed, 282 were speeding and 106 were following too closely. Officers also checked for violations of safety and weight regulations.



'STOP' IS SLOWING TRUCKS

Increasing complaints from the public about speeding trucks prompted the program, Bailey said. "We went to the unmarked car approach because the truckers can spot the regular marked police cars and relay their whereabouts on the CB radio. Our unmarked cars don't use radar, either. They just pull in behind a truck and clock its speed on their speedometer," he said. Each unmarked car is equipped with blue lights in the grill and a portable blue light that mounts on the dashboard.

The Highway Police used the Department's research data to determine where the highest volume of trucks were speeding, the time of day they were speeding and the days of the week they were speeding. That information was available from the vehicle detector loops installed in the pavement. Each time a vehicle passes over one, it records the vehicle speed, as well as providing a count of the daily average traffic in a certain area.

"We have been concentrating on the high volume stretches of Interstate highways. This gives us maximum effectiveness," Bailey said.

Bailey was so pleased with the program that he asked for, and received permission to add three more unmarked vehicles to the fleet for speed enforcement.

Texas officials heard of the program while attending a conference in Arkansas in September and invited Bailey to Austin to discuss it with them.

"As a result, Texas has agreed to work with us on a trial basis during November, December and January on I-30 between Fort Worth and Little Rock," Bailey said. "There will be officers stationed along the interstate every ten miles for an eight hour period on each of two days during each of those three months," he added.

The enforcement agencies will also be checking the movement of hazardous materials, truck drivers' logs and other legal requirements for truckers.

Oklahoma is also interested in STOP because of mounting public pressure to enforce speed limits and may be joining Arkansas and Texas in future enforcement efforts, according to Bailey.

RURAL ROAD PROGRAM

OVER 600 MILES OF IMPROVEMENTS UNDERWAY

Between April I and the end of October approximately 13 percent, or 634 miles of the 4,850 miles of rural highways identified in the "Ten Year Rural Highway Construction Program" has been placed under contract for improvement by the Arkansas State Highway Commission.


The program, created by Act 456 of 1985, is the most extensive rural highway program ever undertaken in Arkansas. Over the next ten years the Highway Commission will improve 4,850 miles of deteriorated and substandard rural highways with funds from this program.

Since April 1, when the program went into ef-

fect, 98 contracts totaling \$118 million have been awarded for improvements to rural highways throughout the State.

Of these contracts, 71, involving 534 miles of rural highways, are funded with 100 percent State funds amounting to \$37 million. The remaining 27 contracts, involving 100 miles of rural highways, are being funded with \$68 million in Federal funds and \$13 million in State matching funds.

These projects, thus far, have included jobs in 64 of the 75 counties of the State. Additional projects are on the drawing board or programmed in the other 11 counties.

The four major railroads operating in Arkansas have undertaken the task of increasing the public's awareness of the dangers of rail/highway crossings through a special program called "Operation Lifesaver."

In an effort to get the word out, the railroads recently hitched together four locomotives and several passenger cars, invited about 400 special guests aboard, and traveled from Fort Smith to Pine Bluff with several stops in between to promote the public education program.

On board was Jim Burnett, chairman of the National Transportation Safety Board. Burnett, a native of Clinton, Arkansas, told the passengers and others who gathers at each stop on the trip, that because of programs like "Operation Lifesaver" the number of accidents at rail/highway crossings has been cut almost in half over the past five years.

"Most of the people killed in railroad accidents in this country are killed at grade crossings. It is going to be the responsibility of drivers to avoid being in a position where they can be killed by trains," Burnett said

Over the past four years, 75 persons have died in accidents at rail crossings in Arkansas. Another 325 have been injured.

One type of accident involves a careless, perhaps drunk, driver racing a train to a crossing and losing. Another type involves a normally cautious driver, crossing familiar tracks in broad daylight and good weather, who courts disaster through a moment of inattention.

"Operation Lifesaver" was initiated in Arkansas in 1981. Since its inception, the Missouri Pacific, (now part of the Union Pacific), Burlington Northern, the Cotton Belt, and the Kansas City Southern, have been active in the program.

PUBLIC HEARINGS

GARLAND CITY - RED RIVER BRIDGE

Plans for the construction of a new bridge and approximately three miles of roadway were discussed August 29 at Garland City, and although no speaker at the public hearing opposed building a new bridge, several questioned the location chosen for it.

About 40 people attended the hearing on the design of the proposed Red River Bridge on Highway 82 at Garland City in Miller County. The existing structure is in very poor condition and a hearing

to choose a location for a new bridge was held last August. Following that hearing, alternate route "B" was selected as the site for a new bridge.

Several persons asked the Department to reconsider the location and build the bridge nearer to the old one. Others asked that an access road be built across the railroad tracks north of town to connect with the new highway if it is constructed at the designated location.

PARAGOULD - HIGHWAY 412

The Department's plans to reconstruct and widen Highway 412 at Paragould received strong support from over 120 persons at a public hearing in Paragould September 26.

The proposed project calls for widening the existing two-lane highway to four lanes, with left turn lanes at selected locations. The highway currently carries about 10,000 vehicles per day, according to Roadway Design Engineer Bob Walters. Projections estimate that 15,000 vehicles per day will use the facility in the future.

Because of the traffic demands, a four-lane facility is urgently needed. The project would be 50 feet wide, with curb and gutter. It begins at the west city limits and extends each to Third Street, where it would tie in with a new railroad overpass that is presently under construction.

No one spoke in opposition to the project at the hearing, although several persons were concerned about additional right of way requirements and disruptions to traffic during the construction period.

The project would be funded with Federal Primary funds and State matching money. The cost has been estimated to be about \$3.5 million.

HEBER SPRINGS - HIGHWAY 25 BYPASS

Heber Springs residents expressed support for the proposed Highway 25 Bypass at a public hearing held July 20.

Most of the 18 persons who spoke at the hearing commented on the lessened traffic congestion and added safety which would result from the bypass.

The 5.2-mile bypass route would cost an estimated \$3.5 million to \$4 million to construct and eliminate the need for through traffic to negotiate two 90 degree turns and downtown traffic in Heber

Springs along the present route.

Heber Springs Mayor Ray Robus asked the Department to leave the existing route on the state highway system once the bypass was constructed and redesignate it as a Business Route.

Roadway Design Engineer Bob Walters told the audience that the Department hopes to be able to begin acquiring and clearing right of way for the bypass in early fall of 1986.

HENRY WILLIAMS IS NEW CHIEF OF RIGHT OF WAY APPRAISAL




Henry Williams has been promoted to Chief of the Appraisal Section of the Right of Way Division. He replaced Herbert Hooten who recently retired.




