

An Interview with Raymond Pritchett

Raymond Pritchett's term on the Arkansas State Highway Commission will expire in January 1991. He was appointed in January 1981 by Governor Frank White. Pritchett, a native of Lepanto, Arkansas, is a Certified Public Accountant. In a recent interview with Public Affairs Officer Bill Stanton, he reflected on the progress and accomplishments of the Arkansas State Highway and Transportation Department during his tenure on the Commission.

STANTON:

As your term is now coming to an end, what do you consider to be some of the major accomplishments over the ten years you've been on the Highway Commission?

PRITCHETT:

I think that Number One would be the Rural Road Program and the fact that we were able to at least identify a third of the rural roads in the State and go to the legislature and pass the program in historic fashion, to at least protect these roads for a ten-year period of time. Second to that, would be that we have brought some kind of fairness to the highway financing program. Ten years ago the hue and cry was that the heavy trucks were not paying enough. With the weight-distance tax they are now, or were at the time it was passed, approaching their fair share. I think there are many other things that we've accomplished, but 20 years from now, when I look back on my experience here, I think I'll remember those two things.

STANTON:

The truck/weight issue is one that was around at the time of your appointment. As a matter of fact, you served on the Truck Weight Study Commission. Do you foresee this issue being settled anytime soon now that we're involved in lawsuits challenging the tax?

PRITCHETT:

I see the issue as settled. I don't believe that since I have been on the Commission there has been a appointment that received the publicity that mine did. At the first news conference I ever attended of any kind, they asked me questions for two-and-a-half hours. And it was all surrounding the fact that I was in favor of going to 80,000 pounds. I said that from "day one". I was also in favor of the trucks paying for

the additional cost that it would take to pay for the damage the heavier trucks would cause. Both of them were economic reasons. I was for going to 80,000 pounds, because at that time there were very few states that were not at 80,000 pounds. And our participation in not being there was an economic barrier to interstate commerce. And my theory is that whenever you remove any economic barrier to free competition, everybody - every citizen in the nation benefits from that. Conversely, when you put up an economic barrier to free competition, everybody loses. And I wanted to remove that economic barrier. But also that same philosophy of economics told me that I didn't believe in subsidizing folks. And at the time there was going to be more damage caused by the heavier trucks. It was documented in a cost-allocation study done in Washington in 1980 and 81, they ought to pay their fair share. If they didn't, the people driving regular cars and trucks would be subsidizing the heavier trucks. I believe now, today, that we are in accordance with the nation at the 80,000 pounds. We've removed that economic barrier. And I believe, too, that it is settled public policy that the truckers, the heavy truckers, are going to pay for that damage. The only question we have yet to determine through the courts is how that's going to happen. But there is no question in my mind that the vast majority of the people in Arkansas believe that they ought to be paying for the damage they do.

STANTON:

Getting to financing for roads, you mentioned the Rural Road Program. That did help some. Now almost six years later we are finding ourselves in a situation where we are needing additional funds. I guess this is an ongoing problem. Ever since there have been highways, there have always been problems with funding. What are some of the things we ought to look at to improve the situation?


PRITCHETT:

The one lesson that I have learned over ten years as I look at what all has been accomplished in the districts that I've been charged with, and yet today look and see what all needs to be done, most of what I see that needs to be done in the Arkansas River Valley and north central Arkansas probably would have already happened if, during the ten years that I have been on the Commission, we had been at the national average as far as the motor fuel tax is concerned. In a publication that I saw the other day, it showed what the national average of motor fuel tax was, and it showed where Arkansas was in relation to that; and I believe that four or five months in 1985 we were at the national average. But with the proliferation of heavy trucks, and it's growing every day, combined with the oil prices that first hit in 1973 and then again in '79, we saw the national average of motor fuel tax being raised by ten cents - almost a penny a year over the past ten years. The worst thing we can do is to get up to the national average and pass a program and then wait six years before we do anything else. Because the gaps between where you are and where you need to be in the intervening years are so great that you can't politically pass enough tax in that year to ever make up

for it. Arkansas' public policy as far as highway financing is concerned should be that we would go to the national average and do whatever it takes to get there. Right now it would be a nickel increase, and then make a commitment to stay at the national average. And the way you do that is to pass a penny to go into effect a year from now and a penny to go into effect two years from now, knowing that when the legislature comes back into session if the national average didn't rise, then that could be repealed or slowed down of whatever.

STANTON:

Would staying at the national average be enough to meet the growing demands for improved highways?

PRITCHETT:

There are two reasons - good reasons - why Arkansas ought to be above the national average. One of them is we have an abundance of miles on the Arkansas Highway System. We have the 16th largest highway system in America - over 16,100 miles. We have more roads than most of the states that have many more people and a much larger tax base-gasoline tax base-than we have. We have more infrequently traveled roads that require the same type maintenance than most any other state. I'm a rural road kind of guy; was raised in Lepanto, Arkansas; and I believe in that. But if you're going to have many more roads than other states in the nation, that is a good justification for being above the national average. Secondly, we give a much more liberal split to cities and counties out of highway revenues in Arkansas than do most other states. Our state Constitution has traditionally not allowed cities and counties to tax themselves. They can to some extent, but they're really limited to the amount of revenues they can raise for themselves. Now, I don't want to change the Constitution or any of those laws. I'm not advocating anything like that. But you can't have it both ways. If the people are going to overly split the highway revenues with cities and counties, what I mean is over what other states do, then that in itself is justification for being above the national average. But even though there are two good reasons why we ought to be above the national average, roads are more important in Arkansas, and that includes city streets, county roads, and state highways. Our people use them more. So there is good reason why we ought to be above the national average. After what I've been through the last ten years, I would settle for just getting to the national average with a commitment to stay there. And I think what the people of Arkansas would see in the near future, by 1995, they would see if we would get to the national average and stay there that all of a sudden we're not just keeping up, but there are some very much needed improvements that need to be made that would start being made. I'll give you an example. The city of Russellville grew 50 percent in the last decade. The traffic problems that they have are more pronounced today than they were ten years ago when I went of the Commission. They were bad and warranted fixing ten years ago, and we did some. But they have three projects that come to mind right now that desperately need to be done now in order to accommodate that growth. If they keep getting any kind of growth on top of a terrible traffic situation now, it's going to be

unbearable for the people of Russellville and Pope County. And quite frankly, I would - with what I know now - not like to live in a city in Arkansas that's going to have dramatic growth as long as Arkansas is going to stay five cents a gallon behind. It really just doesn't show much intelligence to live in a high-growth area in a state that's going to stay five cents a gallon below the national average and not stay up with the national average in fuel tax. For decades in Arkansas we thought growth would be good, if we could just get more growth. Well, that is not our problem now in half of our state. We're getting more growth than we can finance. And growth is not necessarily good if you can't finance it and control it, and we are getting out of control in some areas of the state because of their dramatic growth and our inability to keep up with it and finance it.

STANTON:

Last year the duties and responsibilities of the former Transportation Safety Agency were transferred to the Department. The Commission took on additional authority due to the fact that you now must hold hearings and act on requests from motor carriers for authority to operate in the State. How has this affected the Commission's ability to oversee all other aspects of the Highway and Transportation Department?

PRITCHETT:

During the first year-and-a-half of it, the learning curve was great and since I also served as chairman, this increased the learning curve on my part. I think for the Commission as a whole, and I know for me personally, it took an enormous amount of time to get on top of that learning curve, to clean up the backlog and to correct some of the unfortunate situations in the public interest that had been left by the other commission. I'm not being critical of them, because they were voted out of business and then had three or four months before the transfer was made, and there was not a lot of attention paid to it in that three or four months. We have learned it requires

monthly attention. There was a great backlog of people waiting to have cases heard which we caught up of in the first five or six months by doing overtime. But I would submit that, in my recollection of the last year and-a-half, almost without exception I would submit that did not take away from the Highway Commission's responsibilities, focus, duties or anything like that. Rather, that just took away from what little personal, family and social and private life that each one of the Commissioners had. The other four Commissioners are 100 percent dedicated to their responsibilities as Commissioners. They had this regulatory function thrust upon them, really without being consulted. But I was so proud of them. They never missed a lick as a Highway Commissioner and yet took from their businesses and their private time, and things like that all the time, an enormous amount of time that was necessary to add to what was already a busy schedule as a Highway Commissioner, and get that thing under control and make significant improvements to the process. That's a biased opinion, of course, but I think that there has been significant improvements made to the process.

STANTON:

Over the last few years there seems to be more and more demand on the Commissioner's time. What effect has this had on you personally?

PRITCHETT:

Let me say, that I wouldn't take anything for the opportunity that I was given to serve the people of Arkansas. Obviously you've got to have, and I have had, an extremely supportive, loving, and understanding wife. And my boys have been very understanding. But you have got to understand, my oldest son will just turn 15 by the time of this publication, and another will turn 14 in the spring. But I have another son that's never known his father a day that he wasn't a Highway Commissioner. I have a son that was born a month after I went on the Highway Commission. But even the oldest two were not really old enough at the time I went on the Commission for them to form definite opinions about their father not being a Highway Commissioner, extremely involved, extremely busy and this, that and the other. So my wife and my sons have been extremely supportive. Without that I could not have served, would not have served. The people I work with in my business have been supportive, 100 percent supportive. My friends were and my clients were. A lot of times I would get a call that I had to be at the legislature or something the next day, and I would have to cancel an appointment And not once in ten years did anybody fail to understand the importance of that. Now the difference was, ri practice sort of had to be scaled down, but sort of kept going. But there was a lot of times when if I'd have to spend three or four hours on the phone or attend a legislative meeting or something, I still had the same amount of work to be done that was done after the children were put in bed at night. I don't think I let my practice, what practice I retained, slip that much. And I don't think I let my family life slip at all. I just made it up with a lot of understanding and spending quality time. But it caused me to work a lot of nights and times when nobody wanted to call you on the phone and talk about roads and things like that. But, hey, I expected that when I went on the Commission. Not a single soul forced me to serve as Highway Commissioner. I volunteered; I did it; and I don't regret any of it.

STANTON:

If you had it to do over again, would you have accepted the appointment?

PRITCHETT:

Yes. Yes. I have an on-going 48-year love affair with the people of Arkansas. It was really honed in 20 years ago when I was elected president of the Arkansas Jaycees and had my first opportunity to go all over the state and meet the people, and it's being reinforced every day of each year. But the other bonus of being a Commissioner is the opportunity that I have had to work with some of the best people I have ever known in my life - and that is the people who have worked for the Highway and Transportation Department. When I compare what I go through to be a Commissioner with the sense of loyalty and responsibility and consistence and professional manner that the people of the Department go through every day of their lives, I make no sacrifice at all, by comparison. The employees - all of the employees of the Department - have been an every-day-kind-of inspiration to me. When they can do the kind of job that they do on a 24-hour-a-day, seven-day-a-week, 52-week-a-year job, and do such a great job maintaining the roads, then what little I've had to go through to be a Commissioner is well worth it just to have the opportunity to say that I was associated with those 4,000 people.

Career Enhancement Program To Assist With Opportunities

As Highway and Transportation Department employees, we are all made aware of the various job openings in the Department that occur from time to time. Each announcement lists the job title, pay grade, and minimum qualifications. If an employee is interested, and qualified, then application is made through the Personnel Office of the Human Resources Division.

It sounds like a simple procedure. However, many employees are either not aware of the opportunities or they don't know how to apply and successfully sell themselves to the interviewing official.

The recently inaugurated Career Enhancement Program hopes to break down many of the barriers employees face when they are considering a career change within the Department.

Twenty-three employees from District Six took part in the first of several meetings designed to help employees move through he job application process. A "job fair" was also incorporated into the meeting, which was held in the Central Office Auditorium in November.

"We are very sensitive to the concerns of the employees and their aspirations," said Assistant Director Dan Flowers. "This program will be a great benefit to our employees and help them advance their careers," he added.

Flowers, a 22-year career employee, told the participants that he spent five summers as a seasonal employee while attending college. After graduation with a degree in civil engineering he became a full-time employee and has held 14 positions with the Department over the years. "Patience is very important. Don't get discouraged," he urged, adding that "there are a lot of opportunities in the Department."

The half-day session included some tips on how to present yourself during the all-important job interview. "First impressions are very important," EEO Section Head Henry Droughter said. "Don't show up for the interview wearing cut-off blue jeans and a t-shirt. Your dress is important. It makes a statement about you. If it is a negative statement, then anything else you say or do during the interview probably will not matter."

"Make sure you meet the minimum qualifications before you even apply," said Personnel Officer Melba Shepard. "If the qualifications require shorthand and you don't have it, then don't apply. If, the job requires a degree in civil engineering, and you don't have it, then don't waste your time, or the time of the interviewer," she said. Shepard pointed out that the Department offers various training programs to employees. Anyone interested in finding out what is available should contact the Human Resources Division.

Following the presentations, employees met with representatives from the Department's various divisions to learn more about the duties and responsibilities of each and to ask questions about job opportunities.

As was pointed out over and over during the program, the opportunities for advancement are there. It is up to each employee to prepare themselves to meet those opportunities. The purpose of the Career Enhancement Program is to aid the employees as they strive to reach their goals.

Monday evening my wife and I shared a conversation regarding the time, money and effort expended to bring the Convincer to Crossett. Our conclusion was that if just one person became "convinced," then our efforts were worthwhile.



At 11:00 AM on Tuesday, July 17, I was presented with the choice of a head-on collision with an on-coming car, hitting a deer broadside at 60 m.p.h. or taking an off-road attempt to escape the other two options. I released my seat belt and crawled of the only available exit way which was the rear window. I walked away dusty and dirty, but with a big smile on my face as I had absolutely no injuries.

The Convincer is used for the purpose of educating the public on the advantages of using safety belts while operating or riding in a vehicle. The Convincer consists of a car seat mounted on a two-wheel trailer. The seat is equipped with both a lap belt and shoulder harness. Once a passenger is seated in the car seat and the lap belt and shoulder harness are properly buckled, the car seat is released from the top of the unit's inclined rails attaining a descent rate of approximately 5 to 10 miles per hour. The car seat is stopped by a pair of rubber bumpers at the bottom of the rails, simulating a jolting crash impact to the occupant riding in the car seat.

The Convincer may be used without charge by interested groups. For further information, contact the Traffic Safety Section at 455-1504. Arkansas State Fair Booth Attracts Crowds

Thanks to the appearance of a couple of "dummies" and the hard work of several dozen "volunteers", the Department's booth at the Arkansas State Fair in Little Rock was a big hit again this year.

Over 350,000 people visited the State Fair this year. One of the stops for many of the fairgoers is the Hall of Industry Building to visit over 100 booths and register for give-aways and pick up as many "freebies" as they can. One of the most popular free items for fairgoers is the Arkansas State Highway Map. During the 10-day event, October 5-14, over 15,000 maps were picked up by persons visiting the Department's booth. Approximately the same number of litter bags were also given to visitors, along with brochures on various highway and safety topics.

A big hit with the visitors was the special guest appearance by Vince and Larry, the crash dummies seen on many billboards and television ads. The Traffic Safety Section was kind enough to loan the costumes to the Public Affairs Office for a few days. Carolyn Johnson, Public Affairs Specialist, and her 15-year old son, Ronnie, were a perfect fit for the roles of Vince and Larry. (If you can't tell them apart in the photo, Carolyn is the short one.) Vince and Larry handed out thousands of "Buckle Up America" bumper stickers and other safety belt promotional items.

The Arkansas Highway Police Division assisted by furnishing officers to work each day at the Fair and they fielded many questions about the new Commercial Drivers License Law, truck weight regulations and other enforcement concerns. The officers also "deputized" several hundred youngsters by giving them stick-on badges with the Highway Police logo and a safety belt message.

Other volunteer workers from the Central Office and District Six handed out maps, brochures, and bumper stickers, and answered questions about the Department's programs and responsibilities.

It was a lot of hard work and long hours, but all of the volunteers said it was worth it. Many even signed up to work a shift at next year's Fair.

The Commercial Driver's License (CDL). By now, we've all heard about it, right? It's that new national driver's license that truckers have to get, right? It doesn't affect many people at the AHTD, right?

WRONG!

It's true that we're hearing quite a bit about CDL's these days. And it is a type of national certification that all truckers will have to have. But, it is also true that about 2,000 Department employees must obtain CDL's. That is approximately one-half of the total AHTD workforce.

The idea of a commercial driver's license came about in 1986. A federal law was passed that year requiring states to offer CDL's. States must comply with the federal law by 1992 or have federal highway funds withheld. The Arkansas Legislature passed Act 241 in 1989 which implemented the CDL requirements in Arkansas.

Basically, the law reads that certain drivers will have to obtain certification as "commercial drivers" by April 1, 1992 or literally get off the road. But the use of the word "commercial" has led to some confusion. Many people believe that it is only the professional truck driver who must obtain a CDL.

The law actually affects anyone driving a vehicle with a total weight rating of more than 26,000 pounds or a vehicle of any size carrying hazardous materials. The law also requires a commercial license for people driving vehicles that can transport sixteen or more people (including the driver), even if the

driverdoesn't consider himself a "professional."

Inother words, men and women who drive anything from tractor-trailer rigs to Greyhound or charter buses, to oil trucks or cement mixers, to school buses and even church buses, must have a commercial driver's license. And in order to get a CDL, a driver must take and pass a lengthy written test and, in some cases, a skills test.

CDL applicants must pass a general knowledge test to receive their appropri ate class of license - Class A for an combination of vehicles with a gross vehicle weight rating (GVWR) or more

han 26,000 pounds where the trailer being towed has a GVWR or more than 10,000 pounds; Class B for other vehicles or vehicle combinations with a GVWR of over 26,000 pounds; or Class C for vehicles with a GVWR of less than 26,000 pounds but which carry passengers or hazardous materials. Separate tests are required for special "endorsements." For example, a driver will have to take a tanker test in addition to the general knowledge test to receive an 'N' (tanker) endorsement if he or she drives a vehicle intended for hauling liquid in bulk.

employees have been identified as needing to obtain a CDL to perform their jobs fully. Because of the large number of AHTD employees who must pass the CDL exam, the Department has started a training program designed to assist those who must take the test. Department officials believe that a good training program will help avoid what has taken place in some other states. California, the first state to begin CDL testing, had a 53% failure rate from applicants in its first year of testing. Similar problems were reported in Michigan, Colorado, and Vir-


ginia.

"Our goal is to have all eligible employees receive a Class A license with an 'X'endorsement," said Leonard Hall, Staff Construction Engineer who is overseeing the CDL training program. A Class A license is needed because about 55% of the Department's major rolling stock has a GVWR of over 26,000 pounds and approximately 145 AHTD trailers are rated at over 10,000 pounds, Hall said. An 'X' endorsement covers hazardous material hauling (some asphalts are considered hazardous) and tanker testing.

Training is taking place in each of the ten districts. Videos and classroom lectures are being used to go over the material which will be covered on the test, and behind-the-wheel training is offered to those who need to take a driving skills test. Also, timed sample tests are given to the employees to help acquaint them with testing procedures. "The sample tests give the employee an idea of what type of environment to expect when they take the actual exam and it also helps us identify areas where the employee may need more schooling," Hall explained.

The actual CDL exam is given by the Arkansas State Police and test results to date indicate that the training has been very successful in preparing AHTD employees for the CDL exam. As of the middle of October, 623, AHTD employees had taken the test. Of that number, 591, or 95%, qualified for a Class A license and 571, or 92%, qualified for a Class A license with an 'X' endorsement. Those who do not pass the test on their first try are allowed more training and assistance before taking the test again.

Nearly 16,000 man-hours have been spent in training and testing to date. That works out to about 25 hours per employee tested. "Our success rate is due to our ten district coordinators and district trainers. They have gotten behind this program 100% and the results are obvious," Hall stated. "We are very pleased with the way our training and testing is working out. At this rate, we won't have any trouble meeting the April 1, 1992 deadline."



Dedications

Trumann Groundbreaking

It's often hard to picture a new highway when you're standing in the middle of a beanfield, but the residents of Trumann came out in force to do just that recently. A groundbreaking ceremony was held August 31 at the site of what will be Highway 63 just west of Trumann.

The ceremony took place where an interchange will be constructed connecting Highway 63 with Highway 69. From there, the project will proceed south and east to connect with the four-lane portion of Highway 63 south of Trumann.

Arkansas Highway Commissioner Rodney Slater of Jonesboro told the group that Highway 63 was a major artery in northeast Arkansas and that improvements were either complete, underway, orplanned on a great portion of it. He said the portion between Trumann and Bay was the last two-lane segment of High-




Officials break ground for the new Highway 63 south of Trumann

way 63 between Jonesboro and Interstate 55 near Turrell. A contract for the Trumman-Bay segment would be let sometime in 1991, Slater said.

The contract for the 4.5-mile project

being celebrated this day was awarded to Potashnick Construction, Inc., of Cape Girardeau, Missouri, on August 1, 1990. Contract amount for the grading and structures work was \$5.75 million.



New Lights for Prescott Interchange

It may not have been as dramatic as "a thousand points of light", but twenty-two new lights in Prescott was cause for celebration on October 22, 1990.

Approximately fifty residents of the Prescott area were on hand that evening for a ceremony to dedicate the lights recently installed at I-30/Highway 24 interchange in Prescott.

The purpose of the project was to improve safety and provide better visibility at the interchange. The project consisted of installing twenty-two lightpoles, each individually controlled by a photoelectric cell, along the entrance and exit ramps at the interchange. A contract for \$81,045 was awarded on April 18, 1990, to Apex Contracting, Inc. of Paris, Kentucky, for the work.

Arkansas State Highway Commission Vice Chairman Ron Harrod of Prescott addressed those in attendance at the event. He said that this project, though relatively small in cost, would do as much to enhance business in the area as some more costly projects. Prescott Mayor Joe Tate McGill also expressed the City's appreciation for the project.

Jim Meadows, manager of the Comfort Inn located at the interchange, said the lights were a welcome addition which should help his business. "In addition to the better visibility, travelers are more likely to stop at a well-lighted interchange. I'm glad we have them."

Celebration Marks Highway 162 Improvements

A narrow 20-foot roadway with virtually no shoulders is the type of transportation problem the Rural Road Program of 1985 was designed to solve. Highway 162 between Kibler and Alma in Crawford County is now much safer to drive, thanks to the completion of a \$2.1 million project funded under the Rural Road Program.

Governor Bill Clinton was on hand September 28 to join with residents of the two towns as they officially dedicated the 4.5-mile improvement. The new highway was constructed with two 11-foot travel lanes and 8-foot paved shoulders. Curvature and grade problems which existed along the route were also eliminated.

"We all know that Northwest Arkansas is experiencing rapid growth," Governor Clinton said. "We hear talk about the need for four-lane highways, and we are working on meeting those needs," he said, referring to construction on the nearby Highway 71 Relocation project. "But we also know that improved rural roads are important to our state's economy. We must have a good network of farm-to-market roads, and this Highway 162 improvement is a good example of meeting those needs."

Highway Commissioner Bobby Hopper of Springdale thanked the local officials for their cooperation in getting the project ready for contract. "During my term on the Highway Commission I have always been able to count on the people of Crawford County. It is that kind of working relationship that makes good things happen, like this highway improvement we are dedicating today," Hopper said.

State Representative Ed Thicksten of Alma and Alma Mayor Joe Hawkins expressed their thanks for the project and pledged to continue to work with the Highway Commission for future improvements.

Highway 1 Widening Dedicated

The widening of Highway 1 from Colt to Wynne to include passing lanes, and to add a continuous left turn lane on Highway 1 through the city of Wynne, are the first steps in the overall improvement of the Highway 1 corridor in Eastern Arkansas, according to Highway Commissioner Rodney Slater. "The Highway 1 corridor is essential to the economic growth of the area," Slater said.

Speaking at a ceremony to formally dedicate the two projects on November 2, Slater said the Highway Commission had made a commitment to Eastern Arkansas. "One hundred percent State funds were used for the construction of these projects totaling nearly \$760,000. That says a lot about how important we think this is to the overall development of this area," he said.

Slater commended those present for their work over the years to secure highway improvements. "As long as we see people locking arms and making a difference, then we're going to lock arms and work with you," he said.

At a meeting of the Highway 1 Corridor Group immediately following the dedication, Gazzola Vaccaro of Forrest City, a member of the Arkansas Industrial Development Commission, said East Arkansas has a lot to offer. "We must maximize our assets and find answers for our liabilities, such as education, commitment and involvement," he said. The improvement of Highway 1 is a step in the right direction, he added.




