

Director's Message

The Intermodal Surface Transportation Efficiency Act of 1991 was signed into law by the President last December. The Act provides authorizations for highways, highway safety, and mass transportation for the next six years. Total funding will reach about \$155 billion. Arkansas' share will be about \$1.7 billion.

This new level of funding is nearly twice the amount the State received over the past five years. Coupled with the 1991 Highway Improvement Program approved last year by the State Legislature, these federal dollars will allow us to make tremendous progress over the next few years.

For the past 20 years, the Federal-Aid Highway Program has been directed primarily toward the construction and improvement of four Federal-aid systems - Interstate, Primary, Secondary and Urban. Now, instead of four systems, there are two - The National Highway System (NHS) and the Interstate System, which is a component of the NHS. Plus, a new block grant type program, the Surface Transportation Program (STP), will be available for all roads not functionally classified as local or rural minor collector.

The National Highway System will consist of the current Interstate routes, a large percentage of the urban and rural principal arterials and strategic highway connectors. This system will be more clearly defined and designated by law by September 30, 1995. In the interim, the NHS will consist of highways classified as principal arterials.

What does this mean for Arkansas? Basically, it means we will have more miles of the State Highway System eligible for Federal-aid participation and we will have more discretion over the use of those funds.

The Act also includes categories that will achieve equity in funding levels among the states. In the past, Arkansas has been a donor state, which means we contributed more dollars to the Federal trust fund than we received back. Under the new Act each state is assured at least 90 percent return. However, since Arkansas has several "Demonstration Projects" identified in the Act, we should get back nearly all of the dollars we send in to the trust fund.

The highway commissioners and I are extremely grateful to the members of the Arkansas Congressional delegation for their untiring efforts in supporting an equitable Federal-aid Act. We expressed our concerns to them on many different occasions, and they responded positively.

We have a lot of work ahead of us as we begin preliminary studies and plans preparations, however, I am confident we can meet the challenge and move Arkansas forward.

Mack-Blackwell Amendment & 40th ANNIVERSARY

The history of the Arkansas State Highway and Transportation Department is filled with many significant people and events. Since its creation in 1913 to the present, literally thousands of individuals and events have helped shape the Department into what it is today.

Though the Department's history is quite varied and colorful, one event stands out as being the most significant — that being the passage of Amendment No. 42 to the State's Constitution, the Mack-Blackwell Amendment.

1992 marks the 40th anniversary of the passage of the Mack-Blackwell Amendment by the people of Arkansas. On November 4, 1952, by a margin of 231,529 For and 78,291 Against, the people overwhelmingly gave their stamp of approval to the amendment. A new era had begun regarding how the Department and Commission would go about their business.

To commemorate this historic occasion, "Arkansas Highways" is printing a series of articles about the history of the Department and the effect the Mack-Blackwell Amendment has had on it.

This first article gives a general overview of the political climate leading up to the 1952 vote by the people. Subsequent articles will give a more detailed look at various aspects of the Department's history, both prior to and since the passage of the Mack-Blackwell Amendment.

When the 58th General Assembly convened in 1951, there were many financial problems that required attention. Continued eco-

nomic growth was a prime focus, and better roads were needed to support that demand. But the legislature was not convinced that the Highway Department, operating under the system of the time, could build and maintain the desired transportation network.

Many years earlier, in the early 1910's, Arkansas' legislators had responded to a similar demand by providing for the creation of Road Improvement Districts (RID's). By the mid 1920's,

the number of RID's in the state had grown to over 400, and they had amassed a debt of \$64 million. The RID's were soon done away with and the debt was assumed by the State.

In 1927, the Martineau Road Program was passed. It was designed to create a system of U.S.-numbered highways, both interstate and intrastate. A significant number of bonds were sold to finance this program and pay off

the RID debt.

But the Depression of the 1930's hit and road construction was virtually halted. Revenues decreased dramatically, and those funds that were raised had to be used to pay off the Martineau and RID bonds. The Highway Department, barely 20 years old, was finding it difficult to live up to the expectations of the people.

The State and the Department had not fully recovered from the depression of the 1930's when World War II broke out. The advent of the war meant that only critical maintenance activitic could be performed on the high ways. This lack of needed improvements, coupled with the increased military transport traffic, made Arkansas' already inadequate highway system deteriorate even further.

When Sid McMath ran for governor in 1948, he based his campaign on a road-building program. The people of Arkansas were so eager for an improved road system that they elected McMath and overwhelmingly voted for a \$28 million, 4-year bond issue to finance road construction.

About the same time, legislation was passed to expand the Highway Commission to 12 members, each appointed by the Governor for a term to coincide with his. The Governor was also allowed to name the Director, Purchasing Agent, and Personnel Director for the Highway Department.

Though some roads were bing built, questions soon surfaced about the efficiency of the Highway Department. Concerns were

oiced about whether purchasing procedures and hiring practices of the Department were giving the state full value for its highway dollars. There was also speculation that the roads being constructed were being built for political advantage and favoritism rather than need.

So when the 1951 legislature convened, Highway Department reorganization proposals were among the early introductions in spite of the State's many other needs. Even Governor McMath, in his second inaugural address, suggested that the Department be reorganized by constitutional amendment, thus preventing repeal by future legislatures.

Senator W.M. Mack of Moorefield offered one of the first such proposals. le suggested that the legislature, not the Governor, select the members of the Highway Commission. But Senator Lawrence Blackwell of Pine Bluff opposed the idea. He said that under such an arrangement, the potential would still exist for future legislators to trade, deal, and tamper with the Commission.

After much debate, a compromise was worked out. The appointment of a five-member Highway Commission would be left with the Governor, subject to the approval of the Senate. The Commissioners would serve staggered 10-year terms, with a new Commissioner being appointed every two years. The Commission would then have the authority to hire a Director to oversee the day-to-day operations f the Highway Department.

This compromise became proposed Constitutional Amendment No. 42, commonly referred to as the Mack-Blackwell Amendment.

To add further fuel to the reorganization fire, the legislators pointed out several serious problem areas within the Department and determined that an independent audit would be the most reliable means of identifying specific problems and offering corrections.

The Highway Audit Commission held several public hearings in early 1952 before issuing its final report in March of 1952. The ficial in November of 1952 with the landslide approval of the Mack-Blackwell Amendment by the people of Arkansas by a nearly 3 to 1 margin.

With the resolution of those past practices, the Department embarked on a broad program of highway expansion and improvement. Since that time, total mileage has increased from 9,992 miles, of which 43% were unpaved, to 16,203 miles, with less than 1% unpaved.

The General Assembly

that the Highway Commission would remain a servant of the people and not dispensers of political favors. No longer would the Commissioners and the Director serve at the pleasure of whoever happened to be Governor at the time, and Highway Department jobs would cease being patronage positions.

Today, the

Department's responsibilities are managed by a highly trained and dedicated staff. A planned and continuous program of highway construction and maintenance has produced a balanced system of highways comparable to any in the nation.

These results are directly attributable to the foresight of the 1951 General Assembly, the citizens who overwhelmingly voted for passage of the Mack-Blackwell Amendment, and a dedicated and professional Arkansas State Highway and Transportation Departmental staff.



report charged that the Department had been operated "inefficiently, extravagantly, and with great waste of highway revenues." It placed most of the blame for the deficiencies "upon an unsound political system and philosophy of government." The Department's employees were generally found to be "able, honest, and efficient," but were used as "pawns in a game of politics."

The reorganization of the State Highway Department and the Highway Commission became of-

Implemented by the Arkansas State Highway Commission in the Fall of 1989, this program emphasizes the importance of studying mach, science, and English while encouraging students to pursue a career in the highway and transportation field.

Using a short video presentation and handouts, an engineer with the Department addresses students on the advantages of a career in highway and transportation work. The satisfaction obtained from planning, designing, and constructing long-lasting projects which have positive impacts on education, economic development, and the quality of life, are highlighted during the presentations.

By the end of the program's fifth semester, 99 of the Department's engineers had made 1,221 classroom presentations and contacted 26,171 students around the state.

The hard work is paying off. Many of the students have said they will certainly take a look at a career in engineering. One student at Harrisburg complemented an engineer on his presentation and noted that "it really made me start to think about going into engineering."

A Hope Junior High School student was impressed with the knowledge share by Assistant District 3 Engineer Don Donaldson. "He was a good speaker. . .I think people need to pay more attention to the roads today," the student said.

Other students throughout the state have made similar comments

on their critique forms. "A lot more goes into roads and bridges than I thought," commented a Malvern student. "I didn't know much about Civil Engineering before, but now I might be interested in that career," wrote a student from Warren.

A Bearden eighth grader told Engineer Kevin Thornton that she hadn't thought much about highways until his presentation. "I didn't think there was very much importance to the Highway Department," she said. But after the presentation she realized "working with the Highway Department is an important job."

Judging from the responses, it is evident that the Career Development Program is doing what it set out to do...create an awareness and interest in the highway and transportation field. Hopefully, this new-found interest will encourage many students to enroll in advanced math and science classes to better prepare themselves for an engineering career.

Military Road Project Underway

The city of Benton celebrated the start of the Military Road widening project with a groundbreaking ceremony February 20. Nearly 200 people were on hand to witness the start of the longawaited project.

"There is no doubt that this is a much needed improvement for the City," Highway Commissioner Bill Clark said. "We have been working with the City officials for a number of years to secure funding to widen Military Road. The City Council voted in 1985 to pro-

vide its share of the funding for the preliminary engineering and has continued to fund its share of the costs associated with this project," he said.

Military Road will be widened from three lanes to five lanes. It is

currently carrying an average of 16,000 vehicles per day and the widening is needed to ease congestion.

The project begins at Mair Street and continues east approximately 1.1 miles. A three block area at the beginning of the project is part of State Highway 88, but the remainder of the route is a city street. A combination of City, State and Federal funds were used to finance the construction.

Benton Mayor Jim Presnall said the project was probably the single most important street improvement project ever undertaken in Benton. Hogan Construction Company, Inc. of Little Rock was awarded the \$1.7 million contract in January. Work is expected to be completed by mid-1993.

State Highway 100 Dedicated at Maumelle

Maumelle and North Little Rock residents gathered at the city limits of the two towns November 13 to dedicate the recently completed four-lane section of State Highway 100 (Maumelle Boulevard).

The highway connects the Crystal Hill Road Interchange at Interstate 430 with State Highway 365. It runs through Maumelle and the western part of North Little Rock.

"The addition of two more lanes will make travel safer and relieve traffic congestion," Highway Commissioner Bill Clark told the crowd at the ribbon cutting eremony.

The additional two lanes were constructed adjacent to the existing highway, creating a four-lane divided highway along a 4.6-mile stretch. Turnarounds are provided every one-quarter mile along the highway to enhance access to businesses located on the route.

Clark said 14,000 vehicles a day travel the highway in the I-430 area and approximately 8,100 use the route at the Highway 365 end in Maumelle. The new lanes were constructed at a cost of \$3.1 million.

Former Highway Commissioner Raymond Pritchett of Maumelle served as Master of Ceremonies for the event and praised the cooperative spirit of officials from both cities and the state.

Maumelle Assistant Mayor Mike Odom recalled that it once tas 70-mile round trip from west ittle Rock to Maumelle. With the construction of I-430 in the mid 70's and the addition of Maumelle

Boulevard to the State Highway System the late 1980's, the round trip has now been reduced to less than 20 miles.

North Little Rock Mayor Pat Hays said the new four-lane "would enhance both commercial and residential growth" for that portion of North Little Rock.


State Senator Cliff Hoofman of North Little Rock noted that he and other officials from the two cities have been involved in a campaign to improve the route since Maumelle was incorporated in 1985.

"Maumelle was the only city of the first class in the whole state without a State Highway to it," Hoofman said. "The addition of what was once a county road to the highway system in 1987 was a step in the right direction. Now, with the completion of this fourlaning, we have a highway we can be proud of and one that will serve our needs for many years to come," he said.

Proposed North Belt Freeway Topic of Public Hearing

The North Little Rock High School East Campus Mini-Auditorium was filled to capacity Tuesday, January 7, 1992, as nearly 250 people attended a location public hearing to discuss the proposed North Belt Freeway through northern Pulaski County.

The proposed North Belt Freeway will be a multi-lane, divided facility built to Interstate standards.

It is designed to link I-430's terminus at I-40 west with I-440's terminus at I-40 east. The route would loop through the northern

portion of the North Little Rock metropolitan area.

This was Round 2 for public hearings on the North Belt. Hearings were initially held in the ear and mid-1980's on the route, but the plans had to be scrapped when suitable access could not be ob-

tained across Camp Robinson on the west end of the project.

Federal Highway Administration approval was received in the late 1980's for the leg of the route to connect I-40 east with U.S. 67/167 between Sherwood and Jacksonville. Construction could begin on that section by the end of the year.

The Department of the Army has recently granted the Highway and Transportation Department access across Camp Robinson for the roadway, therefore the January 7 hearing was set up to discuss the various location alternatives now being considered for the route between I-40 west and U.S. 67/167 north of Sherwood.

Four alternate locations were discussed at the hearing. All four routes were identical on the west end - the portion through Camp Robinson. The routes differ through the Sherwood and Gravel Ridge areas.

Kit Carson of the Surveys Division and Lynn Malbrough of the Environmental Division explained

in detail each of the four alternates. Based on the information gathered to that point, the AHTD presented Alternate 1, the southernmost route, as its preferred alternate.

Comments varied widely at the hearing. Favorable remarks were presented for all four routes, but most of the comments centered around Alternates 1, 2 and 2A.

It was announced at the hearing that a decision on the route would be made by summer and that a design public hearing would be held in about two years.

Extension of Highway 321 Subject of Public Hearing at Cabot

A new road linking State Highway 89 with the Highway 5/Highway 367 intersection just south of Cabot would decrease travel time and increase safety for motorists. That was the general tone expressed by area residents who attended a public hearing Thursday, December 12, 1991.

The meeting was held on a rainy evening in the Municipal Courtroom of the Cabot City Hall. But the rain did not keep the crowd away, as nearly 80 people were on hand for the meeting.

Highway and Transportation Department officials presented their proposal for extending Highway 321 from Highway 89 to the Highway 5/Highway 367 intersection.

This route would allow residents of the rapidly developing areas southeast of Cabot access to U.S. Highway 67/167 without having to travel through downtown Cabot.

State Representative Bill Foster of England was one of the first people to speak at the hearing. He spoke of the history of the project and how badly it was needed.

"I received over 2,000 signatures asking that I help, through the Highway Department, get this project started," he said. "When I campaigned last year, I publicly stated to everyone that I was for this project. I am stifl for it and I think we're gonna get it," commented Foster.

Larry Odom, a business owner and member of the Lonoke County Quorum Court, also spoke favorably about the project. "I have a strawberry field that's involved and my number one complaint from my customers is that they cannot get through Cabot. Some of them say they take twenty minutes to get from the freeway to my berry field, and it only takes twenty minutes to get to Little Rock from there," he stated.

It was announced at the hearing that, pending FHWA approval, a construction contract could be awarded sometime in 1992.



Arkansas Selected As Test Site

for High Performace Concrete

Arkansas is one of four states selected as a test site for high performance concrete by the Strategic Highway Research Program (SHRP). The new test is one of several projects being conducted in the state as part of a long-term study to determine pavement performance and life under various

conditions. The other high performance concrete test sites are in New York, North Carolina and Illinois.

Dr. John Schemmel of the Civil Engineering Department at the University of Arkansas at Fayetteville is conducting the research under a SHRP contract.

A section of Interstate 40 near Forrest City in east Arkansas was selected to test the long-term qualities of a High Early Strength Concrete (HESC). Two 45-foot sections of pavement were removed and replaced with HESC last fall, according to Bill Staggs, Pavement Management Engineer, who is serving as project coordinator.

The I-40 site was selected because of the large percentage of heavy trucks using the highway. Trucks make up approximately 55 percent of the nearly 25,000 vehicles per day using this section of

highway.

"As the name implies, High Early Strength Concrete attains its strength much quicker than normal concrete," Staggs said. "Our specifications call for standard concrete to reach the 3,000 psi to 4,000 psi range in 28 days. With HESC, we have reached 5,000 psi within 24 hours and 0,000 psi in 28 days," he said.

One obvious advantage to reaching this level of strength in a shorter period of time is that sections of highways being repaired can be reopened to traffic much sooner, thus creating less inconvenience to the motorists.

"It still takes the same amount of time to remove the damaged pavement sections and prepare the highway for the new concrete, but once the new concrete is poured the highway can be reopened the next day. Using regular concrete, the repaired section must remain closed at least 7-14 days to allow for proper curing, "Staggs said.

Staggs pointed out that a quick setting concrete has been used for a number of years to patch small sections of pavement as part of routine maintenance operations. The HESC is intended to be more permanent and will be used to relace entire sections of payment.

"This type of concrete has been around for years, but it has primarily been used in building con-

struction. Highway construction is a relatively new use for this concrete," he said.

In addition to the test site near Forrest City, there are 18 other location in Arkansas being monitored as part of SHRP. Researchers have already documented pavement, base and subgrade conditions at these sites and will continue to monitor them for 15 years. Only maintenance that is necessary to ensure road safety will be done at these sites thus allowing the test sections to deteriorate under the effects of traffic and weather.

Four additional projects will be undertaken this year as part of the testing on new construction projects. Two other projects will be started in 1993.

"Current pavement design practices are based on a road test conducted nearly 30 years ago at one test site by the American Association of State Highway Officials (AASHO). SHRP's program is the first effort to measure pavement performance in different locations, climates and soil conditions," Staggs said.

Department Receives Achievement Awards

The Arkansas State Highway and Transportation Department has received an Achievement Award from the National Highway Traffic Safety Administration (NHTSA) for its "outstanding leadership and managerial initiatives which revitalized the Arkansas Highway Safety Program."

The Department has administered the Highway Safety Program since July 1989 when the duties and responsibilities of the former Arkansas Transportation Safety Agency were transferred.

In presenting the Award to AHTD Director Maurice Smith, NHTSA Regional Administrator Georgia Jupinko praised the Department for "improving the efficiency of the Safety Program since taking over in 1989." NHTSA was initially concerned about the future of the Program because it was the second time in as many years that the Program was being shifted to another state agency, Jupinko said.

"However, you quickly dispelled any concerns we had and you have led the way in promoting highway safety," she said. "You

spearheaded the passage of safety belt laws in Arkansas and have encouraged safety belt usage. Without your leadership, a safety belt law may not have been passed during the last legislative session," she said.

In addition to the Achievement Award, Jupinko also presented the Department with a 70% Plus Safety Belt Use Award. The Award is presented to businesses, organizations, and government agencies that attain a 70% or higher safety belt use among its employees.

Independent spot check surveys are conducted to determine safety belt use by agency employees.

EDITOR'S NOTE: The AHTD has purchased several vehicles over the past few years that have air bags. Robert Cox, Highway Inventory Supervisor with the Technical Services Section of the Planning Division, was recently involved in an accident while driving a Department owned 1988 Dodge Diplomat and credits the air bag, coupled with seat belt use, as a major factor in preventing serious injuries. He submitted the following article relating his experience.

On January 15, 1992, I was driving south on State Highway 5 between Little Rock and Benton. When I approached Salem Road, a vehicle came out in front of my car. Upon impact, the air bag came out, stopped my forward motion, and possibly saved me from more serious facial injuries.

I was wearing my seat belt, and with the seat belt and air bag I did not move. I think I would have hit the steering wheel had the air bag not worked, as my legs are short and I sit very close to the wheel. Had I made contact with the wheel I could have had any number of injuries, whereas I only received some bruises and a busted lip from the air bag. I will take that type of injury anytime over what could have happened.

There is one thing people should know about the air bag. When it inflates, it immediately deflates. The residue from the chemical reaction that inflates the bag will appear to be smoke. My first reaction was, "the car is on fire." But, of course, it was not. Also, I was driving with the steering wheel in the up position; this caused the bag to hit me in the face. Had I been driving with the wheel down, the bag would have hit me in the chest area, and I probably would not have been bruised.

Henry Droughter Appointed To Serve On TRB Committee

Henry Droughter, EEO Section Head, has been appointed to serve on the Transportation Research Board (TRB) Management and Productivity Committee. He will serve as a member of the committee through January 1994.


The Management and Productivity Committee was recently formed. Its mission is to address all aspects of human resource management and development as they relate to transportation organizations. The committee is also concerned with the general theory and practice of management, productivity and effectiveness.

Droughter participated in the first working session of the committee last summer in Washington, D.C. Key issues in the area of management and productivity were discussed. From the topics discussed, the committee selected its priorities: cultural diversity, environmental awareness, productivity, organizational structure and culture, and informational systems.

During the Transportation Research Board's Annual Meeting in January 1992, the committee met to plan an agenda based on the priorities selected. The members used this opportunity to share information about their current activities and major areas of concern in management and productivity.

Droughter has also been nominated as one of seven potential new instructors for the Disadvantaged Business Enterprise (DBE) Program Training Course. During the week of February 3-7, 1992, he participated in an instructors' training session in Texas. If selected, he will join the team of four instructors currently conducting the training nationwide.

The training course, sponsored by the National Highway Institute, has been well received throughout the country and as news spreads about the beneficial nature of the training for both State and Federal personnel involved in the DBE Program, re-

quests for training have exceeded initial expectations. To accommodate the increased demand for the course, the number of instructors will be increased.

Twenty-five training courses have been presented nationally over the past two years. The practical, "hands on" approach of the instructors is the predominant reason the course has been so well received. This course was presented for Department personnel in November 1990.








District Four Service Award Recipients


