


Director's Message



Department Reorganization and Personnel Changes

Shown below is the Department's organization chart which became effective May 16, 1994. This chart reflects the designation of the positions of Deputy Director and Chief Engineer, Chief of Administration and Public Affairs, and the re-designation of the position of Assistant Chief Engineer for Planning. In addition, the Construction and Maintenance Division has been split to form two separate divisions. This change is to add emphasis to the Construction and Maintenance functions. The responsibilities of the former Traffic Division have been reassigned within the organization as follows: Traffic Services to the Maintenance Division, Traffic Engineering to the Roadway Design Division, and Traffic Safety to the Programs and Contracts Division.

Computer Services, Equipment and Procurement, Fiscal Services, and Human Resources Divisions have been reassigned to the Chief of Administration and Public Affairs.

"Partners In Quality" 1994 Quality Initiative Conference

The afternoon program con-

sisted of breakout sessions covering Pre-Design/Design, Construction, Local Government Issues, Quality Assurance/Quality Control and Information Superhighway. Each session consisted of a discussion with participants exploring how quality initiatives could contribute to a better product.

Commission Chairman L.W. "Bill" Clark, Vice Chairman Bobby Hopper and Commissioners Herby Branscum, Jr. and J.W. "Buddy" Benafield spoke at the banquet Tuesday evening.

During the Wednesday morning session, Dr. Walter LeFevre,

Director of the University's Mack-Blackwell Transportation Center (MBTC) and Dr. Robert Elliott, Head of the University's Civil Engineering Department, spoke of the roles the MBTC and the University of Arkansas play in the development of professional and quality transportation facilities.

Charles Cowan, a consultant from Washington and former Director of the Arizona Department of Transportation, was the keynote speaker. He stressed that the effective implementation and sustainment of a quality initiative in the construction industry is de-

pendent on full participation of the entire construction team—owner, designer, contractor, subs, and suppliers. 

State Highway 7 Designated As Arkansas' First Scenic Byway

More than 100 people braved cloudy skies and rainy weather in Russellville on Tuesday, April 5, for the dedication of the 194-mile stretch of Arkansas 7 as the State's first scenic byway.

The day began with two bus tours departing from the north and south ends of Highway 7. One bus left Harrison at 8 a.m. and headed south with stops at Jasper and the Rotary Ann Rest Area, north of Dover, before arriving in Russellville. The other bus departed Arkadelphia and headed

north with ceremonial stops in Hot Springs, Jessieville and Nimrod before rendezvousing in Russellville at 1 p.m.

Speakers at the final ceremony were: L.W. "Bill" Clark, Highway Commission Chairman; Richard Davies, Director of the Arkansas Department of Parks and Tourism; Mike Curran, Forest Supervisor, Ouachita National Forest; and Lynn Neff, Forest Supervisor, Ozark National Forest. Commissioner Clark said, "It is an extremely beautiful highway ... it is

fitting that Highway 7 become the State's first scenic byway."

Plans to pursue the designation of Highway 7 as a scenic byway were initiated in 1989, and a year later the Scenic 7 Byway Partners group was founded. The group consists of 20 organizations and government agencies interested in promoting the Highway 7 corridor as a tourist attraction.

Citizens were able to express their opinions on the designation at a public hearing held July 13, 1993.in Russellville. Bryan Davis,

Planning and Research Division Head, commented, "The proposed section of highway meets all three of the national requirements for byway consideration: the route is already a state highway, a group of interested people are supporting the designation, and the byway contains many tourist-attractive elements." The general consensus was that people were in favor of the proposal.

The Highway Department expects to spend \$1,000,000 over the next several years to enhance the highway. The U.S. Forest Service

will spend \$500,000 to improve the Rotary Ann Rest Area in Pope County. International Paper Company will plant approximately 500 red maples along the route to enhance its beauty.

"The designation will make Highway 7 eligible for federal funds and will also draw nationwide attention to the area," com-

mented Dan Flowers, AHTD Director.

According to recent studies, driving for pleasure is the most popular recreational activity in the country.

Lisa Wolfe of the Department of Parks and Tourism said that in 1992, "25 percent of the State's visitors listed sightseeing as their main activity."

Richard Davies said that he did not know how much tourism the new scenic byway would attract, but that it would help a lot. "Simply being on the map, people tend to give it credibility," he said.



Meeting of I-69 Proponents Held In Memphis

The concept of I-69, often referred to as the "Mid-Continent Highway," gained momentum as members of the I-69 Mid-Continent Coalition held their first annual meeting recently in Memphis.

The Coalition is composed of state officials and business supporters from Indiana, Kentucky, Tennessee, Arkansas, Mississippi, Louisiana, and Texas. Approximately 100 people attended the meeting May 12 at the Brooks Museum of Art in Overton Park. The highway is listed as a "high priority corridor" in the Intermodal Surface Transportation Efficiency Act (ISTEA) of 1991. The route will connect the cities of Indianapolis, Memphis, Shreveport, and Houston.

Arkansas Governor Jim Guy Tucker said a combined push by the eight states may help win federal approval for the project. "When you

have this many states interested in a project, you enhance the prospect of getting Congress and the President to turn loose our money that's sitting in the Highway Trust Fund," Tucker emphasized.

Both Governor Tucker and Tennessee Governor Ned McWherter, who also attended the meeting, said their states support the project as a way to create jobs and boost the economy. "I-69 would open southeast Arkansas to economic development providing long-term benefits for the rest of our state," Tucker said.

Arkansas Highway Commission Chairman L.W. "Bill" Clark and Commission members John "M" Lipton and J.W. "Buddy" Benafield attended the meeting with Department Director Dan Flowers and Deputy Director and Chief Engineer Roger Almond.

Arkansas has assumed the role of the lead state in the coalition and the responsibility for coordinating the activities of the steering committee, composed of representatives from the eight states involved. Flowers told the gathering that a consultant has been selected to conduct a feasibility study which should take about 15 months to complete. "Once the study is complete, we can take our proposal to the federal government and request additional funding," Flowers said.

Arkansas sent an impressive delegation to the meeting. In addi-

tion to the Governor and highway officials, former Commissioner James Branyan, State Senator Kevin Smith, State Representative Charlotte Schexnayder and Terry Sherwood, Executive Director of the Arkansas I-69 Coalition also attended.

Dan Flowers Participates In "Capital for a Day" Program

Five hundred people assembled at a town hall meeting during the "Capital for a Day" program at Siloam Springs May 19, 1994.

The "Capital for A Day" series brings the Governor and state agency heads to various cities throughout the state in an effort to bring government to the people and listen to their concerns.

Governor Jim Guy Tucker, responding to a question regarding how long the Highway 71 project would take to complete said, "I'd like to see a road built so that those who pay for it can drive on it in this lifetime." He also said he would not sit back and let the project take the estimated 12 years to be completed.

Director Dan Flowers addressed the question of completion for Highway 71 by saying, "The Commission is exploring alternate funding sources in order to speed up the time frame." Flowers also explained to the audience that the Highway 71 project is a state and federal priority by virtue of being in the Interstate 49 corridor. He said that presently all but 16 miles of the project were under some stage of construction.

Governor Tucker followed Director Flowers' remarks by explaining how highways are funded traditionally and then discussed some of the options he and the Commission have been exploring, such as tolls, bond issues, and privatization. "We have been working on the problem for several months and it is a priority for all of us," he emphasized. "The plans have been drawn and the people of Arkansas will have to decide how they want to fund the construction in order to complete the highway sooner," he continued.

Following the town hall meeting, Director Flowers stayed overnight with AHTD Area Maintenance Supervisor Bill Harbison and his family in Gentry.

The next morning Flowers visited with the Maintenance Crew at the Area Headquarters and listened to their concerns and suggestions.

Flowers has also attended "Capital for a Day" programs in Nashville, Prescott, DeQueen, Pocahontas, Newport, Walnut Ridge and Harrison.

Students Speak Out On Litter

A recent series featured in Crossett's local newspaper, *The Ashley News Observer*, generated a lot of interest. The series published essays written by Crossett students about the litter problem and what can be done to resolve it.

Five schools were involved: Anderson Elementary, Hastings Elementary, Price Elementary, Norman Junior High, and Daniel Middle School. Approximately 300 students participated and the best five or six essays from each school were submitted to the local newspaper for publication.

Chris Jordan, a fifth grader at Price Elementary, summed up the problem by saying, "Some people are lazy and throw their trash on the highway instead of in a trash can."

Although the Crossett Area Chamber of Commerce sponsors an annual Spring Clean-Up Drive, litter seems to be a growing concern to many people in the community.

The students had several suggestions for alleviating the problem. Some thought that the citywide cleanup should be more than once a year. Many also suggested raising the fine for littering, as well as enforcing the law more aggressively. "You never hear about fines being given out," said Brad Walsh, an eighth grader at Norman Junior High. "None of the laws are enforced."

When asked what should be done to punish litterers, Clint Knighton, an eighth grader at Norman Junior High, replied, "Send them to Singapore."

"Everybody needs to pitch in and help or someday our world will look trashy," said Kimberly Guthrie, a fourth grader at Hastings Elementary.

Janice Clark, a retired reporter for the Crossett paper, is responsible for starting the project. After noticing an article entitled, "Students Celebrate Newspaper in Education Week," Ms. Clark wrote to the editor suggesting that teachers guide students to focus their thoughts on highways. "They might learn that writing can be an effective tool for solving problems. I think this should be dramatized," Ms. Clark stated. "Hopefully the kids can teach their parents better."

Department Conducts Three Public Hearings



HIGHWAY 9B AT MORRILTON

A vocal crowd attended the open forum public hearing covering proposed plans to widen Highway 9B in Morrilton March 1.

Mayor Jim Sitton requested the hearing to address citizen concerns about the project. The proposal would add a center turn lane to Highway 9B from Highway 64 to

Highway 247. Residents along the route expressed their opposition and directed many of their comments to the Mayor and members of the City Council.

The Mayor responded that he did not favor the current proposal. He suggested minor modifications at several intersections to accom-

modate turning movements and correct drainage problems. Department representatives said the Mayor's suggestions would be considered along with other comments received at the hearing before a final decision is made.

HIGHWAY 62 AT EUREKA SPRINGS

Over 230 citizens attended a public hearing in Eureka Springs May 24 to comment on alternates being considered for the widening of Highway 62. Comments varied widely from ardent support to extreme opposition.

Four new construction alternates were presented at the hearing along with a "No Action" alternative. The new construction alternates add a center turn lane through all or most of Highway 62 between the Highway 23 North intersection and East Mountain Drive.

Participants at the hearing were informed that a final decision regarding which alternate to pursue would be made after their comments were evaluated and reported to the Federal Highway Adminis-

tration. This is expected to take approximately four to six months.

HIGHWAY 8 EXTENSION AT WARREN

The crowd was small but enthusiasm high at a public hearing held June 7 in Warren to discuss the proposed extension of Highway 8. About 35 people attended with the vast majority clearly in favor of the project.

"This extension will accomplish two needs for our community and county," said State Senator Jim Scott of Warren. "First, it

will combine the truck traffic from Highways 8 and 15. Secondly, it will further our work toward a north-south artery from Pine Bluff through Warren to El Dorado with connections to Ruston, Louisiana and I-20.

State Representative Marian Owens of Warren also attended the hearing and expressed her support for the project. "I would hope that construction could begin at the earliest opportunity."

"The City of Warren supports this project and thanks the Highway Department for its efforts to see it completed," said Greg Reep, Mayor of Warren. "It will improve the safety and quality of life for all our citizens."



I am writing in regards to one of your employees, Tommy Harper. If he hadn't gone beyond the call of duty our motor home would have burned to the ground.

We were parked in the rest stop south of Batesville about ten miles out on Highway 167. We were unaware that our generator was on fire. He saw the smoke and came up. The generator was in flames and the luggage compartment beside it was in flames. It looked hopeless and there was a chance that it would blow up from the fuel.

He came back up later when he saw that we were still there and ran my husband to the parts store because we were leaking fuel and couldn't plug the line up. We were able to get back on the road and make it back to Mountain Home just before the roads became impassable.

If it wasn't for Tommy Harper our motor home would

have burnt to the ground and also if it weren't for him w wouldn't have made it home. We would have been strande on the road without a generator.

I now believe in guardian angels! You are very lucky to have such a man in your employment. A lot of people wouldn't have bothered to be as helpful. He takes his job seriously and does it with pride. Thank you for hiring such a wonderful man. We had only bought the motor home the week before and had spent our savings on it. We were only taking it out a couple of days to see how things worked. Well we found out. Even if the insurance gives us trouble we feel lucky that we still have a motor home and can repair it someday. We didn't have to watch our savings go up in smoke. Please give Tommy our thanks.




