

### Director's Message

It's been an eventful year thus far for the Highway and Transportation Department. The General Assembly enacted the 1995 Highway Bond and Local Road Improvement Program which the people will have a chance to vote on later. In addition, Act 893 was passed by the legislature to help make highway work zones safer. Also Operation Safe Speed, a joint law enforcement effort, has increased awareness of the speeding problem on our roadways and had an impact on the speed of vehicles traveling on our highways.



The highway bond program drew most of the attention during the session, and this program is covered in more detail later in this magazine.

Act 893 is designed to enhance safety for motorists and workers in highway work zones. This law doubles the fine for a motorist who commits a moving violation in a work zone. The intent of this legislation is to cut down on the number of accidents and injuries that occur in highway work zones. Once motorists become aware of the law, we hope to see significant decreases in these numbers.

Operation Safe Speed and Act 893 are designed to improve safety on our roadways. The increased awareness of vehicle speed and safety laws will prove to be very beneficial to our maintenance workers and our highway construction crews as travel continues to increase.

These initiatives represent a cooperative effort between the Department, the Legislature, and the law enforcement community to enance safety and improve the quality of travel for the motoring public.



### THE 1995 LEGISLATIVE SESSION:

### One for the History Books

The highway bond construction program encountered a few roadblocks on its way to approval by the Arkansas General Assembly. Some in the media pronounced it "dead on arrival" and there was vocal opposition. But after weeks of discussion and close scrutiny, legislators sent the program to the Governor for his signature. Voters will have an opportunity to approve the program in an upcoming special election.



Newspaper accounts followed the course of the highway bond package through the legislature. A sample of headlines taken from papers around the state during the session gives one an idea of the twists and turns the legislation encountered:

The highway construction bond proposal is made up of four components. Act 1007 authorizes the Highway Commission to issue up to \$3.5 billion in bonds to finance highway construction in the state. The other three acts provide the funding necessary to repay the bonds once they are issued. They are:

Act 1005, which levies a 6.5%

excise tax on gasoline at the wholesale level;

Act 1006, which increases the diesel tax rate by 5¢ per gallon; and,

Act 1008, which increases the general sales tax by one-half of one percent.

More information about each of these acts and the benefits that the program might provide can be found on pages 4 and 5 of this magazine.

Though the legislature approved the proposal, the voters of Arkansas will have the last word. According to the Arkansas Constitution, no bonds can be issued without the approval of the public in a general or special election. In this case, Governor Tucker will likely call for a special election to

e held in early 1996. At that time, the people will decide whether to approve bond program.

"We have a big task ahead of us to educate the public about this program in the coming months," said Highway Commission Chairman L. W. "Bill" Clark. "I want to commend the members of the General Assembly for their careful study of this issue and for referring it to the people. The people are the ones who have expressed a desire for building roads faster. They now have the opportunity to implement such a program."

If the proposal is approved by the public and bonds are issued, it will be the first time in more than four decades that bonds have been issued by the State for a road proram. Act 5 of 1949 authorized the Commission to issue bonds to finance Governor Sid McMath's road program. The last of those bonds were issued in 1951 and were retired in 1960. The State has been free of any bonded indebtedness for highways since 1973 when the last of the Helena Bridge Construction bonds were paid off.

"This is a pivotal moment for the Highway Department and for the State," said AHTD Director Dan Flowers. "If this proposal is approved by the public, it will mean more miles of construction in a shorter period of time than has ever been undertaken before. It will be a tremendous challenge and opportunity for Department's employees, and it rill give the people of Arkansas the highway system they deserve in the the time frame they desire."

### Historic Legislation Signed Into Law


With all the debate and discussion of the legislative session behind, the four bills making up the highway bond construction program were signed into law by Governor Jim Guy Tucker at a ceremony Friday, April 7 in the Governor's Conference Room. Highway Commissioners and other AHTD officials joined Governor Tucker and legislative sponsors and supporters for the event.

The Governor referred to the struggle to get the legislation passed as he inked his signature in place. "These bills were dead on arrival," he quipped. "I want to sign this legislation with a flourish and a smile."

State Senator Wayne Dowd of Texarkana sponsored the four bills and ushered them through the Senate. Representative John Miller of Melbourne handled the bills during debate in the House.

"This was a team effort," said Commission Chairman L.W. "Bill" Clark. "I want to thank the Governor for his initiative and foresight, and all the Senators and Representatives who supported this legislation. I especially want to thank Senator Dowd and Representative Miller for the extra effort they put forth."

### **FACTS: 1995 HIGHWAY BOND PROGRAM**



Act 1007 (Senate Bill 662)

Authorizes the Highway Commission to issue up to \$3.5 Billion in Bonds for Highway Construction

- Must be approved by voters in a general or special election;
- General obligation bonds backed by the full faith and credit of the State;
- Routes to be improved will be generally identified prior to bond election;
- Specific construction to be identified before each series of bonds are issued.

## Act 1005 (Senate Bill 660) Levies a 6.5% Excise Tax on Gasoline at the Wholesale Level

- Tax will be levied only if bond proposal and diesel tax are approved by voters:
- Calculation to be based on wholesale price plus federal tax of 18.4 cents;
- Tax increase roughly equal to five cents per gallon at a taxable price of 73.4 cents (wholesale price of 55 cents plus federal tax of 18.4 cents);
- Collections to be divided with cities and counties (70/15/15);
- Tax will terminate once associated bonds are retired;
- Estimated to generate \$44 million annually for the 1995 highway program and \$9.5 million each for the cities and counties.

6.5% Excise Tax on Gasoline at Wholesale Level



## Act 1006 (Senate Bill 661) Levies an Additional Five Cents per Gallon Tax on Diesel Fuel

- Must be approved by voters separate from the bond proposal in the same election;
- Tax will be levied only if bond proposal is approved by voters;
- Collections to be divided with cities and counties (70/15/15);
- Tax will terminate once all associated bonds are retired;
- Estimated to generate \$15 million annually for the 1995 highway program and \$3.5 million each for the cities and counties.

## Act 1008 (Senate Bill 762) Increases the General Sales Tax by One-half of One Percent


- Tax will be levied only if bond proposal and diesel tax are approved by voters;
- All proceeds dedicated to highway program;
- Tax will terminate once all associated bonds are retired;
- Estimated to initially generate approximately \$150 million per year for the 1995 highway program;
- Cities and counties will not share in this revenue.

General Sales Tax Increase 1/2 of 1%




### **Program Benefits**

P rogram will provide an interconnecting system of four-lane highways to tie the state together and provide the potential for increasing economic growth, safety, and convenience.



P rogram will create over 190,000 new jobs (based on 40 jobs created for every \$1 million spent on highway construction);





Additional economic activity over the \$11 billion previously mentioned occurs as new construction investment takes place. This may come in the form of businesses, etc. that locate along the new highways.



ver 1,300 miles of two-lane highways will be improved under the bond program. Many of these routes will be improved to four-lane highways which are considerably safer. Based on statewide historical accident data, it is estimated that upgrading two-lane rural highways identified in the bond program to various types of four-lane roadways will lower the accident rate from 1.45 to 0.85 accidents per one million vehicle miles traveled, a 170% decrease. For the fatal accident rate, it is projected that the proposed improvements would lower the rate from 3.18 to 1.07 fatal accidents per one hundred million vehicle miles traveled, a 300% decrease.

### Officials Tour New US Highway 71

Federal Highway Administrator Rodney E. Slater returned to Arkansas March 19 to see firsthand the progress on new Highway 71 north of Alma. Commission Chairman L.W. "Bill" Clark, Vice Chairman Bobby Hopper, and Commissioners Herby Branscum, Jr., and John "M" Lipton along with AHTD Director Dan Flowers showed the new construction north of Alma to Slater, U.S. Senator Dale Bumpers, U.S. Representative Tim Hutchinson, and other officials.

After the morning tour, the Fort Smith Chamber of Commerce hosted an outdoor event to demonstrate support for the Highway 71 project.

Slater applauded the project as a way to connect Arkansas to the world. "For a long time we believed we could build a wall around Arkansas and survive... we need to connect ourselves to the nation and the world so that everyone can benefit from what we hold dear."

Bumpers mentioned the \$350 million cost of the project from Alma to Fayetteville. "That's a lot of money, but you can't really put a price tag on it. The highway will have an enormous economic benefit. It will be one of the most magnificent scenic drives in America."

Most important, he added, is safety. "It's worth all \$350 million to the parents whose children drive that highway to the University of Arkansas," he said. He reminded the crowd that his parents were killed in an accident on Highway 64 between Fort Smith and Sallisaw, Oklahoma, before the construction of Interstate 40. "A drunk driver came over the hill on their side. There was no shoulder, nowhere to go....If we'd have had the interstate, my brother and sister and I could have enjoyed our parents for another 30 years."

Tucker urged the crowd to support the proposed highway bond program in order to deliver more quickly on projects such as the new Highway 71 from Interstate 40 south to Louisiana.

"If the people are given the chance to decide their own future, given the opportunity to provide new jobs for their children, they will seize the opportunity," he said.

Clark called attention to a recent agreement that delivers more federal money for the project.

"We just recently concluded a successful effort with Senator Bumpers and Administrator Slater to secure a \$24.2 million advance on funds earmarked for Highway 71," Clark told the crowd. "Rather than waiting on that money, we no put it to work right away to meet our goal of completing this project in 1999."

### S.H. 160 Bridge Opened to Traffic Replacing Historic Spring Bank Ferry

State Highway Commissioner John "M" Lipton, AHTD Director Dan Flowers, and other dignitaries were on hand March 24 to dedicate a new bridge replacing the historic Spring Bank ferry. The bridge is located on State Highway 160 at the Red River, 15 miles west of Bradley and two miles west of Doddridge.

Those speaking to the crowd of more than 200 included Lipton, Senator Wayne Dowd of Texarkana, Flowers, Lafayette County Judge Frank Scroggins, and Miller County Judge Hubert Easley.

"It's always a bittersweet occasion when a faithful old ferryboat is retired," said Lipton. "On the other hand, the benefits of a bridge are clear. When you cross the new bridge, remember the Spring Bank ferry with fondness — and look forward to the new opportunities the Spring Bank bridge will bring you."

Flowers recalled the heyday of the ferries. "When I first joined the Department,





we still operated ferries at nearly 20 locations all over the state," Flowers told the audience. "Since then, the Department has replaced nearly all ferry crossings with bridges. When Spring Bank ferry makes its last crossing next month, we will operate only one ferry — at Peel on Bull Shoals Lake north of Yellville."

The Spring Bank ferry, operated continuously since the early 19th century, was retired upon completion of the bridge. Attending the dedication was Norma Blanton Roberts, 89, of Doddridge, the oldest surviving member of the Blanton family. He family operated the Spring Bank ferry from the mid-1830s to 1964.

### Spring Bank Ferry's Last Ride

Crew members will miss hard work, good times

It may have looked peaceful, that big orange tug and barge gliding back and forth across the river. But operating the Spring Bank ferry was no vacation. Ferry supervisor Lonnie Hazel and pilot

Rex Barnes talked about their work at Spring Bank shortly before the ferry made its last run Friday morning, April 7.

"I usually start my day around 5:00 a.m. to make sure the land-

ings are in good shape," said Hazel. "I get the time sheets made out, put fuel in the tug, and have it ready to go by 5:30. Usually at 5:20 or 5:25 we'll make the first round."

"A lot of people think there's nothing to being a deckhand," said Barnes, who signed on as a deckhand and later moved up to the pilot's seat. "But you walk a lot of miles back and forth on that thing in the heat and the weather. It's an easier job, being pilot. You've got more responsibility but when the water condition's good, it's good running."

Hazel, Barnes and the rest of the crew never made the exact same run twice. The Red is a restless river, constantly rearranging its bed, moving sandbars here and there.

"The east bank is the shallow side of the river and that's where we usually have our problems," said Hazel. "It might be deep water this afternoon, but tonight or tomorrow morning you'll be looking at a big sandbar. Our landing on the west bank is an asphalt landing, and the landing on the east bank we move according to what the river and the sandbars are doing."

High water was always easier running than low water — except in 1990. Newspapers across the country carried photos of the swollen Red River raging over its floodplain. The east landing was deeply under water; the usual five-minute crossing turned into a white-knuckle 45-minute ride. "We finally tied it up until the river calmed down," he said.

Hazel's crew members were the last in a 170-year line of ferry operators at Spring Bank. The first ferryman in the mid-1820s was "a rugged old pioneer man dressed in buckskin" piloting a log raft, according to records of the Lafayette County Historical Society.

John Caffery bought the ferry around 1834 and hired a Swedish carpenter to build a new boat of cypress. Slaves performed the hard work of poling the ferry across the Red River. Caffery soon sold the ferry to Colonel William Blanton. Six generations of Blantons operated the ferry until 1964, when the state assumed responsibility for it.

The Blantons' ferry attracted the interest of both sides during the Civil War. Federal troops guarded the crossing sometime before 1864 to stop the transport of Confederate supplies from Mississippi to Texas. In 1864 a Texas army division camped at Spring Bank to guard against a possible Federal invasion of Texas.

In more recent times the ferry was an important connection between southern Lafayette and Miller counties. Even so, the ferry never tied the two counties very closely. Hazel and Barnes, both Miller County natives, say they never knew many people on the Lafayette County side.

"I knew more people around Texarkana and Atlanta, Texas, than I did those who lived within five miles of us here.... it's strange. We lived right next to those people and never knew them because we were divided by the river."

Barnes said he will miss the ferry. He's made many friends onboard, and has a folder full of postcards to prove it — some from as far away as Spain and Japan. "I'll miss the crew and miss the people who cross here," said Barnes. "A lot of people are late before they leave home. They don't have time to wait on a ferry."

Hazel takes the broad view as well. "We're going to miss the ferry, but on the other hand, you look forward to going on into another field of the Highway Department." Hazel and his crew have been reassigned elsewhere in District Three, most of them to the Miller County maintenance crew.

"It's going to be different from the way we work out here. We're here seven days a week." Hazel paused, then laughed. "Working a five-day workweek, I'm going to have to sign up for a second job. I'll have too much spare time on my hands."

### Celebrate Construction Week Observed May 8-12

All eyes focused on the role that the construction industry plays in our everyday lives as the Arkansas Chapter of the Associated General Contractors of America sponsored the third annual "Celebrate Construction in Arkansas Week" May 8-12.

The week was kicked off by Governor Jim Guy Tucker's official proclamation of the event. Contractors, suppliers, designers, and legislators joined together throughout the week in saluting the industry and its importance. The celebration culminated on Friday, May 12 with a luncheon featuring AHTD Director Dan Flowers as one of the keynote speakers.

Flowers' remarks centered on the proposed highway bond construction program and the impact it might have on the state and the construction industry. "People are demanding a lot more from the highway system than we can currently provide with pay-as-you-go financing," Flowers said. "Using bonds to finance construction will allow us to do more in a shorter period of time than we are currently able to do."

Arkansas' highway contractors will be directly affected if the bond proposal is approved by voters in a special election early next year, Flowers noted. The Department would award up to four times the

amount of contracts that it currently awards if the proposal passes. "I don't think I need to explain further the impact this program would have on your indus-

try, on jobs, and on economic development opportunities that would be created for this state," he concluded.


# **Operation Safe Speed Takes Aim at Drivers**

Unless you have never picked up a newspaper, listened to the radio, or turned on the television in the last several months, you know about Operation Safe Speed. The AHTD, its Arkansas Highway Police Division, and the Arkansas State Police are working together to reduce average speeds on Arkansas highways.

Operation Safe Speed was announced March 13 in a news conference at the Highway Police inspection station just north of Mayflower on Interstate 40. AHTD Director Dan Flowers and High-

way Police Chief Randy Reed were joined by John Bailey, Director of the Arkansas State Police; Jane Wilson, Chief of Administration and Public Affairs; Bill Richardson, Arkansas Division Administrator of the Federal Highway Administration; Pulaski County Sheriff Randy Johnson; Faulkner County Sheriff Bob Blankenship and several other officials.

By all accounts, the Operation has been a success. Since March 13, Highway Police officers have written 8,266 tickets, averaging

20 a week. Media outlets around the state have alerted the public to the emphasis on speed enforcement and the need to drive safely—and more slowly.

"We've seen a decrease in speed statewide," said Reed. "The State Police have seen much the same results as we have. We've worked several joint operations with them that have proven to be very successful."

Operation Safe Speed was sparked by a recent AHTD report showing that most motorists are exceeding the posted speed limit on Arkansas highways. As a result, the state is not in compliance with federal regulations concerning speed limits.

The report, which covers the rst quarter of Federal fiscal year 1995 (October 1 to December 31, 1994), was submitted recently to the Federal Highway Administration.

Increasing speed leads to increasing safety concerns:

• From 1990 to 1993, there have been 761 speed-related fatalities in Arkansas.

• Some 3,043 Arkansans were injured in 1993 in accidents where speed was a contributing factor.


"Our officers see the aftermath of too many accidents that result from speeding," said Reed. "It's vital that drivers pay careful attention to speed limits."

While excessive speeding is not as significant on rural interstates, average speeds have risen dramatically on urban interstates and rural two-lane highways:

- The average speed on rural two-lane highways is 58 mph, up from 54.5 mph in 1988.
- The average speed on urban interstates is 62 mph, up from 59.5 mph in 1988.

"We're seeing initial success in lowering highway speeds," said Flowers. "That translates directly into fewer accidents and fewer fatalities."

### New Highways Dedicated at Trumann

State Highway Commissioner J.W. "Buddy" Benafield, AHTD Director Dan Flowers, District 10 Engineer Joe Barnett, and other officials were on hand May 4 to dedicate two new highways in the Poinsett County town of Trumann.

Trumann's Main Street was taken into the state highway system as State Highway 198, connecting the access road along new Highway 63 with downtown Trumann. New State Highway 214 connects the access road to the industrial park area.

"Many of you may have been present back in October when we dedicated the fine new section of Highway 63," said Benafield. "...But even the best highway is useless without good access. With the dedication of Highway 198 and

Highway 214, the people of Trumann can get to and from Highway 63 more easily. Businesses will see improved traffic flow and easier customer access. Industries will find it easier to drive large trucks across town."

A ribbon cutting for the new highways was followed by a luncheon at Trumann Country Club. Benafield and Flowers explained the benefits of the proposed highway bond program to the audience of 50, including Senator Jerry Bookout and Representative Bobby Wood of Jonesboro, Representative Jack Critcher of Grubbs, area mayors and chamber representatives, and Richard Baughn, contractor on Highway 214.

"The bottom line is, if we want to expand or speed up highway construction in Arkansas, we'll have to find additional revenues," Benafield told the audience. "The answer that the Governor and the Highway Commission have come up with is a highway construction program financed through the sale of bonds."

Benafield added that the traditional 70/15/15 split would be used for revenue from the new motor fuels and sales taxes in the program, giving cities and counties 15 percent each of the new revenue. Poinsett County would receive an additional \$160,000 annually to address needs on county roads, while Truman would receive more than \$55,000 annually.

### Plaque Unveiled on New Highway 41 Bridge

About 100 people gathered May 17 to unveil a bronze plaque at the new Highway 41 bridge on the Red River in honor of longtime legislator Marion Crank. Highway Commissioner John "M" Lipton and AHTD Director Dan Flowers were among the officials on hand for the unveiling.

While the Commission does not officially name highways or

structures, the Little River Chamber of Commerce and other area leaders chose to honor Crank with a plaque at the bridge. Lipton and Flowers spoke at the ceremony along with Senator Wayne Dowd of Texarkana, Representative Barbara Horn of Foreman, Little River County Judge Clyde Wright, and Ken Cowling, President of the Little River Chamber of Commerce. The honoree's widow, Mary Pauline "Polly" Crank, un-

"It's a bittersweet day as we gather here to name this new bridge in his honor," said Lipton. "It was just a few months ago when we gathered in Ashdown for Marion Crank Day. I'm glad that we were able to show Marion the plaque bearing his name.

"Governor Tucker also came to salute Marion that day," Lipton continued. "The Governor told him, 'You are a builder, not just of Little River County, but of the whole state.' I could not agree more."

The ceremony was followed by a luncheon at the Marion H.

Marion Crank's long career of public service included his years in the State House of Representatives from 1951 to 1968. Crank served as Speaker of the House from 1963 to 1965, and majority leader in 1967 and 1968. After losing to Winthrop Rockefeller in the 1968 gubernatorial race, he returned to private business and was instrumental in securing the cement plant for Foreman. He also worked with the Association of Arkansas Counties, the Southwest Arkansas Planning and Development District, and the Southwest Arkansas Water District.

Crank died December 19, 1994, the same day the Highway 41 bridge was opened to traffic. Flowers talked about the benefits of the bridge. "The project will improve safety and convenience on the highway from Foreman to New Boston, Texas. It will keep western Little River County in the flow of commerce," Flowers told the crowd. "It is appropriate that we dedicate this bridge to Marion Crank, who devoted his life to the future of his hometown, his county, and his state."


The new Red River bridge is part of a project which involves replacing two bridges and rehabilitating one bridge in the Red River area. A \$5.3 million contract for the work was awarded in November 1992 to Jensen Construction Company of Des Moines, Iowa. This is a joint project between AHTD and the Texas Department of Transportation, and should be complete by fall.
