CHARACTERISTICS OF WORK

This position is responsible for the setup, drilling, sampling, and document preparation for subsurface investigation units.

EXAMPLES OF WORK

The following examples are intended only as illustrations of various types of work performed. No attempt is made to be exhaustive. Related, similar, or other logical duties are performed as assigned. The Department may require employees to perform functions beyond those contained in job descriptions. The Department may modify job descriptions based on Department needs. The Arkansas Department of Transportation is an "at will" employer.

- Drive tandem axle water truck on highway and off-road.
- Perform daily maintenance on drill rigs and vehicles.
- Troubleshoot and perform mechanical repairs in the field.
- Inspect the drill site for safety concerns.
- Confirm utility positive response.
- Inspect construction plans to confirm correct station and offset.
- Survey drill hole locations for elevation.
- Select appropriate drill tooling.
- Adjust and maintain drill tooling.
- Operate drill rig.
- Prepare field documentation of samples.
- Adjust recycle water viscosity with chemical additives.
- Prepare samples for transport.
- Provide technical assistance, mentoring and training to lesser-experienced personnel as needed.
- Act as geotechnical crew coordinator in the absence of the Party Chief.

MINIMUM REQUIREMENTS

Education and experience:

The educational equivalent to a diploma from an accredited high school. Experience in drill rig or soil sampling operations.

Knowledge, skills and abilities:

Ability to read and speak the English language sufficiently to converse with the general public, to understand highway traffic signs and signals in the English language, and to respond to official inquiries, and to make entries on reports and records. Working knowledge of reading construction plans, surveying, soil classification, sampling equipment, and geotechnical drill rig operation. Ability to train others. Ability to safely and efficiently set up and operate every drill rig in the ARDOT Materials Division fleet. Ability to accurately log soil and rock formations. Ability to coordinate all geotechnical crew activities in the absence of the Party Chief.

Physical requirements:

Ability to lift and carry 50 pounds with or without reasonable accommodation.

Working conditions:

Constant statewide travel.
