MINUTES OF THE MEETING OF THE ARKANSAS STATE HIGHWAY COMMISSION

March 16, 2022

Following is the record of proceedings of the Arkansas State Highway Commission in Little Rock, Arkansas, March 16, 2022. Members present were:

2022-028

IT IS ORDERED that a meeting of the Arkansas State Commission be opened at 10:00 a.m., March 16, 2022.

2022-029

WHEREAS, the Purchasing Committee has awarded purchases on February 7, February 17, and March 8, 2022 in the amounts of \$111,837.60, \$1,896,372.12 and \$4,672,319.33, respectively, totaling \$6,680,529.05, and supply and service contracts, in accordance with authority previously conveyed, all of which have been documented by official minutes which are of record in the files of the Commission and Equipment and Procurement Division.

NOW THEREFORE, IT IS ORDERED that the action of the Purchasing Committee be ratified and confirmed in all particulars.

WHEREAS, the Pavement Surface Properties Consortium, supported by the Federal Highway Administration, has created a pooled fund study for Managing the Pavement Properties for Improved Safety; and

WHEREAS, the goal of this pooled fund study is to support the implementation of asset management approaches and tools that help improve roadway safety by reducing the number of crashes; and

WHEREAS, the study recommendations will serve as a valuable resource for the Department.

NOW THEREFORE, the Director is authorized to participate in this pooled fund effort and enter into necessary agreements to fulfill the Department's commitment.

2022-031

WHEREAS, Act 884 of the 2021 Regular Session of the 93rd General Assembly of the State of Arkansas amended the Transportation-Related Research Grant Program to include transportation-related workforce development; and

WHEREAS, the purpose of the Transportation-Related Research and Workforce Development Grant Program (TRRWDGP) is to support the study of transportation materials and to support industry training, apprenticeships, and educational programs that foster skills required for transportation related personnel development; and

WHEREAS, the Arkansas Highway Commission passed Minute Order 2021-059, which promulgated rules for administering this program as required by Act 884 and authorized the Director to implement the TRRWDGP.

NOW THEREFORE, the Director is authorized to advertise for TRRWDGP applications annually, as funds become available, in accordance with the Arkansas Legislative Council's approved promulgated rules.

WHEREAS, it is necessary for the Department to provide timely project management services for alternative delivery projects in order to proceed with construction; and

WHEREAS, on-call contracts have been found to be an effective method of providing timely and efficient project management services and supplementing in-house capabilities.

NOW THEREFORE, the Director is authorized to request and evaluate proposals and enter into any necessary contracts and agreements with firms for on-call Alternative Delivery services on assigned projects for calendar years 2022 through 2026.

WHEREAS, Title 23 U.S.C. 109(d) provides that States may erect Specific Service Signs within the interstate and highway rights of way which display information for business establishments offering goods and services in the interest of the traveling public; commonly referred to as Logo Signs in accordance with MUTCD guidelines; and

WHEREAS, Minute Order 79-353 authorized the Director to erect Logo Signs on the State's rural highway and interstate systems that would provide specific information concerning motorist services; and

WHEREAS, local jurisdiction continue to request the installation of Logo Signs along urban interstates and highways; and

WHEREAS, Logo Signs are available for eligible gas, food, lodging, camping and attraction businesses along fully-controlled access interstates and highways.

NOW THEREFORE, the Director is authorized to install Logo Signs for eligible gas, food, lodging, camping, and attraction businesses on existing Arkansas interstates and highways and any future interstates and highways added to the system.

WHEREAS, Act 1 of the 90th General Assembly's Third Extraordinary Session established the Arkansas Highway Improvement Plan of 2016, which provides funding for highway construction; and

WHEREAS, a portion of Act 1 funding includes 25 percent of State Surplus funds; and

WHEREAS, the amount of the State Fiscal Year 2019 State Surplus funds exceeded projections, which resulted in additional funding being made available for highway improvements beyond what was anticipated; and

WHEREAS, Minute Order 2020-004 authorized the use of up to \$15 million in Act 1 Surplus funding from State Fiscal Year 2019 State Surplus funds for projects that promote economic development and economic competitiveness; and

WHEREAS, the Arkansas Economic Development Commission has requested funds from the State Fiscal Year 2019 State Surplus balance to support

infrastructure improvements to handle an increase in traffic volume associated with economic development along Highway 70 in North Little Rock; and

WHEREAS, this request meets criteria established by Minute Order 2020-004.

NOW THEREFORE, upon receipt of a letter of support from Governor Asa Hutchinson, the Director is authorized to commit an amount to be determined from the State Fiscal Year 2019 State Surplus funds for infrastructure improvements along Highway 70 in North Little Rock as requested by the Arkansas Economic Development Commission and to enter into any necessary agreements with the appropriate local agencies to implement these improvements.

WHEREAS, the existing District 6 Headquarters in Little Rock was constructed in 1963 and is inadequate in both property size (9.9 acres) and facility size and condition; and

WHEREAS, the District Bridge Crew and the District Sealing Crew are located away from District 6 Headquarters at two of the Area Maintenance Headquarters; and

WHEREAS, ARDOT acquired a suitable property (54.0 acres) located at 11006 Baseline, Little Rock, Arkansas 72209, adjacent to the Maintenance Division, to be used for new District 6 Headquarters.

NOW THEREFORE, the Director is authorized to procure the services of an Architectural/Engineering firm and proceed with the design and construction of the new District 6 Headquarters including buildings, appurtenances, fencing, and related items as funds become available.

Work to be done by contract as a Building Project.

WHEREAS, the Tennessee Department of Transportation (TDOT) completed the Mississippi River Crossing Feasibility and Location Study in 2006; and

WHEREAS, the study explored the feasibility of providing a new Mississippi River Bridge Crossing in the Memphis metropolitan area and evaluated possible transportation solutions to help determine a preferred corridor alternative for proposed improvements for cross river mobility over the Mississippi River; and

WHEREAS, TDOT has expressed interest in partnering with the Department to conduct an update to this study.

NOW THEREFORE, the Director is authorized to enter into an agreement with the Tennessee Department of Transportation to participate in an update of the Mississippi River Crossing Feasibility and Location Study.

WHEREAS, IN INDEPENDENCE COUNTY, IN THE CITY OF BATESVILLE local officials have expressed concern about the traffic flow within the City; and

WHEREAS, Minute Order 2008-163 adopted the <u>Batesville Bypass Feasibility</u> <u>Study</u> as a planning guide for future improvements in the area; and

WHEREAS, an update to this study is necessary to accurately evaluate the current transportation needs in the Batesville area.

NOW THEREFORE, the Director is authorized to update the <u>Batesville Bypass</u> <u>Feasibility Study</u> to reassess the need for and feasibility of a bypass around Batesville.

2022-038

WHEREAS, it has been determined that improvements are warranted to enhance safety at the five railroad crossings indicated on the attached list; and

WHEREAS, these improvements are eligible for Federal-aid Rail-Highway Crossing Safety funds; and

WHEREAS, local officials and a railroad company have indicated their willingness to provide matching funds for the off-system railroad crossings.

NOW THEREFORE, the Director is authorized to proceed with improvements at these crossings as funds become available subject to the following conditions:

• Maintenance of the signals and surfaces shall be performed by the applicable Railroad Company at no cost to the State.

• All required right-of-way shall be furnished at no cost to the State.

WHEREAS, the Department has entered into a Design-Build Agreement for design and construction of Job CA0602, otherwise known as "Phase 1 - 30 Crossing"; and

WHEREAS, the project scope included in the executed Design-Build Agreement for "Phase 1 - 30 Crossing" does not include the removal and reconstruction of the direct connector between westbound Interstate 30 and westbound Interstate 630 or the connection from the southbound frontage road to westbound Interstate 630 ("Additional Phase 1 Scope"); and

WHEREAS, it has been determined that incorporating the Additional Phase 1 Scope will positively impact the cost, time, road user impacts, and safety of the overall project and will be in the public's best interest; and

WHEREAS, a proposed change order has been negotiated with the Design-Build contractor for this Additional Phase 1 Scope; and

WHEREAS, the Federal Highway Administration has acknowledged their concurrence with this proposed change.

NOW THEREFORE, the Director is authorized to Proceed with a Change Order to amend the Design-Build Agreement to incorporate the Additional Phase 1 Scope work into the current "Phase 1 - 30 Crossing" project.

WHEREAS, IN BENTON COUNTY, IN THE CITY OF GENTRY, Job 090651 is programmed to improve the intersection of Highway 12 and Highway 59; and

WHEREAS, through Resolution No. 21-652, the City of Gentry has offered to partner with the Department to construct improvements at this intersection by providing \$250,000 towards construction of this project.

NOW THEREFORE, the Director is authorized to enter into any necessary agreements with the City and to proceed with surveys, plans, and construction of the improvements as funds become available.

WHEREAS, IN MISSISSIPPI COUNTY, the Department has been informed of a planned economic development project that will construct a new steel mill south of Osceola along Highway 119, Section 1; and

WHEREAS, to expedite construction, Mississippi County has requested ownership of Highway 119, Section 1; and

WHEREAS, the developer and Mississippi County have committed to ensuring that property access for all landowners is maintained; and

WHEREAS, the Department has determined that this transfer of ownership is practical and will not adversely impact the State Highway System or the traveling public.

NOW THEREFORE, IT IS ORDERED, that upon official notification by the Deputy Director and Chief Engineer, Highway 119, Section 1 is hereby removed from the State Highway System as shown on the attached sketch.

WHEREAS, a thorough bid review and analysis is undertaken by the Department to ensure that only those projects are awarded which are judged to be in the best interests of the State; and

WHEREAS, the right is retained to reject any or all proposals, to waive technicalities, or to advertise for new proposals, also as judged to be in the best public interests of the State; and

WHEREAS, the Commission desires to expedite work on these important projects; and

WHEREAS, in accordance with Amendment 42 of the Arkansas Constitution, Section 6, as well as other laws of this State, the Commission has the authority to delegate certain powers to the Director of Highways and Transportation.

NOW THEREFORE, upon the contractors furnishing the necessary performance and payment bonds and submitting all additional information required for the above mentioned projects, the Director is hereby authorized to enter into contracts and supplemental agreements for any projects deemed to be in the best interests of the State.

FURTHERMORE, the Director is authorized to reject any or all proposals, to waive technicalities, and/or to advertise for new proposals whenever deemed to be in the best interests of the State.

Chairman Moore opened the meeting by welcoming those in attendance inperson, as well as those who were watching online.

MOTIONS

MOTION

Vice Chairman Alec Farmer moved, Commissioner Philip Taldo seconded and the motion passed to authorize the use of electronic signatures for the March 16, 2022 Minute Orders.

MOTION

Vice Chairman Alec Farmer moved, Commissioner Philip Taldo seconded and the motion passed to approve the Minutes from the February 2, 2022 Commission Meeting.

MOTION

Commissioner Philip Taldo moved, Commissioner Marie Holder seconded and the motion passed to authorize the Department to prepare and submit the Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grant application for the Highway 5 (Highway 183 to the Saline County Line) project in Saline County.

MOTION

The Commission authorized the Department to advertise for consultant services for evaluation of the Department's Bridge Inspection

Program in May 2021. Commission Keith Gibson moved, Commissioner Marie Holder seconded and the motion passed to accept the Staff's recommendation to enter into negotiations to provide an evaluation of the Department's Bridge Inspection Program with the following firm:

Michael Baker International, Inc. – Pittsburgh, Pennsylvania

MOTION

The Commission authorized the Department to advertise for consultant services for On-Call Bridge Inspection services for 2022-2026. Commission Keith Gibson moved, Commissioner Marie Holder seconded and the motion passed to accept the Staff's recommendation to enter into negotiations to provide On-Call Bridge Inspection services for 2022-2026 with the following firms:

Burgess & Niple, Inc. – Columbus, Ohio CONSOR Engineers, LLC – Edmond, Oklahoma Garver, LLC – North Little Rock, Arkansas HNTB Corportation – Plano, Texas Michael Baker International – Little Rock, Arkansas Modjeski and Masters, Inc. – New Orleans, Louisiana Volkert, Inc. – Little Rock, Arkansas

OTHER DISCUSSION ITEMS

Patrick Patton, Chief Fiscal Officer, provided the February 2022 update on State Highway Revenue. Mr. Patton noted that State Highway Revenues to the Department from traditional sources are up a total of 5.2% (\$14.1 million) in State Fiscal Year (SFY) 2022 compared to SFY 2021. Revenue from the Natural Gas Severance Tax is higher this year compared to last year. Total revenues available are 12.5% (\$34.7 million) above last year. Actual State Revenue received is 10.5% (\$29.6 million) above projected (budgeted) revenue for this year. Mr. Patton stated that February revenue from the 0.5% General Sales Tax for the Connecting Arkansas Program was -1.89% lower, (-\$350,007) than projected by the Department of Finance and Administration (DF&A) for the month. Year to date actual revenue is above projections by 2.78% (\$4,427,619). Since inception, this revenue source is 1.78%, or \$28.9 million, above DF&A's projections.

Kevin Thornton, Assistant Chief of Administration, updated the Commission on the status of Federal Highway and Transit funding issues. Since the February 2 meeting,

Congress has taken several actions regarding Federal funding for transportation. Two Continuing Resolutions were passed to keep the government operating and an Appropriation Bill was passed and signed by the President. This bill provides funding for the reminder of Federal Fiscal Year 2022, which will end on September 30. This Appropriation Bill provides full funding for the Infrastructure Investment and Jobs Act (IIJA) including an increase in formula funding and various new programs. It also provides full funding for the various grant programs. During FFY 2022, Arkansas will receive an increase of approximately \$189 million from the IIJA. Of this amount, approximately \$34 million is sub-allocated to urban and non-highway funding, leaving the remaining \$155 million in FFY 2022 for highway construction. Another significant change to the transportation funding includes Community Project Funding or Congressionally Directed Spending Projects, formerly referred to as earmarks. There is \$59 million for projects in Arkansas. The Community Project Funding or Congressionally Directed Spending Projects included in the Appropriation Bill include the following:

- \$18 million for Future I-49 requested by Senator Boozman and Congressman Womack
- \$18 million for US Highway 67 requested by Senator Boozman
- \$18 million for Future I-69 requested by Senator Boozman
- \$5 million for Future I-57 requested by Senator Boozman

Director Tudor provided an update on the Arkansas Legislative Council Efficiency Study Recommendations Rules for Implementation. At the February 2 meeting, the Commission authorized the submission to revise of Rule 6, which deals with the implementation of Construction Contractor Performance Measurement. In this revision, two members of the highway construction industry will serve as representatives on the Contractor Performance Evaluation Committee. Due to the 93rd General Assembly – Fiscal Session 2022, the Highway Commission Review and Advisory Subcommittee did not meet, and is currently scheduled to resume in April.

Director Tudor updated the Commission on recent Department activities. Since the February 2 meeting, several noteworthy Department activities occurred as listed below:

- Director Tudor was named by Governor Asa Hutchinson to the Arkansas Council on Future Mobility;
- Director Tudor and Staff attended a partnering workshop in Rogers, AR, with the Arkansas Asphalt Paving Association;
- Director Tudor attended the Southern Association of State Highway and Transportation Officials (SASHTO) Board of Director's Retreat in Jackson, MS;
- Director Tudor and Staff attended the American Association of State Highway and Transportation Officials (AASHTO) Washington Briefing in Washington, DC;

- Director Tudor continued her work on the Infrastructure Planning Advisory Committee; and
- Director Tudor and Staff participated in the On-Call CM/GC Industry Workshop, held virtually.

Director Tudor presented a list of upcoming meetings and events that the Director and Commission will be attending.

Rita Looney, Chief Legal Counsel at ARDOT provided an update to the current lawsuits that challenged the spending of Amendment 91 and Amendment 101 funds. Ms. Looney also updated the status of the current NEPA case for the 30 Crossing Project.

In closing, Director Tudor recognized Commissioner Marie Holder, who was recently appointed by Governor Hutchinson to the Arkansas Commission on the Status of Women. Director Tudor also recognized Chairman Robert Moore for his recent recognition in the OuachitaCircle publication of Ouachita Baptist University. Chairman Moore was presented the Distinguished Alumni Award in August 2021.
