IT IS ORDERED that a meeting of the Arkansas State Highway Commission be opened at 10:00 a.m., April 27, 2022.

#### 2022-045

WHEREAS, the Purchasing Committee has awarded purchases on April 1, and April 13, 2022, in the amounts of \$1,862,597.11, and \$427,000.00, respectively, totaling \$2,289,597.11, and supply and service contracts, in accordance with authority previously conveyed, all of which have been documented by official minutes which are of record in the files of the Commission and Equipment and Procurement Division.

NOW THEREFORE, IT IS ORDERED that the action of the Purchasing Committee be ratified and confirmed in all particulars.

#### 2022-046

WHEREAS, the National Academy of Sciences, Engineering and Medicine Transportation Research Board (TRB) provides leadership in transportation innovation and progress through research and information exchange, conducted within a setting that is objective, interdisciplinary, and multimodal; and

WHEREAS, the TRB offers opportunities for information exchange on current transportation research and practice, management of cooperative research and other research programs, analyses of national transportation policy issues, guidance on federal and other research programs, and publications and access to research information from around the world; and

WHEREAS, all states provide financial support for TRB's Core Program activities that are designed to support dialogue and information exchange among researchers, practicing transportation professionals, and others concerned with transportation; and

WHEREAS, the Department's participation rate has been approved by the TRB Executive Committee; and

WHEREAS, the Federal Highway Administration has created a pooled fund study to provide a mechanism for state transportation departments to support the TRB's Core Program activities; and

WHEREAS, the TRB's Core Program activities are regarded as highly beneficial to the Department in order to exchange ideas, information, and best practices with other agencies.

NOW THEREFORE, the Director is authorized to participate in this pooled fund effort and to enter into such agreements as necessary to fulfill the Department's commitment to this important program for TRB Fiscal Year 2023.

WHEREAS, Act 298 of 2019 required the Arkansas Legislative Council to conduct a study of the processes and functioning of the Arkansas Department of Transportation to identify areas of potential improvement within the overall functioning of the Department; and

WHEREAS, the final report produced from the study was adopted by the Arkansas Legislative Council on November 20, 2020; and

WHEREAS, a recommendation contained within the final report identified an opportunity to improve existing communication with regard to construction projects and maintenance activities in order to enhance public visibility, project performance, and project delivery; and

WHEREAS, enhancement of the Department's website to publish up to date information with regard to construction projects and maintenance activities will provide the desired improved communication.

NOW THEREFORE, the Director is authorized to issue a Request for Proposals to retain the services of a qualified consultant to enhance communication through the Department's website with regard to construction projects and maintenance activities for the Department.

WHEREAS, the Arkansas Strategic Highway Safety Plan (2017) (SHSP) identified Traffic Incident Management (TIM) as a primary emphasis area; and

WHEREAS, TIM provides significant benefits to our transportation system by safely and efficiently clearing traffic incidents; and

WHEREAS, the SHSP also identified the need to continue TIM training for responders as a priority safety strategy; and

WHEREAS, a training facility to allow consistent and continual TIM training for Arkansas Highway Police Officers and various responders in Arkansas is highly beneficial.

NOW THEREFORE, the Director is authorized to partner with the Arkansas State Police to assist in construction of a TIM training facility as funds become available.

WHEREAS, IN PULASKI COUNTY, the Institutional Drive System maintained by the Department at the Arkansas Department of Corrections – Wrightsville Unit was recently reviewed; and

WHEREAS, an existing drive no longer meets the criteria for inclusion into the State Maintenance System as established by Commission Policy 4201 on August 2, 1961; and

WHEREAS, there are additional roads that meet all the criteria for inclusion in the State Maintenance System.

NOW THEREFORE, IT IS ORDERED, that upon official notification by the Deputy Director and Chief Engineer, drives totaling 0.870 miles, as shown on the attached sketch, are hereby to be maintained by the Department as State Highway 834, Section 1.

WHEREAS, a thorough bid review and analysis is undertaken by the Department to ensure that only those projects are awarded which are judged to be in the best interests of the State; and

WHEREAS, the right is retained to reject any or all proposals, to waive technicalities, or to advertise for new proposals, also as judged to be in the best public interests of the State; and

WHEREAS, the Commission desires to expedite work on these important projects; and

WHEREAS, in accordance with Amendment 42 of the Arkansas Constitution, Section 6, as well as other laws of this State, the Commission has the authority to delegate certain powers to the Director of Highways and Transportation.

NOW THEREFORE, upon the contractors furnishing the necessary performance and payment bonds and submitting all additional information required for the above mentioned projects, the Director is hereby authorized to enter into contracts and supplemental agreements for any projects deemed to be in the best interests of the State.

FURTHERMORE, the Director is authorized to reject any or all proposals, to waive technicalities, and/or to advertise for new proposals whenever deemed to be in the best interests of the State.

#### 2022-056

WHEREAS, IN HEMPSTEAD COUNTY, the feasibility of constructing a Highway 278 bypass of Washington State Park has been studied; and

WHEREAS, the Arkansas State Parks, Recreation and Travel Commission passed a motion at their April 22, 2022 meeting requesting that the Department update the study.

NOW THEREFORE, the Director is authorized to update the Highway 278 Bypass Feasibility Study to reassess the need for and feasibility of a bypass around Historic Washington State Park.

Chairman Moore opened the meeting by welcoming those in attendance in-person, as well as those who were watching online. Chairman Moore stated that the use of electronic signatures on Minute Orders would be used, as has been done in previous meetings.

## **MOTIONS**

**MOTION** 

Vice Chairman Alec Farmer moved, Commissioner Philip Taldo seconded, and the motion passed to approve the Minutes from the March 16, 2022, Commission Meeting.

Commissioner Keith Gibson moved, Commissioner Philip Taldo seconded, and the motion passed to submit an application for the Future I-49 Project, Highway 22 to I-40 in Sebastian and Crawford Counties for the Multimodal Project Discretionary Grant program.

**MOTION** 

The Commission approved Minute Order 2021-057 on July 28, 2021, authorizing the Department to request proposals, select consulting firms and enter into any necessary contracts and agreements with firms for safety studies and engineering services for Federal Fiscal Years 2022-2024. Commissioner Keith Gibson moved, Vice Chairman seconded, and the motion passed to accept the Staff's recommendation to enter into negotiations to provide On-Call Safety Studies with the following firms:

Burns McDonnell Engineering Company, Inc. – Springdale, AR Garver, LLC – North Little Rock, AR Halff and Associates, Inc. – Little Rock, AR Olsson, Inc. – Fayetteville, AR

### OTHER DISCUSSION ITEMS

Arkansas Highway Police (AHP) First Lieutenant Brad Perkins gave an informational presentation on the Traffic Incident Management (TIM) Program and the partnership with the Arkansas State Police (ASP). The TIM program is designed to establish consistent training for all responders. The National Unified Goal (NUG) has three major objectives – responder safety; safe, quick clearance; and prompt and reliable communication. The TIM program is designed for responders of all disciplines, which include communications, emergency management, emergency medical services, fire and rescue, law enforcement, towing and recovery, and transportation/public works. The TIM program provides training for safe and quick clearance of the roadway during an accident, reducing the risk for secondary crashes and reducing the economic impact to the traveling public. 1st Lt. Perkins also noted that the TIM program allows the AHP to work with other agencies and entities to help them to understand how work zones are laid out and how to set up accidents in the same manner of a work zone. The TIM facility at Camp Robinson in North Little Rock provides a safe and controlled environment in which to simulate

various scenarios. The proposed TIM building would provide adequate office and classroom space for agencies to utilize. Currently, the average number of minutes of a lane closure due to a crash is 42 minutes, which is dropped from 101 minutes in 2018. The number of trained responders in 2021 is over 3,500 compared to 450 in 2018. As the TIM center is utilized more, these numbers are expected to continue to improve. The Commission, with a verbal vote, unanimously agreed to approve the proposed Minute Order, authorizing the Director to partner with the ASP to provide funding for this facility.

Patrick Patton, Chief Fiscal Officer, provided the March 2022 update on State Highway Revenue. Mr. Patton noted that State Highway Revenues to the Department from traditional sources are up a total of 5.4% (\$16.7 million) in State Fiscal Year (SFY) 2022 compared to SFY 2021. Revenue from the Natural Gas Severance Tax is higher this year compared to last year. Total revenues available are 12.4% (\$38.9 million) above last year. Actual State Revenue received is 10.3% (\$32.8 million) above projected (budgeted) revenue for this year. Mr. Patton stated that March revenue from the 0.5% General Sales Tax for the Connecting Arkansas Program was 16.91% higher, (\$3,349,666) than projected by the Department of Finance and Administration (DF&A) for the month. Year to date actual revenue is above projections by 4.35% (\$7,777,286). Since inception, this revenue source is 1.96%, or \$32.2 million, above DF&A's projections.

Kevin Thornton, Assistant Chief of Administration, updated the Commission on the status of Federal Highway and Transit funding issues. On March 15, 2022, spending authority for Federal Fiscal Year 2022 was enacted. This agreement provides full funding for FFY 2022 and has allowed Staff to turn their full attention to implementing the benefits of the IIJA and to begin preparing for FFY 2023. Staff is currently doing so by responding to requests from Congress for recommendations for projects that will receive additional funding, which are called Community Funded Projects. The following projects have been recommended to Congress for inclusion in next year's appropriation bill:

- Highway 67 (Future I-57), Walnut Ridge Missouri State Line Up to \$100 million;
- Highway 412 Corridor, Selected Section Corridor Improvements Up to \$500 million;
- Highway 60, Arkansas River West Up to \$30 million;
- On New Location, Northwest Arkansas National Airport Access Up to \$60 million:
- Highway 270, Ouachita River Fleetwood Drive Up to \$20 million;
- Future I-49, Highway 22 Interstate 40 Up to \$600 million.

Mr. Thornton also noted that the US Department of Transportation has published a list of anticipated dates for when they will announce guidance for the IIJA Grant programs. Staff will be studying these announcements closely to ensure that the Department applies for any eligible grants.

Jared Wiley, Assistant Chief Engineer – Planning, briefed the Commission on the Multimodal Project Discretionary Grant Opportunity (MPDG). The MPDG combines three IIJA Grant programs into a single application to provide a more efficient application process. A single application can be considered for all three programs if it meets the criteria requirements. The three grant programs are;

- Mega Grants (new program)
  - Supports large, complex projects that are difficult to fund by other means and likely to generate national or regional economic, mobility, or safety benefits;
  - o \$1 billion for FFY 2022
- Infrastructure for Rebuilding America (INFRA)
  - Supports projects for multimodal freight and highway projects of national or regional significance to improve the safety, efficiency, and reliability of the movement of freight and people in and across rural and urban areas:
  - o \$1.55 billion for FFY 2022
- Rural Surface Transportation or RURAL Grants (new program)
  - The RURAL Grant Program supports projects to improve and expand the surface transportation infrastructure in rural areas to increase connectivity, improve the safety and reliability of the movement of people and freight, and generate regional economic growth and improve quality of life;
  - o \$300 million for FFY 2022.

One project, with the assistance of a consultant, was selected as the best candidate project in which to prepare and submit an application for consideration:

- Future I-49, Highway 22 I-40 in Sebastian and Crawford Counties
  - Will construct a four-lane interstate facility on new location with a bridge crossing of the Arkansas River

- Total current estimated total project cost is \$925 million
- o Project will be delivered in phases as funding allows

A motion was made and seconded and passed unanimously to submit an application for this project in the MPDG program.

Director Tudor provided an update on the Arkansas Legislative Council Efficiency Study Recommendations Rules for Implementation. On April 21, the first monthly report was submitted the Highway Commission Review and Advisory Subcommittee (HCRAS). This report included the revision to Recommendation Rule #6, which was approved by the Commission on February 2. During this meeting on April 21, both the monthly update and the revision to Recommendation Rule #6 were presented with no questions.

Director Tudor updated the Commission on recent Department activities. Since the March 16 meeting, several noteworthy Department activities occurred as listed below:

- Director Tudor continued her work on the Infrastructure Planning Advisory Committee;
- Director Tudor conducted a General Staff Meeting for all Executive Staff, Division Heads and District Engineers.
- Director Tudor and Commissioner Marie Holder participated in a media event for the announcement of the purchase of seven lower emission trucks using funds received from the Volkswagen settlement. Department of Energy and Environment Secretary Becky Keough also attended the event;
- Director Tudor attended the kickoff meeting of the Future Mobility Council in Rogers, AR;
- Director Tudor provided opening remarks of the Arkansas Asphalt Paving Association at their Annual Conference in Hot Springs, AR;
- Director Tudor participated in the Women in STEM Conference, hosted by ARDOT in North Little Rock, AR;
- Director Tudor attended the National Council of Examiners for Engineering & Surveying as a delegate for the Central/Southern Zone joint interim meeting in Oklahoma City, OK.

Director Tudor presented a list of upcoming meetings and events that the Director and Commission will be attending.

In closing, Director Tudor recognized the 30 Crossing Litigation team and presented them with the FHWA Administrator's Excellence in Teamwork Award. ARDOT Staff that was recognized were Rita Looney, Chief Legal Counsel; Mark Umeda, Staff Attorney; and Keli Wylie, Alternative Project Delivery Administrator. Director Tudor also notified the Commission that ARDOT recently received Arkansas Engineering Excellence Award from the American Council of Engineering Companies (ACEC) for the Hernando DeSoto Bridge Emergency Repairs. This award was recognized under the large category, structural systems and was submitted by the engineering firm Michael Baker International.
