IT IS ORDERED that a meeting of the Arkansas State Highway Commission be opened at 10:00 a.m., July 27, 2022.

2022-070

WHEREAS, the Purchasing Committee has awarded purchases on June 9, June 10, June 29, and July 14, 2022, in the amounts of \$223,930.00, \$1,684,685.91, \$372,917.76 and \$59,800.00, respectively, totaling \$2,341,333.67, and supply and service contracts, in accordance with authority previously conveyed, all of which have been documented by official minutes which are of record in the files of the Commission and Equipment and Procurement Division.

NOW THEREFORE, IT IS ORDERED that the action of the Purchasing Committee be ratified and confirmed in all particulars.

WHEREAS, the Department relies on our fleet of vehicles and equipment to assist in fulfilling our mission of providing safe and efficient transportation solutions to support Arkansas' economy and enhance the quality of life for generations to come; and

WHEREAS, efficient management of our fleet requires replacement of certain vehicles and equipment at or near the time when operational costs surpass their remaining value; and

WHEREAS, through public auctions, the Department realizes the remaining value of these vehicles or equipment; and

WHEREAS, procurement of the services of a professional auctioneer to conduct public auctions has proven to be an effective approach to maximizing the benefit to the Department.

NOW THEREFORE, the Director is authorized to issue a Request for Proposals to retain the services of a qualified professional auctioneer to conduct public auctions for certain vehicles and equipment at or near the time when operational costs surpass their remaining value.

WHEREAS, the 93rd General Assembly of the State of Arkansas enacted Act 451 during the 2021 Regular Session, which authorized issuance of an annual permit for movement of overweight forestry equipment of up to a total gross weight of 104,000 pounds under certain conditions; and

WHEREAS, as required by Act 451 of 2021 the attached amendment to the Permit Rules for the Movement of Oversize and Overweight Vehicles on the State Highway System shall be promulgated.

WHEREAS, these memberships include the Development of AASHTO Materials Standards (DAMS); Equipment Management Technical Services Program (EMTSP); Highway Safety Policy and Management Technical Service Program (SAFETY); Load and Resistance Factor Design (LRFD) Bridges and Structures Specification Maintenance; National Transportation Product Evaluation Program (NTPEP); National Operations Center of Excellence (NOCoE); Transportation Curriculum Coordination Council (TC3); Transportation System Preservation Technical Service Program (TSP2); Transportation and Civil Engineering (TRAC) and Roadways Into Developing Elementary Students (RIDES); and Transportation Performance Management (TPM); and

WHEREAS, these programs are regarded as highly beneficial to the Department in order to exchange ideas, information, and best practices with other highway agencies.

WHEREAS, participation in this pooled fund study will ensure that the Department has access to the most current technologies and practices related to concrete pavements.

NOW THEREFORE, the Director is authorized to participate in this pooled fund effort and enter into necessary agreements to fulfill the Department's commitment.

Transportation, has created the Steel Bridge Research, Inspection, Training and Education Engineering Center (S-BRITE) pooled fund study; and

WHEREAS, participation in this pooled fund study will support improvements to Arkansas' bridge inspection program through training, education, consulting, and research centered around steel bridges that is tailored towards engineering and inspection staff; and

WHEREAS, participation also includes expert technical assistance for specific complex problems associated with steel bridges; and

WHEREAS, this pooled fund effort will serve as a valuable educational resource for the Department.

NOW THEREFORE, the Director is authorized to participate in this pooled fund effort and to enter into necessary agreements to fulfill the Department's commitment.

WHEREAS, IN PULASKI COUNTY, IN THE CITY OF LITTLE ROCK, Job CA0602 (30 Crossing) will obliterate a portion of Highway 10 and the associated ramps at the Interstate 30 Interchange; and

WHEREAS, the City of Little Rock has requested ownership and maintenance responsibility for Highway 10 (Cumberland Street) south of President Clinton Avenue and adjacent to the 30 Crossing Project; and

WHEREAS, upon completion of 30 Crossing, President Clinton Avenue will serve as a logical terminus for Highway 10 in the City of Little Rock.

NOW THEREFORE, IT IS ORDERED, that upon official notification by the Deputy Director and Chief Engineer, the portion of Highway 10, Section 8 between Cumberland Street and Interstate 30, as shown on the attached sketch, is hereby removed from the State Highway System.

FURTHERMORE, upon receipt of a proper ordinance from the City of Little Rock the ownership and maintenance responsibility for the portion of Highway 10, Section 8 (Cumberland Street) between President Clinton Avenue and 3rd Street will be transferred to the City of Little Rock, as shown on the attached sketch.

WHEREAS, IN RANDOLPH COUNTY, the City of Pocahontas has requested that the Department reallocate funding previously committed to widening Highway 90 between Park Street and Country Club Road and to provide the additional funding necessary to construct a bypass between Highway 90 and Highway 67; and

WHEREAS, through Resolution No. 17-2022, the City has offered to partner with the Department by accepting ownership and responsibility for portions of Highway 90 and Highway 115; and

WHEREAS, the City has agreed to provide \$2,000,000 for construction of the bypass.

NOW THEREFORE, the Director is authorized to enter into any necessary agreements with local agencies and to proceed with surveys, plans, and construction of the improvements as funds become available.

FURTHERMORE, IT IS ORDERED that upon completion of the proposed bypass and official notification by the Deputy Director and Chief Engineer, the following changes are hereby to be made to the State Highway System as shown on the attached sketch.

- The portion of Highway 90, Section 6 beginning at the intersection of the future bypass and continuing southwest to Highway 67 shall be removed from the State Highway System.
- Highway 115, Section 1 beginning at Highway 90 and continuing north to the proposed bypass shall be removed from the State Highway System.
- The newly constructed bypass shall be designated as part of Highway 90, Section 6.

OTHER DISCUSSION ITEMS

Patrick Patton, Chief Fiscal Officer, provided the June 2022 update on State Highway Revenue. This is the year-end report for State Fiscal Year (SFY) 2022. Mr. Patton noted that State Highway Revenues to the Department from traditional sources are up a total of 4.0% (\$17.0 million) in the SFY 2022 compared to SFY 2021. Revenue from the Natural Gas Severance Tax is higher this year compared to last year. Total revenues available are 10.4% (\$45.3 million) above last year. Actual State Revenue received is 12.0% (\$51.3 million) above projected (budgeted) revenue for this year. Mr. Patton stated that June revenue from the 0.5% General Sales Tax for the Connecting Arkansas Program was 12.29% higher, (\$2,529,359) than projected by the Department of Finance and Administration (DF&A) for the month. Year to date actual revenue is above projections by 5.96% (\$14,235,131). Since inception, this revenue source is 2.28%, or \$38.7 million, above DF&A's projections.

Jared Wiley, Assistant Chief Engineer for Planning, updated the Commission on the status of Federal Highway and Transit funding issues. The current spending authority under the IIJA for Federal Fiscal Year (FFY) 2022 is set to expire on September 30. Congress

continues to work on the Appropriations for FFY 2023. The US House has already passed an Appropriations Bill for FFY 2023, which includes an increase in funding for Transportation of \$833 million. Of this, Arkansas would receive approximately \$11 million. The House Bill includes funding for Community Project Funding, or Congressionally Directed Spending Projects. These projects, totaling \$27 million are as follows:

- Future I-57, requested by Congressman Crawford \$5 million;
- US Highway 412, requested by Congressman Crawford \$5 million;
- Future XNA Access Road, requested by Congressman Womack \$7 million;
- Future I-49, requested by Congressman Westerman \$5 million; and
- Highway 270 in Garland County, requested by Congressman Westerman \$5 million

Now that the House has passed their bill, it is up to the Senate to pass their Appropriations Bill. The Senate can add their own Community Project Funding to their bill, which would, once again, increase the amount of funding Arkansas will receive. It is expected that a Continuing Resolution will go into place at the beginning of FFY 2023 until an agreement can be reached.

Director Tudor provided an update to the Efficiency Review Recommendation Implementation. The Highway Commission Review and Advisory Subcommittee (HCRAS) met on June 16. At their meeting, there were no questions regarding the monthly progress report. The last monthly progress report was submitted on July 1; however, the HCRAS did not meet in July. The next meeting is scheduled in August and a report will be submitted to the HCRAS. Director Tudor updated the Commission on the inquiry tracking recommendation. The Department's Customer Service Oversight Committee has recommended the Department execute a contract with GovQA to provide the software and training to address this need. Due to the cost being less than \$50,000, it does not require review by the Committee and implementation of this new technology is moving forward.

Director Tudor updated the Commission on recent department activities as detailed below:

- Aaron Pinedo, Advanced Transportation Planning Engineer, and Brad McCaleb, Division Engineer of Transportation Planning and Policy provided an update and overview of the Electric Vehicle Infrastructure plan, which was presented to the Infrastructure Planning and Advisory Committee on July 18.
- Commissioner Philip Taldo, Director Tudor and Staff attended the Osage Creek Ribbon Cutting in Benton County on June 20.
- Chairman Moore, Commission Holder, Director Tudor, and Staff attended the 31st Annual Equipment Operator Roadeo finals Little Rock on June 23.

- ARDOT hosted its annual Engineering Intern Orientation at the Central Offices on July 12 – 13.
- All five members of the Highway Commission, Director Tudor and Staff attended the I-49 Policy Discussion event in Fort Smith on July 13 - 14.
- Director Tudor and Staff attended a ribbon cutting on Highway 133 in Crossett on July 20
- ARDOT District 10 personnel were able to complete a left turn lane project in Mississippi County near the Rivercrest School in time for the first day of school, which is August 16.

Director Tudor presented a list of upcoming meetings and events that the Director will be attending.
