Tier 1 Categorical Exclusion

After appropriate environmental review, it has been determined that the subject job is a Tier 1 Categorical Exclusion as described by the ARDOT/FHWA Programmatic Agreement on Categorical Exclusion Documentation and Processing. A public hearing will not be offered for this project.

This project intends to level and provide a 1" overlay for Sections 1 and 2 of Highway 255 in Sebastian County. Additionally, 2' shoulders will be added to Section 1. The project would not involve relocations, prime farmlands, wetlands, underground storage tanks, hazardous materials, any environmental justice issues, or cultural resources. This project has been determined to generate minimal air quality impacts for Clean Air Act criteria pollutants and has not been linked with any special mobile source air toxics concerns. The cultural resources clearance is attached.

The official species lists obtained through the US Fish and Wildlife Service's (USFWS) Information for Planning and Consultation identified the following species as potentially occurring within the project area: Indiana Bat (Myotis sodalis), Northern Long-eared Bat (Myotis septentrionalis), Tricolored Bat (Perimyotis subflavus), Eastern Black Rail (Laterallus jamaicensis ssp. jamaicensis), Piping Plover (Charadrius melodus), Red Knot (Calidris canutus rufa), Alligator Snapping Turtle (Macrochelys temminckii), American Burying Beetle (Nicrophorus americanus), geocarpon (Geocarpon minimum), and Monarch Butterfly (Danaus plexippus). The official species list is attached. This project would have "no effect" on the aforementioned species due to the limited scope of the action, lack of suitable habitat, and distance to known species locations.

The Tricolored Bat is currently a proposed endangered species, and the Alligator Snapping Turtle is a proposed threatened species; however, the proposed project would not jeopardize the continued existence of either species.



Sebastian County

This job proposes to conduct the following surface improvement activities along 7.38 miles of Sections 1 and 2 of Highway 255 in Sebastian County: 1" level up and overlay on both sections and add 2' shoulders to Section 1.

A records check at the Arkansas Archeological Survey found no previously recorded archeological sites located near the existing ROW along the project. No historic structures were shown on the Arkansas Historic Preservation Program's structure database eligible for inclusion or listed on the National Register of Historic Places near the project. An unidentified road is noted in Section 1 of the 1826 General Land Office (GLO) plat for T7N, 31W and was identified as "County road" on the 1829 GLO plat. The 1826 GLO plat of T8N, R30W shows a "Road from Crawford courthouse to Fort Smith" trending SW-NE south of Highway 255 in Section 31 and crossing the existing highway in the corner of Sections 28, 29, 32, and 33. No other cultural indicators were found on the 1832, 1829, 1826 GLO plats of 7N, 30W or the 1827 GLO plat of The 1936 Sebastian County road map shows a multitude of structures located along numerous roads for the project area. The 1987 7.5' Lavaca topographic map shows Highway 255 as the "Old Military Road", a carryover from the Civil War. The Lavaca and the Barling 7.5 topographic maps do not indicate any known cemeteries in the project area.

All work will be within the existing ROW in Section 1 of Highway 255, and all work will be limited to existing paved surfaces on Section 2, that contains a portion of the Military Road.

The existing road infrastructure, known construction practices, utilities, and plans were examined to assess previous ground disturbance. The current scope of the project occurs within previously disturbed areas. This type of undertaking will not affect historic properties. Therefore, this project requires no Section 106 review under Appendix C, Activity 2, of the 2021 Programmatic Agreement.

The species list fulfills the requirements of the U.S. Fish and Wildlife Service (Service) under section 7(c) of the Endangered Species Act (Act) of 1973, as amended (16 U.S.C. 1531 *et seq.*).

New information based on updated surveys, changes in the abundance and distribution of species, changed habitat conditions, or other factors could change this list. Please feel free to contact us if you need more current information or assistance regarding the potential impacts to federally proposed, listed, and candidate species and federally designated and proposed critical habitat. Please note that under 50 CFR 402.12(e) of the regulations implementing section 7 of the Act, the accuracy of this species list should be verified after 90 days. This verification can be completed formally or informally as desired. The Service recommends that verification be completed by visiting the ECOS-IPaC website at regular intervals during project planning and implementation for updates to species lists and information. An updated list may be requested through the ECOS-IPaC system by completing the same process used to receive the enclosed list.

The purpose of the Act is to provide a means whereby threatened and endangered species and the ecosystems upon which they depend may be conserved. Under sections 7(a)(1) and 7(a)(2) of the Act and its implementing regulations (50 CFR 402 *et seq.*), Federal agencies are required to utilize their authorities to carry out programs for the conservation of threatened and endangered species and to determine whether projects may affect threatened and endangered species and/or designated critical habitat.

A Biological Assessment is required for construction projects (or other undertakings having similar physical impacts) that are major Federal actions significantly affecting the quality of the human environment as defined in the National Environmental Policy Act (42 U.S.C. 4332(2) (c)). For projects other than major construction activities, the Service suggests that a biological

evaluation similar to a Biological Assessment be prepared to determine whether the project may affect listed or proposed species and/or designated or proposed critical habitat. Recommended contents of a Biological Assessment are described at 50 CFR 402.12.

If a Federal agency determines, based on the Biological Assessment or biological evaluation, that listed species and/or designated critical habitat may be affected by the proposed project, the agency is required to consult with the Service pursuant to 50 CFR 402. In addition, the Service recommends that candidate species, proposed species and proposed critical habitat be addressed within the consultation. Migratory Birds: In addition to responsibilities to protect threatened and endangered species under the Endangered Species Act (ESA), there are additional responsibilities under the Migratory Bird Treaty Act (MBTA) and the Bald and Golden Eagle Protection Act (BGEPA) to protect native birds from project-related impacts. Any activity, intentional or unintentional, resulting in take of migratory birds, including eagles, is prohibited unless otherwise permitted by the U.S. Fish and Wildlife Service (50 C.F.R.
