SUBJECT: Job A60031 FAP STPF-0043(52) Hwy. 89 – Hwy. 31 (S) Route 321, Sections 1 & 1S Lonoke County Tier 1 Categorical Exclusion

After appropriate environmental review, it has been determined that the subject job is a Tier 1 Categorical Exclusion as described by the ARDOT/FHWA Programmatic Agreement on Categorical Exclusion Documentation and Processing. A public hearing will not be offered for this project.

The proposed project involves a 1" mill and 2" overlay on 7.6 miles of Highway 321 between Highway 89 and Highway 31 in Lonoke County due to deteriorating pavement conditions. A project location map is attached.

The project would not involve relocations, prime farmlands, wetlands, underground storage tanks, hazardous materials, any environmental justice issues, or cultural resources. This project has been determined to generate minimal air quality impacts for Clean Air Act criteria pollutants and has not been linked with any special mobile source air toxics concerns. The cultural resources clearance is attached.

The official species lists obtained through the US Fish and Wildlife Service's Information for Planning and Consultation identified the following species as potentially occurring within the project area: Eastern Black Rail (*Laterallus jamaicensis ssp. jamaicensis*), Piping Plover (*Charadrius melodus*), Red Knot


(*Calidris canutus rufa*), alligator snapping turtle (*Macrochelys temminckii*), and monarch butterfly (*Danaus plexippus*). This project would have "no effect" on the aforementioned species due to the limited scope of the action, lack of suitable habitat, and distance to known species locations.

The alligator snapping turtle is currently a proposed threatened species, and the monarch butterfly is a candidate species. The proposed project would not jeopardize the continued existence of the alligator snapping turtle or the monarch butterfly. This project would not have a discharge of dredged or fill material into waters of the United States; therefore, a Section 404 permit will not be required.

This project proposes to add a 1" mill and 2" overlay on 7.6 miles of Highway 321 in Lonoke County. The project extends from Log Mile 3.289 to 7.740 and from Log Mile 0.000 to 3.152 on Highway 321.
