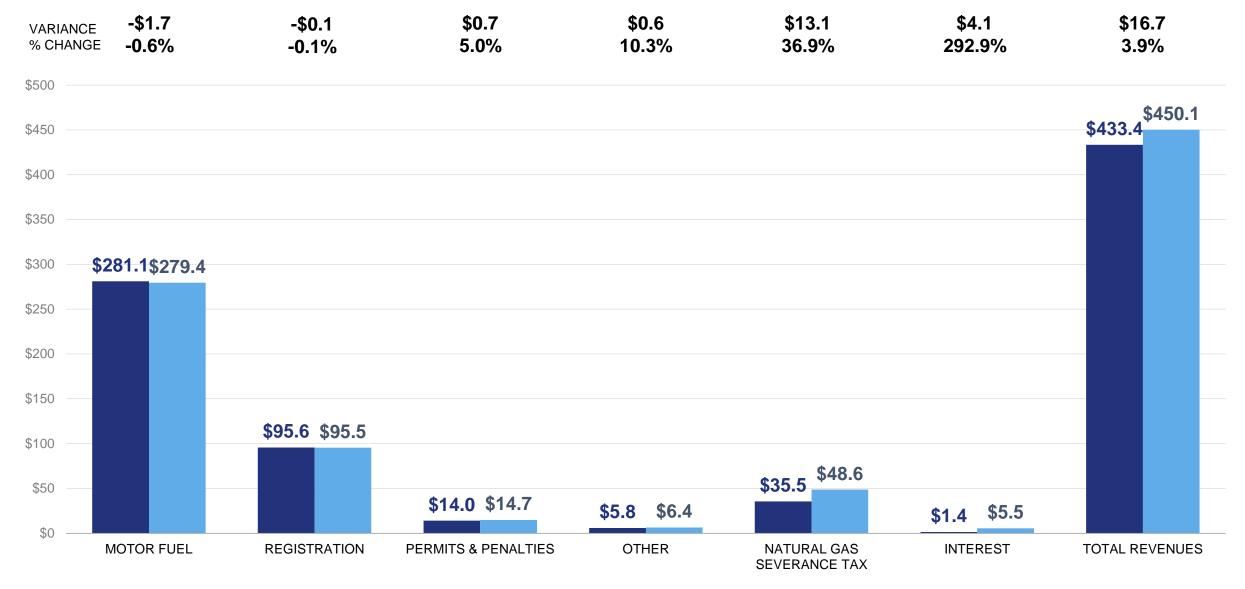

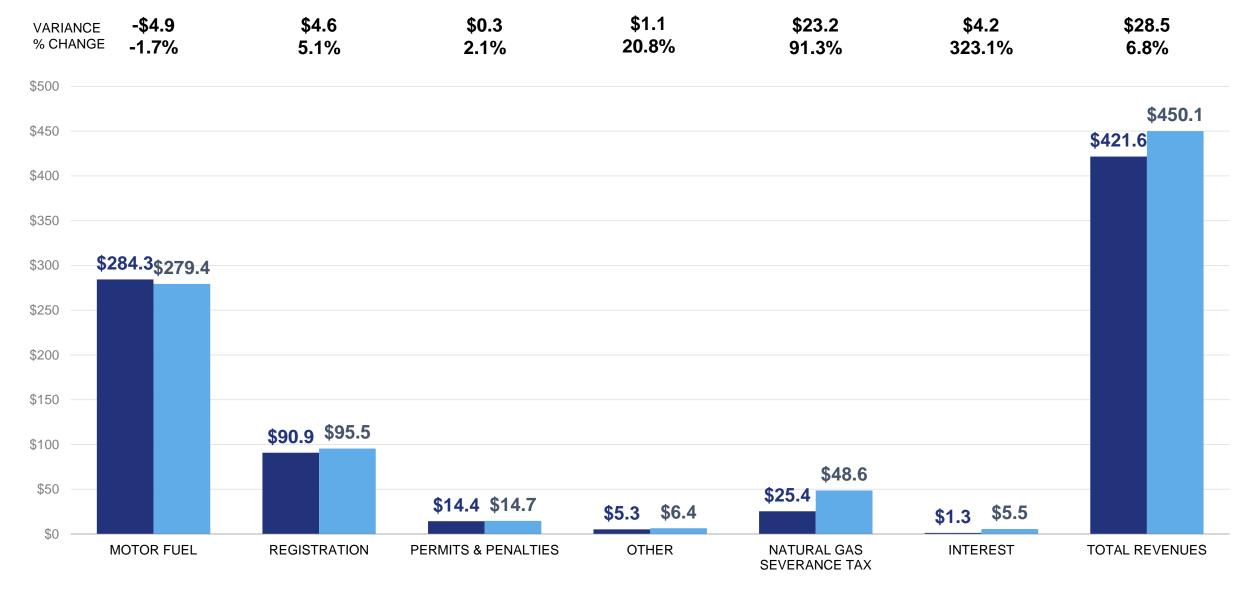

■FY 2022 ■FY 2023 (MILLIONS)



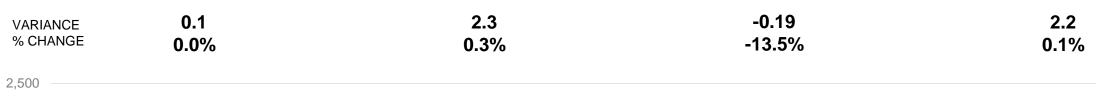


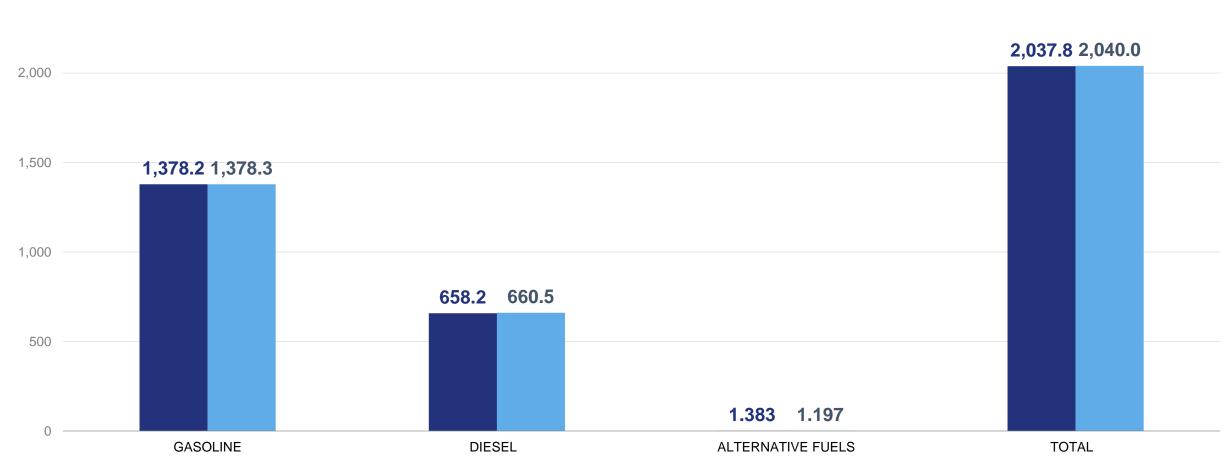

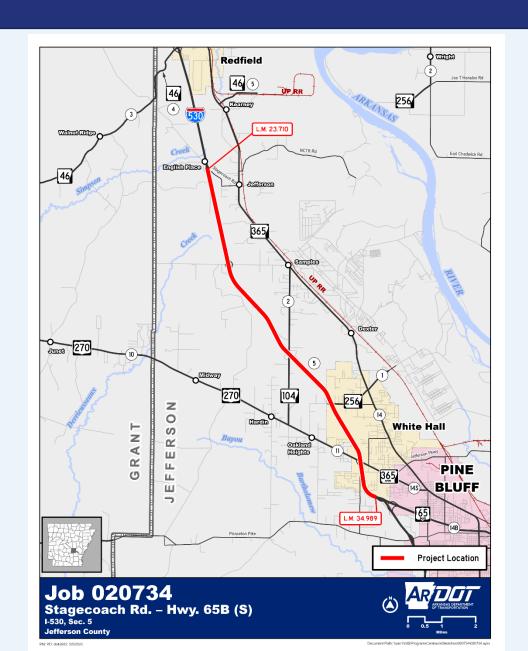

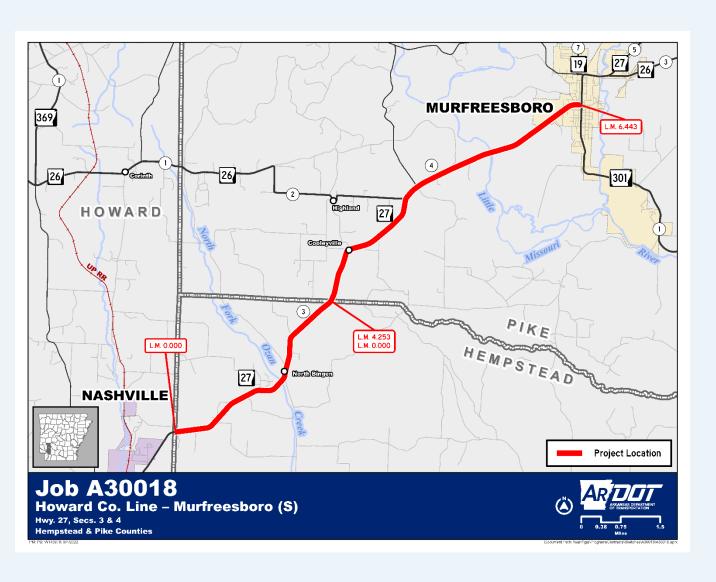
