MINUTES OF THE MEETING OF THE ARKANSAS STATE HIGHWAY COMMISSION

December 6, 2023

IT IS ORDERED that a meeting of the Arkansas State Highway Commission be opened at 10:00 a.m., December 6, 2023.

2023-106

WHEREAS, the Purchasing Committee has awarded purchases on October 26, and November 6, 2023, in the amounts of \$182,720.64, and \$596,091.00, respectively, totaling \$778,811.64, and supply and service contracts, in accordance with authority previously conveyed, all of which have been documented by official minutes which are of record in the files of the Commission and Equipment and Procurement Division.

NOW THEREFORE, IT IS ORDERED that the action of the Purchasing Committee be ratified and confirmed in all particulars.

WHEREAS, Minute Order 2018-104 authorized the Director to participate in the 2020–2024 Census Transportation Planning Products (CTPP) Technical Services Program organized by the American Association of State Highway and Transportation Officials (AASHTO); and

WHEREAS, the CTPP is a special tabulation of the American Community Survey that provides information on demographic characteristics, home and work locations, and journey-to-work travel flows; and

WHEREAS, CTPP data supports a variety of transportation policy and planning efforts, including long-range planning, corridor studies, travel demand modeling, and environmental analyses; and

WHEREAS, the CTPP Technical Services Program is now called AASHTO Census Transportation Solutions (ACTS); and

WHEREAS, the time and costs necessary to obtain the CTPP data will be substantially reduced by participating in a consolidated purchase coordinated by AASHTO; and

WHEREAS, ACTS will not only ensure production and delivery of CTPP data, but will also provide technical assistance, training, outreach, and associated research.

NOW THEREFORE, the Director is authorized to participate in the 2025–2029 ACTS program.

WHEREAS, the Department currently uses parcel records and project plans to identify existing highway right of way; and

WHEREAS, the existing process relies heavily on paper records and manual processes that are labor intensive and time consuming; and

WHEREAS, a shift to a digital dataset encompassing all Department right of way and surplus properties would be beneficial to the Department; and

WHEREAS, implementing a digital and spatial right of way database, that includes a record of utility locations within the right of way and billboard locations along regulated routes, is needed; and

WHEREAS, with a Geographical Information System (GIS), this information could be accessed accurately and more effectively; and

WHEREAS, utilizing the services of qualified consultants to develop a right of way record-keeping system would improve the Department's ability to efficiently deliver projects and manage right of way related inquiries.

NOW THEREFORE, the Director is authorized to request and evaluate proposals, and to enter into any necessary contracts and agreements with a consultant for the implementation of the digital and spatial integration of all right of way records.

WHEREAS, Act 1019 of 2019 granted the Commission the authority to procure qualification-based Construction Manager-General Contractor (CM-GC) services to implement the CM-GC Method of Procurement Pilot Program; and

WHEREAS, Act 823 of 2023 extended the Commission's authority to procure qualification-based CM-GC services to implement the CM-GC Method of Procurement Pilot Program; and

WHEREAS, the CM-GC alternative project delivery method provides value to the Department by including a construction contractor to participate in a project's preconstruction activities and thereby encouraging innovation, reducing risk, improving design, improving cost certainty, and optimizing construction schedules; and

WHEREAS, selection of the Contractors for CM-GC projects will be qualifications-based in accordance with Arkansas Code Annotated § 19-11-1406.

NOW THEREFORE, the Director is authorized to request and evaluate proposals and enter into any necessary contracts and agreements with firms for on-call CM-GC services on assigned CM-GC projects for calendar years 2024 through 2026.

WHEREAS, the *Department's Standard Specifications for Highway Construction* (Specifications) manual was last published in 2014 and significant changes have occurred since the last update; and

WHEREAS, the Specifications establish the policies and procedures for administration of highway and bridge contracts; and

WHEREAS, a rewrite of the 2014 Edition *Standard Specifications for Highway Construction* is needed and will be overseen by the Department's Specification Committee with collaboration from the contracting industry; and

WHEREAS, the rewrite of the Specifications will include a focus on performance based measurements that will require extensive research to identify best practices across the nation and evaluation of practicality along with legal sufficiency.

NOW THEREFORE, the Director is authorized to solicit proposals from qualified firms and to enter into contracts necessary for the development of the 2025 Edition of the *Standard Specifications for Highway Construction* manual.

WHEREAS, the Infrastructure Investment and Jobs Act (IIJA) authorized funding for the Transportation Alternatives Program (TAP) and the Recreational Trails Program (RTP) for Federal Fiscal Years 2022 through 2026; and

WHEREAS, applications were solicited and received for these two programs from March 1, 2023 to June 1, 2023; and

WHEREAS, the Arkansas Department of Transportation, the Transportation Alternatives Program Advisory Committee, and the Arkansas Recreational Trails Advisory Committee have reviewed the applications submitted and developed funding recommendations.

NOW THEREFORE, the Director is authorized to enter into contracts with the projects' sponsors for implementation of the projects recommended for award on the attached list.

WHEREAS, the Arkansas State Highway Commission (hereinafter called "the Commission") owns property in Garland County, Arkansas, acquired in 2019 from Tamara D. Abernathy and Paul S. WHEREAS, IN DALLAS COUNTY, IN THE CITY OF FORDYCE, the City has proposed to partner with the Department to make changes to the highway system; and

WHEREAS, the City has passed Resolution No. 412 proposing a traffic study to improve the flow of traffic for commercial motor vehicles related to the low-clearance Union Pacific Railroad overpass over Highway 8 in the east side of the City; and

WHEREAS, the Department has determined that the most logical and cost effective solution is to make changes to the State Highway System; and WHEREAS, the City is agreeable to assuming ownership and responsibility for the portion of Highway 8, Section 8 from Morton Street to the intersection of U.S. Highway 79 Business, including a low clearance railroad bridge; and

WHEREAS, the Department will assume ownership and responsibility for portions of Morton Street and South Charlotte Street, as well as East 1st Street and North Moro Street; and

WHEREAS, the Department has determined that this proposal will provide route continuity for commercial motor vehicles and the traveling public.

NOW THEREFORE, IT IS ORDERED that upon official notification by the Chief Engineer – Preconstruction, the following changes are hereby made to the State Highway System as shown on the attached sketch.

- The portion of Highway 8, Section 8 from Morton Street to U.S. Highway 79 Business is hereby removed from the State Highway System.
- The portion of Morton Street between Highway 8 and South Charlotte Street is hereby added to the State Highway System as part of Highway 8, Section 8.
- The portion of South Charlotte Street between Morton Street and East 1st Street is hereby added to the State Highway System as part of Highway 8, Section 8.
- The portion of East 1st Street from South Charlotte Street to North Moro Street is hereby added to the State Highway System as part of Highway 8, Section 8.

- North Moro Street from East 1st Street to U.S. Highway 79 Business is hereby added to the State Highway System as part of Highway 8, Section 8.
- The portion of East 1st Street from Highway 274 to North Moro Street will be added to the State Highway System as part of Highway 274, Section 4.

Chairman Farmer opened the meeting by welcoming those in attendance in-person, as well as those who were watching online.

Commissioner David Haak moved, Commissioner Marie Holder seconded, and the motion passed to approve the Minutes from the October 25, 2023, Commission Meeting.

MOTION

Vice Chairman Philip Taldo moved, Commissioner Marie Holder seconded, and the motion passed to adopt the Draft Transportation Management Plan to distribute and use as a guide in preparing for managing traffic impacts during the 2024 Total Solar Eclipse.

MOTION

The Commission approved Minute Order 2023-010 on February 22, 2023, authorizing the Department to engage the services of a qualified consultant to update the Arkansas Travel Demand Model. Public advertisement was made on July 30, 2023, in the Arkansas Democrat-Gazette and on the Department's website. Commissioner Marie Holder moved, Vice Chairman Philip Taldo seconded, and the motion passed to approve the

MOTION

The Commission approved Minute Order 2023-007 on February 22, 2023, authorizing the Department to enter into on-call service agreements with qualified consultants for Federal-aid Emergency Relief projects. Public advertisement regarding landslide repair services was made on June 14, 2023, in the Arkansas Democrat-Gazette and on the Department's website. Commissioner Keith Gibson moved, Commissioner Marie Holder seconded, and the motion passed to approve the Staff's recommendation to begin negotiations with the following firms to provide on-call landslide repair services for 2024 – 2027:

GeoStabilization International, LLC – Commerce City, CO Hinkle Environmental Service, LLC – Richmond, KY Keller North America, Inc. – Little Elm, TX

MOTION

By Minute Order 2023-054, on June 21, 2023, the Commission authorized the Director to request and evaluate proposals and acquire the appropriate software and services needed to enhance the Department's ability to monitor bridge structures to address the Federal highway Administration scour monitoring recommendations. A Request for Proposal (RFP) was distributed on August 18, 2023, and proposals were received by September 22, 2023. Commissioner Keith Gibson moved, Commissioner Marie Holder seconded, and the motion passed to approve the Staff's recommendation to begin negotiations with the following firms to provide bridge scour event monitoring software and services:

Bridge Intelligence, LLC - North Brunswick, NJ

MOTION

Commissioner Keith Gibson moved, Commissioner Marie Holder seconded, and the motion passed authorizing the Department to submit applications for the 2024 Rebuilding American Infrastructure with Sustainability and Equity (RAISE) application cycle for the following projects:

Interstate 49 in Sebastian and Crawford Counties Future Interstate 57 in Northeast Arkansas

OTHER DISCUSSION ITEMS

Patrick Patton, Chief Fiscal Officer, provided the October 2023 State Highway Revenue update. For State Fiscal Year (SFY) 2024 Budgeted vs. Actual Operating Expenses for ARDOT, overall expenses (maintenance, operations, administrative, and construction) were below budgeted by -5.2% (-\$3.2 million). Mr. Patton noted that State Highway Revenues to the Department from traditional sources for the year were up a total of 1.2% (\$2.8 million) in State Fiscal Year (SFY) 2024 compared to SFY 2023. Revenue from the Natural Gas Severance Tax was lower compared to the previous year. Total revenues available in SFY 2024 were -6.2% (-\$16.2 million) below last year. Actual State Revenue received was -10.1% (-\$26.2 million) below projected (budgeted) revenue for the year.

Kevin Thornton, Chief of Administration, provided the Federal and State Legislative updates to the Commission. Federal Fiscal Year (FFY) 2024 began on October 1, 2023. Since this time, the federal government has been operating under Continuing Resolutions (CR). The current CR is set to expire on January 19, 2024. Congress will need to reach an agreement regarding spending levels in order to be able to provide funding for a full year.

Crystal Woods, Assistant Chief of Administration, provided an update on the Arkansas Legislative Council Efficiency Study Recommendations Rules for Implementation. The monthly report for November was submitted and addressed the following recommendations:

- Recommendation #2 noted that the Department should "Strengthen knowledge management in anticipation of increased retirement".
 - O A Knowledge Management Steering Committee has been established to ensure alignment with current processes and provide support for the growth of the Knowledge Management program. The steering committee will perform its first annual review of the program in the first quarter of calendar year 2024 and every year thereafter.
- Recommendation #4 noted that the Department should "implement a platform that tracks all stakeholder inquiries to resolution".

 Ask ARDOT was made available to the public in October 2023 and can be accessed from the main website and on IDriveArkansas. A customer service satisfaction survey has been implemented to provide feedback once an inquiry has been answered.

In addition to the monthly reports submitted to the HCRAS, staff has been working with the Arkansas Department of Inspector General's Office of Internal Audit (OIA) to submit information regarding the portion of the law that established the efficiency review. Their first annual report was submitted to the Legislative Council in late August. Overall, the report was positive and recognized ARDOT for making substantial progress in implementing the Guidehouse recommendations. The Office of OIA has recommended that the HCRAS consider eliminating the consulting component of their engagement due to the noted strong internal controls currently in place.

Keli Wylie, Assistant Chief Engineer – Program Delivery provided the bid letting update from the November 1, 2023, bid letting.

Rex Vines, Chief Engineer – Operations provided a Maintenance Activity update.

Steve Frisbee, Assistant Chief Engineer – Updated the Commission on how the Department is preparing for the 2024 total solar eclipse, which will occur on April 8, 2024.

Director Tudor updated the Commission on recent Department activities. Since the October 25 meeting, several noteworthy Department activities occurred as listed below:

- Director Tudor presented at the American Public Works Association fall conference in Fayetteville on October 26.
- Director Tudor spoke at the Southeastern Asphalt User/Producer Group annual meeting in Little Rock on November 14.
- The Commission and Director Tudor attended the Good Roads Annual Meeting in Little Rock on November 15.
- Chairman Alec Farmer, Vice Chairman Philip Taldo and Director Tudor attended a ribbon cutting on the new Spring River Bridge in Hardy on November 29.

Jared Wiley, Chief Engineer of Preconstruction presented on the Statewide Transportation Improvement Program (STIP) development process.

Director Tudor presented a list of upcoming meetings and events that the Director and Commission will be attending.

In closing, Director Tudor reported on the proceeds from the 2023 Fall Equipment Auction, which took place in Lonoke on November 8. After paying the auctioneer's commission, the Department's net proceeds were \$2,041,102.82.
