IT IS ORDERED that a meeting of the Arkansas State Highway Commission be opened at 10:00 a.m., August 2, 2023.

WHEREAS, the Purchasing Committee has awarded purchases on June 12, and June 30, 2023, in the amounts of \$406,659.00 and \$618,930.50, respectively, totaling \$1,025,589.50, and supply and service contracts, in accordance with authority previously conveyed, all of which have been documented by official minutes which are of record in the files of the Commission and Equipment and Procurement Division.

NOW THEREFORE, IT IS ORDERED that the action of the Purchasing Committee be ratified and confirmed in all particulars.

WHEREAS, information provided to on road commercial drivers in real time related to traffic situations ahead will be highly beneficial in reducing crashes and incidents.

WHEREAS, the existing Central Office Administration Building in Little Rock located at 10324 I-30 was constructed in 1966; and

WHEREAS, a facility condition assessment identified the risk of a potential future failure of the building brick facade panels; and

WHEREAS, the removal of all existing brick panels is recommended to mitigate this risk; and

WHEREAS, the treatment to the underlying surface will be determined based on cost effectiveness and feasibility.

NOW THEREFORE, the Director is authorized to procure the services of an Architectural/Engineering firm and proceed with the design and construction for the brick facade removal and treatment of the underlying surface as funds become available.

WHEREAS,, the Arkansas Highway Commission has adopted guidelines for the installation of commemorative signs by Minute Order 2014-023 and this request meets these guidelines.

NOW THEREFORE, the Director is authorized to permit the installation of signs on each end of this bridge, as requested by the City, in accordance with Commission Policy.

WHEREAS, a number of communities have expressed interest in improving the aesthetics along highways and bridges by incorporating decorative features like gateway monuments, graphics, and transportation art; and

WHEREAS, aesthetically pleasing features will allow communities to express their sense of identity, welcome visitors, and enhance the roadside setting while providing minimum distraction for motorists; and

WHEREAS, the Department's current City or County Welcome Sign Guidelines only addresses decorative signage and landscaping within the state highway right-of-way and does not address other forms of transportation art.

Patrick Patton, Chief Fiscal Officer, provided the State Fiscal Year (SFY) 2023 Budgeted vs. Actual Operating Expenses for ARDOT. Overall expenses (maintenance, operations, administrative, and construction) for SFY 2023 were below budgeted by -3.1% (-\$5.1 million). Mr. Patton provided the year-end report for SFY 2023. Mr. Patton noted that State Highway Revenues to the Department from traditional sources for the year were down a total of -0.7% (-\$3.1 million) in State Fiscal Year (SFY) 2023 compared to SFY 2022. Revenue from the Natural Gas Severance Tax was higher compared to the previous year. Total revenues available in SFY 2023 were 2.4% (\$11.3 million) above last year. Actual

State Revenue received was 5.9% (\$27.3 million) above projected (budgeted) revenue for the year. Mr. Patton stated that June revenue from the 0.5% General Sales Tax for the Connecting Arkansas Program was 18.13% higher, (\$3,757,464) than projected by the Department of Finance and Administration (DF&A) for the month. Year to date actual revenue was above projections by 13.90% (\$33,531,344). Since inception, this revenue source was 3.72%, or \$72.2 million, above DF&A's projections. This was the final report on the revenues from the 0.5% General Sales Tax for the Connecting Arkansas Program. Moving forward, this report will be included in the State Highway Revenues.

Jared Wiley, Chief of Preconstruction, provided an update on Federal Highway and Transit issues. Wiley updated on the status of the previously discussed Federal Highway funding discrepancy. Originally, the discrepancy, discovered in 2018, was totaled at \$3.5 billion, but has now been reduced by 70% to \$1 billion. An ongoing audit revealed that in 2005 a \$2.5 billion accounting operation was incorrectly coded in the USDOT system, which erroneously impacted the State's contract authority. This was restored in July and states now have access to the additional \$2.5 billion. Arkansas share of the \$4.7 billion is \$67.5 million. In April 2023, Arkansas was originally given access to 5% (3.3 million). Currently, Arkansas has access to 70% (\$47.2 million) this Fiscal Year. ARDOT will continue coordinating with AASHTO and FHWA to provide comments, feedback, and suggestions about this issue. Mr. Wiley notified the Commission that ARDOT received a \$25 million grant from the 2023 Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Grant application for the Highway 5 widening project in Bryant. This project begins at Highway 183 and continues eastward to the Pulaski County line. The City of Russellville was also awarded \$24 million in RAISE Grant funding to create approximately 13 miles of multi-use paths.

Kevin Thornton, Chief of Administration, provided the Federal and State Legislative updates to the Commission. As the end of the Federal Fiscal Year (FFY) approaches, Congress continues working to provide funding for FFY 2024. Both the Senate and the House have passed their 2024 Transportation Appropriations Bill out of Committee; however, there are differences between them that will have to be worked out before a bill can be sent to the President. Both bills provide enough to fully fund the formula funding that was authorized in the IIJA. However, they are significantly difference when it comes to the discretionary grant programs. Mr. Thornton also updated the Commission on the status of Community Project Funding from the June 21 meeting. While funding has not been awarded, multiple projects from across the State are included in these bills. A total of \$91 million is included for Future Interstate 49, Future Interstate 57, U.S. Highway 412, U.S. Highway 82, and Highway 10 – Greenwood Bypass.

Crystal Woods, Assistant Chief of Administration, provided an update on the Arkansas Legislative Council Efficiency Study Recommendations Rules for Implementation. The monthly reports for the July and August were submitted and addressed the following recommendations:

- Recommendation #3 noted that the Department should "Publish status of construction projects and maintenance activities".
 - The proposed contract with Garver for the website was submitted to the HCRAS for their review and comment on June 19, and the public comment period was open from June 19 through July 5. This contract will be reviewed by the HCRAS in their August 24 meeting.
- Recommendation #4 noted that the Department should "implement a platform that tracks all stakeholder inquiries to resolution".
 - o The GovQA platform, now known as Ask ARDOT continues to develop, including a list of Frequently Asked Questions as well as a list of Trending Topics to enhance the customer experience.
 - o Branding and logo development for Ask ARDOT is underway, and a public launch date has not yet been determined.
- Recommendation #5 noted that the Department should "implement efficiencies in procurement and purchasing".
 - o A draft Project Delivery Selection tool has been developed and workshops are being held with ARDOT staff to preview the tool.
- Recommendation #6 noted that the Department should "implement construction contractor performance measurement".
 - o Metrics to define quality and desired performance of the prime contractor have been identified and a draft manual is currently under review.
 - A draft form has been developed for use by the Resident Engineer and other stakeholders to document their evaluations of the prime contractor. A pilot program is currently underway to determine how these evaluations will be compiled into a final evaluation.
- Recommendations #12 and #13 under the People Capabilities category noted that the Department should "Ensure staff can develop in their careers at the Department" and "Improve staff capabilities to align with current/future organizational needs".
 - o Cross training in high turnover areas for high turnover positions continues.
 - A method for maintenance supervisors to track employee on-the-job training has been recently introduced.

In addition to the monthly reports submitted to the HCRAS, staff has been working with the Arkansas Department of Inspector General's Office of Internal Audit (OIA) to submit

information regarding the portion of the law that established the efficiency review. A draft report will be submitted for review prior to the final submission to the Arkansas Legislative Council on October 1.

Keli Wylie, Assistant Chief Engineer – Program Delivery provided the bid letting update from the June 28, 2023, bid letting.

Director Tudor updated the Commission on recent Department activities. Since the April 5 meeting, several noteworthy Department activities occurred as listed below:

- Director Tudor provided an Interstate 69 update to Congressman Bruce Westerman on June 26;
- On July 11, the Engineering Intern Orientation kicked off, with 43 Civil Engineering Interns representing 9 schools participating;
- Director Tudor participated in the annual SASHTO Scholarship drawing on July 18. \$500 scholarships were awarded to 30 students in a random drawing;
- On July 20 and 21, the Commission, Director Tudor and staff participated in the Northeast Arkansas Policy Event in Jonesboro, hosted by the Arkansas Good Roads Foundation;
- Chairman Farmer, Vice Chairman Taldo, Commissioner Holder, Director Tudor and staff participated in the fourth and final Tip of the CAP celebration in Little Rock on July 25; and
- Commissioner Holder, Director Tudor, and staff officially broke ground for the extension of Highway 83 in Monticello on July 28.

Maggie Garrett, Chief Auditor, presented the 2024 Annual Audit Plan. Audit standards require that this plan be presented to the Commission and approved annually.

Kevin White, Division Head of Right of Way, provided an overview of the Department's Right of Way Division.

Director Tudor presented a list of upcoming meetings and events that the Director and Commission will be attending.

With no other business or discussion, the meeting concluded.
