MINUTES OF THE MEETING OF THE ARKANSAS STATE HIGHWAY COMMISSION

October 25, 2023

Following is the record of proceedings of the Arkansas State Highway Commission in Little Rock, Arkansas, October 25, 2023. Members present were:

IT IS ORDERED that a meeting of the Arkansas State Highway Commission be opened at 10:00 a.m., October 25, 2023.

2023-087

WHEREAS, the Purchasing Committee has awarded purchases on August 21, September 5, September 13, September 21, October 9, and October 11, 2023, in the amounts of \$351,366.40, \$865,936.00, \$832,608.00, \$518,907.00, \$76,080.00, and \$49,665.80, respectively, totaling \$2,694,563.20, and supply and service contracts, in accordance with authority previously conveyed, all of which have been documented by official minutes which are of record in the files of the Commission and Equipment and Procurement Division.

NOW THEREFORE, IT IS ORDERED that the action of the Purchasing Committee be ratified and confirmed in all particulars.

WHEREAS, the Department's wildflower program was created to provide for the establishment, proliferation and maintenance of wildflowers and native plants on highway rights of way; and WHEREAS, the Department's wildflower program and wildflower projects have received awards from the Keep Arkansas Beautiful Commission and the Federal Highway Administration; and

WHEREAS, the Department's *Wildflowers of the Arkansas Roadways* brochure, designed in 1999, has been immensely popular and widely distributed; and

WHEREAS, an updated brochure with a modern design has been developed.

NOW THEREFORE, the Director is authorized to print and distribute the new brochure promoting the Department's wildflower program.

WHEREAS, the 91st General Assembly of the State of Arkansas enacted Act 705 during the 2017 Regular Session, which established the distribution of highway revenue interest income from the State Highway and Transportation Department Fund to create the Future Transportation Research Fund and the Transportation-Related Research Grant Program (TRRGP); and

WHEREAS, the 93rd General Assembly of the State of Arkansas enacted Act 884 during the 2021 Regular Session, amending the program to add workforce development which modified the fund and program to the Future Transportation Research and Workforce Development Fund and the Transportation-Related Research and Workforce Development Grant Program (TRRWDGP), respectively; and

WHEREAS, as required by Act 884, the rules for administering this program have been promulgated; and

WHEREAS, applications were solicited and received for this program from June 6, 2023 to August 4, 2023; and

WHEREAS, the Arkansas Department of Transportation has reviewed the applications submitted and developed funding recommendations.

NOW THEREFORE, the Director is authorized to enter into contracts with the project sponsors for implementation of the projects included in the attached list.

WHEREAS, Act 1176 of 2013 enacted a 15% registration fee increase on certain commercial vehicles registered under the International Registration Plan; and

WHEREAS, the Act provides for the first \$2 million collected under the fee increase each year to be set aside for a Commercial Truck Safety and Education Fund; and

WHEREAS, the purpose of this program is to advance state interests in roadway safety by improving the safety of the commercial truck industry through cooperative public-private programs that focus on increased enforcement, regulatory compliance, industry training, and educational programs to ensure the safe movement of goods on Arkansas' roadways; and

WHEREAS, proposals for eligible projects have been solicited, received, reviewed, and evaluated by the Arkansas Commercial Truck Safety and Education Program (ACTSEP) Committee; and

WHEREAS, the ACTSEP Committee has recommended awarding Commercial Truck Safety and Education Funds for the projects as presented on the attached report.

NOW THEREFORE, the Director is authorized to proceed with the award of these funds as recommended.

WHEREAS, in accordance with 23 CFR Part 772 *Procedures for Abatement of Highway Traffic Noise and Construction Noise*, the Department is required to conduct noise impact analyses for proposed construction projects and provide abatement where warranted; and

WHEREAS, the Department is required to develop a noise policy to ensure compliance with these noise regulations; and

WHEREAS, the noise regulations require the allowable cost for noise abatement in the noise policy to be re-analyzed on a regular interval, not to exceed five years; and

WHEREAS, the last update to the Department's noise policy was approved by Federal Highway Administration in 2018; and

WHEREAS, traffic noise concerns from the public continue to increase around existing highway facilities; and

WHEREAS, the noise regulations provide for a voluntary noise abatement program for existing facilities.

NOW THEREFORE, the Director is authorized to evaluate and update the Department's noise policy and to include the development of a noise abatement program for existing facilities.

WHEREAS, the Infrastructure Investment and Jobs Act (IIJA) created the Carbon Reduction Program to provide funding for projects designed to reduce transportation emissions, defined as carbon dioxide emissions from on-road highway sources; and

WHEREAS, the Carbon Reduction Program requires states to develop and maintain a Carbon Reduction Strategy; and

WHEREAS, the Department has developed the <u>Carbon Reduction Strategy</u> in consultation with the eight Metropolitan Planning Organizations in Arkansas; and

WHEREAS, the Department's <u>Carbon Reduction Strategy</u> follows federal guidelines and aligns with the Department's strategic goals and priorities.

NOW THEREFORE, the <u>Carbon Reduction Strategy</u> is hereby adopted for use as a resource for future transportation planning and implementation.

2023-093

WHEREAS, the existing Crittenden 1 County Area Headquarters facility and Resident Engineer's Office 14 in West Memphis, on Interstate 40/55, were constructed in 1960 and 1971, respectively; and

WHEREAS, both facilities are currently located on the same property in West Memphis and will require relocation as part of the planned Job No. 110651, currently scheduled for 2025.

NOW THEREFORE, the Director is authorized to identify the most appropriate location for the new facilities, acquire the necessary property, and construct an

- 4 -(Continued) Area Headquarters and Resident Engineer's Office facilities, including buildings, appurtenances, fencing, and related items.

WHEREAS, the existing Sebastian 1 County Area Headquarters facility in Greenwood, on Highway 10, was constructed in 1972; and

WHEREAS, this existing Area Headquarters will require relocation as part of the planned Job No. 040861, currently scheduled for 2024.

NOW THEREFORE, the Director is authorized to identify the most appropriate location for the new facility, acquire the necessary property, and construct an Area Headquarters facility, including buildings, appurtenances, fencing, and related items.

WHEREAS, the Arkansas State Highway Commission (Commission) acquired property known as Tract No. 8XR-2, Job No. 080305, from William David Roberson and Sandra L. Roberson, husband and wife, by Warranty Deed dated November 27, 2007, and filed of record on November 27, 2007, as Document No. 2007-24387, in the Circuit Clerk's office for Faulkner County, Arkansas; and

WHEREAS, John Harris, of Conway, Arkansas, has requested to purchase Tract No. 8XR-2, Job No. 080305, which the District Engineer for District 8 has determined is not now, nor in the foreseeable future will be, needed for highway purposes; and

WHEREAS, Tract No. 8XR-2 was acquired as surplus property by the Commission and is exempt from reacquisition by the former owners under Ark. Code Ann. § 27-67-322; and

WHEREAS, Mr. Harris offered to purchase the tract for TWENTY-FIVE THOUSAND AND NO/100 DOLLARS (\$25,000.00), representing the Fair Market Value by a qualified appraiser; and

WHEREAS, the Commission acquired Tract No. 8XR-2 for FIFTEEN THOUSAND FIFTY AND NO/100 DOLLARS (\$15,050.00), which the tract is more particularly described as follows:

Part of the Northeast Quarter of the Southwest Quarter of Section 15, Township 5 North, Range 12 West, Faulkner County, Arkansas, more particularly described as follows:

Commencing at a half inch rebar being used as the Center Quarter corner of Section 15; thence South 01° 08' 19" West along the East line of the Northeast Quarter of the Southwest Quarter of Section 15 a distance of 329.63 feet to the point of beginning; thence continue South 01° 08' 19" West along said East line a distance of 259.01 feet to a point on the Northerly right of way line of Relocated U.S. Highway 64; thence North 71° 24' 32" West along said right of way line a distance of 112.73 feet to a point; thence North 82° 58' 19" West along said right of way line a distance of 136.64 feet to a point; thence North 70° 27' 31" West along said right of way line a distance of 80.00 feet to a point; thence South 87° 57' 26" East a distance of 669.06 feet to the point of beginning and containing 2.73 acres or 118,979 square feet more or less as shown on the plans prepared by the AHTD referenced as Job 080305.

NOW THEREFORE, the above-described property is declared surplus and upon receipt and consideration of the sum of TWENTY-FIVE THOUSAND AND NO/100 DOLLARS (\$25,000.00) from John Harris, of Conway, Arkansas, the Chairman of the Commission is authorized and directed to execute a Quitclaim Deed conveying the right, title, interest or equity of the above-described property to John and Sandra Harris, husband and wife; and hereby releasing the same from the State Highway System, that the Right of Way Division is directed and authorized to record a copy of this Minute Order and the Quitclaim Deed in the records of Faulkner County, Arkansas; and, if necessary, the right of way shall be remonumented to reflect the boundaries designated herein. Any Federal-Aid funds from this disposal shall be credited to Federal-Aid funds or otherwise credited as permitted by Federal Law.

WHEREAS, it has been determined that improvements are warranted to enhance safety at the six railroad crossings indicated on the attached list; and

WHEREAS, these improvements are eligible for one hundred percent Federalaid Rail-Highway Crossing Safety funds.

NOW THEREFORE, the Director is authorized to proceed with improvements at these crossings as funds become available subject to the following conditions:

- Maintenance of the signals and surfaces shall be performed by the applicable Railroad Company at no cost to the State.
- All required right-of-way shall be furnished at no cost to the State.

WHEREAS, IN CRITTENDEN COUNTY, the U. S. Army Corps of Engineers (hereinafter called the USACE), Memphis District, proposes the replacement of the Fifteenmile Bayou bridge on Highway 70 and the Tenmile Bayou bridge on Highway 131 to accommodate a channel widening and cleanout project; and

WHEREAS, the USACE proposes to enter into a cost reimbursable contract with the Department to handle preliminary engineering, environmental clearance, right of way acquisition and utility relocation, construction, and construction engineering for the replacement of both bridges; and

WHEREAS, the USACE will reimburse the Department for completion of all phases of the replacement project.

NOW THEREFORE, the Director is authorized to enter into any necessary agreements with the USACE for the project, and to proceed with surveys, plans, and construction of the improvements, subject to the assurance that funding for all associated costs will be provided by the USACE.

2023-098

WHEREAS, a continuous U.S. Highway connecting Future Interstate 57, in the growing northeast Arkansas region, to Memphis, Tennessee is considered an important transportation connection for economic development in northeast Arkansas; and

WHEREAS, U.S. Highway 78 currently begins in Memphis, Tennessee and continues over 700 miles eastward linking multiple Interstate highways and metropolitan regions through the states of Mississippi, Alabama, and Georgia to its terminus in Charleston, South Carolina; and

WHEREAS, extending existing U.S. Highway 78 from Memphis, Tennessee through Blytheville and Jonesboro to Future Interstate 57 would be beneficial to the State of Arkansas.

NOW THEREFORE, the Director is hereby authorized to coordinate with the Tennessee Department of Transportation to submit a request to AASHTO for an extension of U.S. Highway 78 from Memphis, Tennessee westward to Future Interstate 57.

FURTHERMORE, upon approval from the appropriate agencies and official notification by the Chief Engineer – Preconstruction, the highway segments shown on the attached sketch are hereby to be dual-signed as U.S. Highway 78.

2023-099

WHEREAS, the Intermodal Surface Transportation Efficiency Act of 1991 as amended by the Infrastructure Investment and Jobs Act of 2021 designated the route that generally follows U.S. Highway 412 from Interstate 35 in Oklahoma to Interstate 49 in Arkansas as High Priority Corridor 96 and a Future Interstate facility; and

WHEREAS, upon its completion, the 190-mile High Priority Corridor will improve connectivity and mobility by linking Interstate 35, Interstate 44, and Interstate 49 with an Interstate Highway; and

WHEREAS, the official designation of this corridor as a Future Interstate Highway would be beneficial to the State of Arkansas and the region.

NOW THEREFORE, the Director is hereby authorized to coordinate with the Oklahoma Department of Transportation to submit a request to the American Association of State Highway and Transportation Officials (AASHTO) and the Federal Highway Administration (FHWA) to designate this corridor as Future Interstate 42.

FURTHERMORE, upon approval from AASHTO and FHWA, it is ordered that upon official notification by the Chief Engineer – Preconstruction the following changes are hereby made to the State Highway System as shown on the attached sketch.

WHEREAS, IN CRAIGHEAD COUNTY, the County has passed Resolution No. 2023-30 offering to partner with the Department to fund future transportation improvements by accepting ownership and responsibility for Highway 230, Section 10 in its current condition; and WHEREAS, the Department currently has two projects scheduled to replace five structures on this section of Highway 230; and

WHEREAS, the County has offered to replace these structures using its own forces and funding after the route has been removed from the State Highway System; and

WHEREAS, in exchange, the Department will make available to the County the equivalent amount of funding attributed to the structure replacements and anticipated future maintenance of this section of Highway 230 for future transportation improvements, until the balance has been expended.

NOW THEREFORE, the Director is authorized to enter into any necessary partnering agreements with local agencies and to proceed with surveys, plans, and construction of improvements as projects are identified and as funds become available.

FURTHERMORE, IT IS ORDERED that upon official notification by the Chief Engineer – Preconstruction, Highway 230, Section 10 shall be removed from the State Highway System.

2023-101

WHEREAS, the Quorum Court of Woodruff County, by Resolution No. 2023-11, has requested that a portion of Highway 269 south of McCrory, AR be designated as the "Johnny Kyle Memorial Highway"; and

WHEREAS, the Arkansas Highway Commission has adopted guidelines for the installation of commemorative signs by Minute Order 2014-023 and this request meets these guidelines.

NOW THEREFORE, the Director is authorized to permit the installation of signs on each end of this portion of Highway 269, as requested by the County, in accordance with Commission Policy.

2023-102

WHEREAS, the Quorum Court of Craighead County, by Resolution No. 2023-18, has requested that the Highway 226 Railroad Overpass west of Jonesboro, AR be designated as the "John Michael Cameron Overpass"; and WHEREAS, the Arkansas Highway Commission has adopted guidelines for the installation of commemorative signs by Minute Order 2014-023 and this request meets these guidelines.

NOW THEREFORE, the Director is authorized to permit the installation of signs on each end of this Highway 226 overpass, as requested by the County, in accordance with Commission Policy.

2023-103

WHEREAS, IN COLUMBIA COUNTY, IN THE CITY OF MAGNOLIA, local officials have expressed concern about the flow of truck traffic within the City and requested a bypass study; and

WHEREAS, a study is necessary to evaluate current and future traffic patterns and transportation needs in the area.

NOW THEREFORE, the Director is authorized to conduct a study to assess the need for and feasibility of a Magnolia bypass to address concerns related to truck traffic.

By Minute Order 2022-10 on December 7, 2022, the Commission authorized the Department to request proposals and enter into any necessary contracts and agreements with firms for on-call planning services as needs are identified for calendar years 2024 through 2026 with an option to extend through calendar year 2028. Public advertisement was made on February 12, 2023, in the Arkansas Democrat-Gazette and on the Department's website. Commissioner Marie Holder motioned, Commissioner David Haak seconded, and the motion passed to accept the Staff's recommendation to enter into negotiations with the following firms to provide On-Call Planning Services for calendar years 2024-2026:

AECOM - Little Rock, AR Alliance Transportation Group - Austin, TX Burns & McDonnell Engineering Company, Inc. - Springdale, AR Cambridge Systematics, Inc. - Medford, Mass. Garver, LLC - North Little Rock, AR HDR Engineering, Inc. - Little Rock, AR High Street Consulting Group - Pittsburgh, PA HNTB Corporation - Little Rock, AR Olsson, Inc. - Fayetteville, AR

OTHER DISCUSSION ITEMS

Patrick Patton, Chief Fiscal Officer, provided the September 2023 State Highway Revenue update. For State Fiscal Year (SFY) 2024 Budgeted vs. Actual Operating Expenses for ARDOT, overall expenses (maintenance, operations, administrative, and construction) were below budgeted by -3.2% (-\$1.5 million). Mr. Patton noted that State Highway Revenues to the Department from traditional sources for the year were up a total

- 12 -(Continued) of 1.8% (\$3.2 million) in State Fiscal Year (SFY) 2024 compared to SFY 2023. Revenue from the Natural Gas Severance Tax was lower compared to the previous year. Total revenues available in SFY 2024 were -5.1% (-\$10.0 million) below last year. Actual State Revenue received was -10.6% (-\$20.7 million) below projected (budgeted) revenue for the year.

Kevin Thornton, Chief of Administration, provided the Federal and State Legislative updates to the Commission. Federal Fiscal Year (FFY) 2024 began on October 1, 2023. At this time, Congress was unable to reach an agreement on an appropriations bill for the entire year, but a Continuing Resolution (CR) was passed which will provide funding for the government until November 17. If a funding agreement is not reached by this date, another CR will need to be passed to prevent the government from shutting down. If this happens, Department operations would not be affected since the majority of funding comes from the Highway Trust Fund.

Crystal Woods, Assistant Chief of Administration, provided an update on the Arkansas Legislative Council Efficiency Study Recommendations Rules for Implementation. The monthly reports for September and October were submitted and addressed the following recommendations:

- Recommendation #3 noted that the Department should "Publish status of construction projects and maintenance activities".
 - The proposed contract with Garver for the website was reviewed by the Highway Commission Review and Advisory Subcommittee and the contract was executed by the Director in September.
- Recommendation #4 noted that the Department should "implement a platform that tracks all stakeholder inquiries to resolution".
 - On September 22, 2023, a "coming soon" video was posted on social media platforms announcing that a new inquiry tracking system would soon be available for public use. Just over one week later, Ask ARDOT was officially made available to the public.
- Recommendation #6 noted that the Department should "implement construction contractor performance measurement".
 - Metrics to define quality and desired performance of the prime contractor were identified and seven projects have been selected for a pilot application. The contractors were informed of the process and agreed to participate.

In addition to the monthly reports submitted to the HCRAS, staff has been working with the Arkansas Department of Inspector General's Office of Internal Audit (OIA) to submit information regarding the portion of the law that established the efficiency review.

Their first annual report was submitted to the Legislative Council in late August. Overall, the report was positive and recognized ARDOT for making substantial progress in implementing the Guidehouse recommendations.

Keli Wylie, Assistant Chief Engineer – Program Delivery provided the bid letting updates from the August 16 and September 20, 2023, bid lettings.

Joseph Hawkins, State Intelligent Traffic Systems (ITS) Engineer provided an update on the Wrong Way Crash Detection System.

Rex Vines, Chief Engineer – Operations provided a Maintenance Activity update.

Deric Wyatt, State Maintenance Engineer reported on the recent Maintenance Supervisor Conference, which was held on October 3 - 5, 2023 at Lake DeGray State Park.

Steve Frisbee, Assistant Chief Engineer – Maintenance briefed the Commission on how the Department is preparing for the 2024 total solar eclipse, which will occur on April 8, 2024.

Director Tudor updated the Commission on recent Department activities. Since the August 2 meeting, several noteworthy Department activities occurred as listed below:

- Director Tudor presented at the Arkansas Concrete Conference in Hot Springs on August 23.
- The Commission, Director Tudor and staff attended the Highway 167 Madison Murphy Highway dedication ceremony in El Dorado on September 19.
- Director Tudor spoke at the Transportation Planning Conference in North Little Rock on September 20.
- Director Tudor presented at the Conway Business Expo on October 12.
- The Commission, Director Tudor and staff attended the ribbon cutting ceremony for the Scenic Hot Springs Bypass Extension on October 24. Following this ceremony, a luncheon was hosted by the Hot Springs Chamber of Commerce.
- Chairman Alec Farmer and Director Tudor joined FHWA Arkansas Division Administrator Vivien Hoang for the signing of the Environmental Record of Decision for Future Interstate 57 on October 24.

Director Tudor presented a list of upcoming meetings and events that the Director and Commission will be attending.

In closing, Director Tudor recognized the ARDOT team for placing 4th place at the 19th Annual Southeastern Regional Roadeo competition held in Beckley, WV. Director Tudor also updated the Commission on plans to raise money and construct a permanent memorial for ARDOT workers killed on the job.
