

Resolution 2023-05
FY 2023 – 2026 Transportation Improvement Program (TIP) Amendment (#2)

WHEREAS, the Tri-Lakes Metropolitan Planning Organization (MPO) is the officially designated MPO; and

WHEREAS, the Tri-Lakes Metropolitan Planning Organization (MPO), in cooperation with the State and any affected public transportation operator(s), shall develop a Transportation Improvement Program (TIP) for the metropolitan planning area, pursuant to 23 CFR §450; and

WHEREAS, the TIP shall reflect the investment priorities established in the current metropolitan transportation plan and shall cover a period of no less than 4 years, be updated at least every 4 years and be approved by the MPO and the Governor; and

WHEREAS, the Tri-Lakes MPO, in conjunction with the City of Hot Springs Intracity Transit, the Arkansas Department of Transportation (ARDOT), and the Federal Transit Administration (FTA) have determined an amendment to the Hot Springs Area Transportation Study (HSATS) Federal Fiscal Year (FFY) 2023-2026 Transportation Improvement Program (TIP) is necessary; and

WHEREAS, based on the adopted Tri-Lakes MPO Public Participation Plan, this City of Hot Springs Intracity Transit requested TIP Amendment was subject to public comment from October 29th, 2023, to November 12th, 2023.

NOW, THEREFORE, BE IT RESOLVED BY THE POLICY BOARD OF THE TRI-LAKES METROPOLITAN PLANNING ORGANIZATION:

That the Tri-Lakes Metropolitan Planning Organization hereby amends the HSATS FFY 2023-2026 TIP by adding the following job items:


