Supply Contract for furnishing to the Arkansas Department of Transportation, Milling Machine Tool, to meet the following specification, from July 1, 2023 thru June 30, 2024, with an option to renew upon mutual agreement of the parties. Milling Machine Tool furnished shall be for Milling Asphalt with a very hard river aggregate, .765 diameter with long sleeve for pavement planning similar in shape to Item #1. Tip shall have not less than 6% or more than 8% cobalt with a Rockwell hardness range of approximately 89.0± 1.0 A-scale. Full expended tools shall have a tip loss of not more than 2% per 100 teeth. SEE Item #1 for details of minimum dimensions.
